500 Alumni visit campus

128 members of '53 class Presented at Alumni luncheon

About 500 Alumni visited on the campus June 3 and 4 for Alumni Day and commencement; 318 attended the Alumni luncheon following commence-

Alumni activities began with registration on June 3 in the lobby of Ganus Student Center. The chapel program at 10 a.m. was presented by the class of '28. Mrs. Rena Woodring Sanderson was chairman of the program committee. Children of the members of this class who are also Alumni, were introduced.

Members of the class of '28 attending were: Mr. and Mrs. L. O. Sanderson, Springfield, Mo.; Maurine Rhodes Kingsley, Penalosa, Kans.; Helen Haynes Smart, Monticello; and Joyce Duvall Kell, Little Rock. Their children present were Lloydene Sanderson, Bettye Kell Cook, Mary Helen Smart Hardy, and Joe Kingsley.

A luncheon was held in the Emerald Room of Ganus Student Center honoring the classes observing 5, 10, 15, 20, and 25-year anniversaries with 53

alumni present.

That afternoon the students of Harding College defeated the Alumni by a narrow margin in the traditional softball game.

Various clubs and classes held their special functions during the day. After Wednesday evening services at the College church, the chorus presented an outdoor concert in front of the auditorium-administration building.

Commencement was held June 4 at 10 a.m. Dr. Henry G. Harmon, president of Drake University, Des Moines, Iowa, was guest speaker. B.A. and B.S. degrees were conferred on 119 students, M.A. degrees were conferred on nine.

The Alumni luncheon was held in the college dining hall. Bill Cook, '49, sang a solo, accompanied by his wife, Bettye Kell Cook, '51. Miss Catherine Root, executive secretary, read the minutes of the last meeting. Dr. F. W. Mattox presented the class of '53 for membership in the association. Bob Anderson will serve as permanent president and Hellen Yohe, secretary. This class

has pledged 100 per cent giving for the next 25 years.

Dr. Joe Pryor, president of the association, made a report of Alumni activities during the past nine months. He announced the appointment of a committee which will nominate officers for 1954-56. Election will be held in the spring. Members of this committee are Chairman Carroll Trent, '35, of Little Rock, Ark.; Avanelle Elliott Baird, '39, Bartlesville, Okla.; Eddie Shewmaker, '44, Roselle Park, N. J.

Honor guests and chapter presidents were introduced. Two vice-presidents were present: Charles Cranford, '51, of Shreveport, La., and Jeannette Norris Baggett, '50, of Searcy.

The Ph.D. degree will be conferred on Prof. Clifton L. Ganus, Jr., at Tulane University, New Orleans, on August 29.

His major was in history and his dissertation was on the Freedman's Bureau in Mississippi. He received his B.A. degree at Harding College in 1943 and his M.A. at Tulane in 1946. He began teaching here in 1946.


