Executive group holds meeting

A called business meeting of the Executive Committee of the Alumni Association was held in the form of a luncheon in the Blue Room of the Rendezvous Thursday noon, November 18. Present were President Joe Pryor, Vice-Presidents Charles Pitner and Emmett Smith, Treasurer ex-officio A. S. Croom, Executive Secretary Jo Connell, two immediate past presidents Clifton L. Ganus, Jr., and Edwin Hughes and two appointed members at large Carroll Trent and Thednel Garner. One member of the committee was absent, Vice-President Ordis Copeland.

The Executive Secretary was instructed by the committee to have official charters printed to issue to local chapters to signify their recognition as organized alumni groups. These charters will have printed on them the date the chapter was organized and a list of the charter members. A chapter is recognized as official when its by-laws are approved by the executive committee.

The Executive Secretary was further instructed by the committee to add to the active files all persons who attended the Harding Academy without later enrolling in the college. In the future those persons who have been enrolled in the extension work being offered this year for the first time in Little Rock will also be added. This decision was reached through the committee's interpretation of the first line in Article III of the Constitution, entitled Membership: "Active members shall include all bona fide former students of Harding College, . . ." At present the active files include very few former students of the Academy who did not later enroll in the College.

Book store orders come from afar

Many alumni are becoming regular customers of the Harding College Book Store by taking advantage of its mail order services. During last month one-fourth the total business of the Book Store was in mail orders received from 36 states, Canada and South Africa.

Most requests are for Bible school literature or recordings made by the different choral groups on the campus. The Book Store stock includes three series of graded Bible school literature and supplementary materials and records of wedding music, hymns for radio and home use and a capella concert numbers.

The John Lee Dykes are now giving full time to managing the Book Store. Mr. Dykes, who has devoted much of his life to Christian education, says, "Our goal is to render the greatest possible service to those engaged in the teaching program of the church."

Placement office to serve alumni

Harding has added to its services a placement office to assist Harding trained men and women in securing the best employment possible. J. D. Fenn, '30, has returned to his Alma Mater to direct the placement service. Barbara Cooper Dean, '53, is secretary.

Fenn urges all alumni who wish to find better employment to use the placement office. He says that numerous requests come to him for competent persons in all fields, school teaching, school administration, business administration and industry. Alumni wishing to contact such prospective employers may write directly to Fenn in the placement office or may write to the Alumni Office.

Alumni in executive positions wishing to employ Harding trained people may wish to contact them through the placement office.

The placement office will serve three groups of people. It will help undergraduates to obtain summer work, seniors to find permanent work, and alumni to secure better employment, Fenn says that the planned followup program should insure Hardingites employed through the placement office of reasonable advancement in their work.

The placement office is counseling students on choices of careers. Alumni wishing to take advantage of this type of service are invited to come talk with Fenn. The office has career reports on all types of work which give salary range, job future, advantages and disadvantages.

The placement office is located on the first floor of the American Studies Building.


