Homecoming attracts 300 Alumni; '32 class celebrates 25th reunion

An estimated 300 alumni attended the annual Homecoming, winding up the two-day get-together at the Alumni Luncheon following graduation May 30.

Activities got underway with Alumni Chapel Wednesday, presided over by members of the '32 class, celebrating their 25th anniversary. The six members of the class present were introduced by Dr. Joe Pryor, president of the Alumni Association, who turned the program over to Sidney Ruby, emcee.

Others present besides Ruby were Mrs. Myrtle Rowe, Bob Neil, F. H. Dunn, Mrs. Florence Cathcart, and Mrs. J. N. Armstrong.

At noon members of all five-year classes held a joint luncheon at Roberson's Rendezvous. Seventytwo alumni representing the classes of '32, '37, '42, '47, and '52 attended the luncheon with the class of '52 leading in the number of members present. The Alumni Luncheon and annual business meeting were held in the College Dining Hall following graduation on Thursday. President Pryor presided, the invocation was given by A. S. Croom, treasurer, and entertainment was furnished by the Harding Men's Quartet.

Dr. Adrian Formby, second vice president, presided while new members were presented for induction. Pryor, senior class sponsor, presented the graduating seniors, and Dr. Clifton Ganus, chairman of the graduate council, presented the graduate students.

Pryor announced the nominating committee for the selection of officers for 1958-60. Those appointed to the committee were Annie Mae Alston, chairman, '39, Rex Westerfield, '49, Ordis Copeland, '46, Bula Moudy, '49, and Dale Larsen, '45.

President's Corner

Since the practice was begun several years ago of having the twenty-five year class take charge of the chapel

program on Alumni Day all of the programs have been very interesting to me and each one has been unique. Such was the program provided by the class of 1932 on May 29. It included a brief history of the members of the class by Florence M. Cathcart, a look through the '32 Petit Jean by Robert Neil with some excellent educational philosophy included, a moving film of the mission work in Northern Rhodesia with narration by Myrtle Rowe, and reminiscings of her associations with Christian colleges by Mrs. J. N. Armstrong.

Sidney Ruby arranged and emceed the program and made very timely comments. I appreciated very much the excellent job that Sidney did. Robert Neil led the singing and F. H. Dunn read a passage of scripture and led in prayer. Walter Blake and his family were on the campus the day preceding but were unable to remain for Alumni Day.

In the last issue of the Alumni Bulletin mention was made regarding the decision of the board for Harding to participate in intercollegiate basketball, baseball, track, and tennis beginning this fall. I would like to comment briefly on this. In 1939, M. E. "Pinky" Berryhill recommended that intercollegiate competition be discontinued in favor of an intramural program. The faculty endorsed this recommendation which was approved by the board and enforced by the administration.

In the spring of 1957, Berryhill, after carefully considering the question for some three years, requested permission from Dr. Benson to present a recommendation to the faculty that Harding again participate in intercollegiate sports on the following conditions: (1) there would be no curtailing of the excellent intramural program, (2) there would be no subsidization or recruiting of athletes, (3) the intercollegiate program would be under the jurisdiction of a faculty committee which would schedule games and see that the program functioned properly.

Hugh Groover was appointed coach and Pinky Berryhill, Cliff Ganus, and Joe Pryor were appointed to serve as the faculty committee on athletics. Cecil Beck will continue to direct the intramural program which he has developed so much during his three years at Harding. All who know Hugh Groover realize not only his ability as a coach but also that his chief interest is in developing Christian character. The developing of Christian character will be the chief concern of all those directly connected with athletics at Harding whether intramural or intercollegiate.

I believe, along with many others, that it is possible to operate an intercollegiate program so that it can make a worthwhile contribution to those participating as well as to those who will be observing as spectators. This past year at Harding many of the best athletes not only possessed real Christian character but they also ranked near the top in academic attainment.

Alumni receive grants for study

Three Harding alumni have been granted National Science Foundation Scholarships for the 1957-58 school year.

Norman Hughes, '54, received a doctoral research scholarship in biology. This grant covers all tuition and fees plus a \$2,500 stipend for living expenses. His research is an embryological and cytological study of salamanders. Norman will continue his graduate work at Emory University, Atlanta, Ga., where he has held a graduate assistantship the past two years. He received his M.S. degree in 1956.

Immediately a f t e r graduating from Harding, Norman and his classmate, Nancy McDaniel, were married and taught for one year at Georgia Christian Institute, Valdosta, Ga. For the past two years Norman has preached for the church in Union City, Ga., while doing graduate work.

Dale G. Gould, '49, received an all-expense scholarship from the National Science Foundation's program to prepare better qualified and more effective science teachers at the secondary level. He will study at Washington University, St. Louis, Mo.

Last summer Dale attended an institute on the teaching of high school science at the University of Arkansas. He taught science at Caruth, Mo., from 1949 to 1952, and since 1952 he has taught in Beebe High School. William Fay Rushton, '53, received a fellowship in physics for this summer and is attending a special summer institute for high school teachers of physics at Louisiana State University.

After receiving his B.S. degree in biology, he began teaching science and mathematics in the high school at Alton, Mo., during the regular session and doing graduate study in the summer. He received his M.A. degree in zoology from the University of Arkansas in 1956.

Tennessee CPAs elect Axel Swang

Dr. Axel W. Swang, '46, head of the business administration department at David Lipscomb College, Nashville, Tenn., has been appointed executive secretary of the Tennessee Society of Certified Public Accountants.

From Harding College he went on to the University of Missouri, where he received the M.A. degree in 1947.

Joining the Lipscomb faculty in 1948, he was given leave of absence to complete his doctoral program from 1954 to 1956 and in August last year he was awarded the Ph.D. at the University of Alabama.

Swang will continue as professor of business administration and head of the department at Lipscomb and also as minister of the Gilroy Church of Christ near Nashville.

Dramatic society elects D. Garner

Don Garner, '51, instructor in speech at David Lipscomb College, Nashville, Tenn., was elected vicepresident of the national honorary dramatic society, Alpha Psi Omega, at its national convention in December.

The election makes him editor of the society's quarterly publication. Don was also appointed to conduct a seminar on the place of honor fraternities in the American educational theater at the 1957 joint convention of Alpha Psi Omega and the Speech Association of America.

Don received the M.A. degree from Kent State University in 1953, where he combined teaching with graduate work in drama and speech. From 1953 to 1954 he did work toward the doctoral degree at Ohio State University and directed the acting laboratory there.


