Winners announced in business awards for alumni programs

On January 6, the Awards Program was launched in support of higher education. Sponsored by American business and industry, this grant of \$10,000 by the United States Steel Foundation is designed to broaden the base of support for higher education.

Texas A&M Wins

Top honors and a check for \$10,000 went to Texas A & M college, winner in the tax supported university classification, in recognition of the support given by the alumni in 1957. Asked to contribute to the erection of a campus chapel, scholarships, and faculty achievement awards, 15,284 alumni contributed out of a total of 31,200 graduates and former students for a participation of 48.9 per cent.

Over 300 in Competition

More than three hundred institutions competed for awards and honors. First place certificates and checks for \$1,000 went to the leader in the following categories: Texas Lutheran College in the small co-educational division; Willamette University for large coeducational; Holy Cross for men's colleges; Princeton University for private; College of Medical Evangelists for professional schools; Monticello for junior colleges; and Thacher School for independent secondary schools. Vassar and Mount Holyoke colleges shared the honor and award for the women's college division.

Criteria guiding the judges in making their decision included: the amount of funds raised by alumni, the number of contributors, the percentage of participation, size of the average gift, purpose for which funds were raised, improvement over previous years and the effort to broaden the base of support for the institution.

Cannons adopt Japanese children

Mr. and Mrs. Joe Cannon, former Harding College students, have a family of two nationalities. In addition to their own daughter, Margaret Eileen, they have four adopted Japanese children.

The Cannons are now in Abilene, Tex., on a teacher exchange between Abilene Christian College and Ibaraki Christian College, Ibaraki Ken, Japan.

Joe Cannon traces the decision to adopt the children back to a ladies Bible class he was conducting in Japan. During a discussion of the care of orphans and widows, he commented that all those who were able to adopt children should do so. Some self-examination proved to the Cannons that they should adopt the children.

The children were secured through the International Social Service, Yokosuka Welfare Center, and the Holt Adoption Program.

The adopted children range in age from two to five. Leonard Earl, age 4, and Troy Joseph, age five, were adopted by the Cannons in August, 1956. Gregory Paul, age two, was adopted in June and Deborah Ann, age 5, in July of 1958.

Joe Cannon, a 1947 graduate of Harding, was a member of the Lambda Sigma social club, and was active in Debate, dramatics, and intramural football. He was elected Best All Around Boy in 1947 and was elected a member of Who's Who in American Colleges and Universities. His wife, Rosabell Cannon, attended Harding in 1946-47.
