HARDING ALUMNI HAVE PART IN GERMAN LECTURESHIP

Harding College was well represented at the 8th Annual German Lectureship held at Augsburg, one of Germany's oldest cities, September 19-23. Six nationalities — American, Austrians, Czech, Dutch, German and Swiss — were represented from congregations in Austria, Germany and Switzerland. Six men of the 70 participating were Harding alumni.

As these determined and devoted Christians assembled for five days to cover the theme of "The Christian in the Service of God" they probably thought many times about the hardships and tribulations brought on their forefathers by the Caesars, and most particularly by Augustus, for whom the ancient German city of Augsburg was named. Perhaps as they walked the streets of this Bavarian city they heard echoes in their minds of "There

went out a decree from Caesar Augustus that all the world should be taxed."

Gottfried Reichel (BA'53), in reporting on the lectureship, added another historical touch in telling of the church of more than 1,000 members in the city in the days of the Reformation whose earnest desire was to follow the pattern of the New Testament. He related that historical records show that more than 70 men of the group were burned at the stake, while many of the women were drowned in the Lech river, because of their stand on scriptural baptism.
