## DO YOU LISTEN TO "HYMNS FROM HARDING"?

The Hymns From Harding radio program is broadcast regularly over 181 stations in 46 states. Is it broadcast in your area? If not, do you think you could get a nearby station to broadcast it as a public service?

Former students and faculty members do write in occasionally offering to try to get a station to join our list. Some of them succeed. For this, we are grateful, and both they and the station are happy after such a success.

We have a nice explanatory folder which we prepared for the purpose of selling radio stations on the idea of using the program for part of their public service time. We will be happy to supply these folders for all who feel they can make good use of them. Each folder contains a prepaid card for the station to use in requesting an audition tape — an actual sample of the program.

The states in which no station carries the program are Hawaii, Massachusetts, New Jersey and New Mexico. Thirteen other states have only one station broadcasting the program. They are Alaska, Idaho, Maine, Minnesota, Montana, Nevada, North Dakota, Oregon, Rhode Island, Vermont, Virginia, Wisconsin and Wyoming.

No station is too large or too small to be considered. We have several with 50,000 watts of power (the FCC limit) and one as low as 125 watts. The weak ones can serve a small city as well as the strong ones can serve a big city.

If you know someone with a nearby station, or feel you could get a station interested in broadcasting the program, you or the station may write to Hymns from Harding, Station A, Box 586, Searcy, Arkansas. We will send information and an audition tape if they should want to consider the program.

## President's Corner

### The Cost of Education

Christian undergraduate education would be even costlier if those who stand to benefit most by a Christian education were forced to pay what it really costs.

In 1956-57 the cost of attending an undergraduate college averaged \$1500 a school year at public institutions and \$2000 at private ones. The cost of attending college has more than doubled in the last 10 years.

According to **The Oklahoma Teacher** May, 1958, about half our college students come from families with annual incomes under \$5000. (61 per cent of the nation's families fall in this salary bracket). About 10 per cent are from families with incomes of less than \$3000.

While 6.1 per cent of American families reported incomes of less than \$1000, only 2.7 per cent of college students came from these families. At the other extreme, one-half of one per cent of the families in the national sample had incomes of \$25,000 or more, yet they supplied 3.4 per cent of the college students, or nearly seven times their normal ratio.

Who pays the bill? Sixty per cent of the money comes from family funds and savings. Student earnings furnish 26 per cent, of which 17 per cent is earned during the school year. Only five per cent

of college costs are defrayed by scholarships. Twenty per cent of the students receive such assistance, but the median award is less than \$300.

What are the implications of these facts for Harding patrons and alumni? First we should decide the worth of a Christian education. Then depending upon the size of our income we should follow one of several plans of action:

1. Begin to save from our regular income for our children's Christian college expense.
2. Contribute money to Harding College to provide scholarships for the able, worthy student who through no fault of his own is financially unable to attend college.
3. Find jobs and work opportunities for students during the summer so they may provide as much of their own educational expense as possible.
4. Give regularly to Harding College where you hope your child will attend. This will help the college to meet the growing demands for services and facilities.

### Send Your Nominations

The first **Distinguished Alumnus Award** was given last June at graduation honoring L. O. Sanderson of Amarillo, Tex., as the recipient.

The second Alumni award will be made again this year at graduation. Your help is needed in selecting the names of those who will be considered.

Please think of those whom you knew at Harding who in your judgment, merit consideration. With each name submitted, please give us all the information you can to help the committee in making a decision.

The following points are suggested as criteria to guide you in your nomination of a candidate for the award:

1. Achieved a degree of excellence and recognition in his chosen field.
2. An active supporter of Harding College.
3. A graduate of Harding College.
4. A life consistent with the ideals of the college.

Other factors will be taken into consideration, but these are the essential points.

Your suggestions are earnestly requested. Names should be submitted not later than May 1.

Such have been the expressions of love, gratitude and generosity that accompanied the gifts that alumni, students and friends sent to the Florence Cathcart Memorial Book Fund.

To date the amount received for this fund is \$270, and it is our hope that future contributions will enable our children's literature collection to experience a steady yearly growth.

Although Mrs. Cathcart did not have access to the books which are now available to students, she would, because of her unselfish nature, be happy to know that today's classes can enjoy the work of writers and artists who are giving their talents to creating a wonderful world of literature for children of all ages.

It would please her to know that on our shelves she would find the Newberry winners represented by such titles as **Call It Courage**, **The Cat Who Went to Heaven**, **Strawberry Girl**, **Secret of the Andes**, and **Carry On, Mr. Rowditch**. Representative of the Caldecott winners are **The Biggest Bear**, **Make Way for Ducklings**, **Prayer for a Child**, **Nine Days to Christmas**, and **A Tree Is Nice**.

The enduring classics are now available in beautifully illustrated editions that no child has to be coaxed to read. In addition to separate titles, anthologies of both prose and poetry have been acquired. To help students judge the literature for children, titles such as **Books, Young People and Reading**, and **Let's Read Together** are available for consultation.

An interesting sidelight to the use of the collection is that married students in the Children's Literature class are now trying out their classroom theories on their children at home. They are finding out first-hand if particular books do really appeal to children at certain ages.

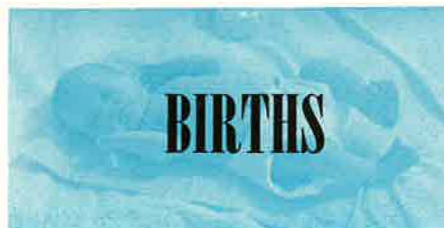
