HARDING ALUMNI BUSY AT 10th GERMAN LECTURESHIP

The 10th annual European Lectureship, held in August in Frankfurt, Germany, drew representatives from 16 nations of Europe, Africa and Asia. At least 15 Harding alumni were on hand, with six conducting part of the lectures.

Evening lectures were built around the theme "Adding to Your Faith." Morning lectures expanded from the theme "The Church in Paul's Epistles." A class for men was conducted on "Developing Spiritually" and special classes were also held for women.

Ex-Harding students conducting part of the lectures were Bob Hare (MA'56), Austria; J. L. Roberts (BS'48), Belgium; Dale Buckley (MA'55), Scotland; Gottfried Reichel (BA'53), Germany; and Glen Olbricht (BS'53), Germany.

One of the class leaders, Henry Seidemeyer of Frankfurt, gave this appraisal, "This lectureship is the highlight of the year for many missionaries in Europe. It is the largest gathering of Christians outside the United States and helps the missionaries to return to their work spiritually refreshed."

The closing day crowd added to a total of 400 persons.


SYMPATHY


