## American Heritage and Alumni Center Will Be New Home For Alumni Returning June 2-3

The Alumni-American Heritage Center is scheduled for completion this spring, in plenty of time to provide a "home" for alumni when Homecoming rolls around June 2-3.

A major addition to Harding's facilities for greater service and filling many needs, it includes a large cafeteria, an auditorium, conference rooms, alumni reception room and offices, and rooms for 150 guests. The Freedom Forum, Christian Workers' Workshop, Thanksgiving Lectureship, science, educational, business, professional and community groups will benefit from it.

Alumni chapel starts at 10 a.m. Wed-

nesday, June 2, under the direction of the Class of '40, which will be holding its 25-year reunion. E. LaMar Baker, class president, will be chairman. A reunion luncheon will be held at the Rendezvous Restaurant at noon. The classes of '25, '30, '35, '40, '45, '50, '55, and '60 will have separate tables for each class. Cost for the meal will be \$1.50 for adults and 75c for children.

Thursday, June 3, will be graduation. Following the ceremonies, alumni will be guests of the college at the annual luncheon. For additional information about the activities see the "Schedule of Events" in this bulletin.





## President's Corner

The goal of any college is to excel in her various areas of endeavor. As a student at Harding I recall Brother Benson emphasizing our pursuit of excellence and stating, "even if you are digging ditches, be the best ditch digger of the crew." Through the years he has demonstrated by his own achievements exactly what he was asking of us.

That this philosophy still characterizes the Harding students is demonstrated daily. For example, after the recent tour our drama group made, we received a letter from their host officer at Ft. Carson, Colorado, stating "Your students have received the best audience reaction of all shows presented at Fort Carson during my duty time with Special Services. The quality of the productions, conduct of the students, and particularly the talent shown by the students, demonstrate the quality of your school and staff."

Last Saturday saw two of our seniors being named to the All-AIC basketball team. Neb Boaz, 5-7 guard, missed by one vote being a unanimous selection for the first team. Gary Goss was selected for the second team.

Therefore, whether it be in the academic area, fine arts, or in sports, our students show their desire to excel. All of us who are alumni can be proud of the many fine accomplishments of the present student body and faculty.

This habit of seeking excellence gained at Harding has stayed with many of our alumni. I can think very quickly of several dozen Harding alumni who are recognized leaders in their chosen careers.

A strong faith in God and a desire to be of service both to God and our fellow man marks the Harding product. His power to excel is not only a matter of self-application but of letting God direct and guide from within.

## Gary Blake Assumes New Position in States

**Gary Blake** (BA'59) is project coordinator of a research project with the deaf which is jointly sponsored by the Arkansas Rehabilitation Service and the Vocational Rehabilitation Administration.

The purpose of this survey project which includes young deaf adults in a seven state area — Mississippi, Louisiana, Arkansas, Missouri, Kansas, Oklahoma and New Mexico — is to determine occupational status of the deaf; determine rehabilitation needs, especially as relates to needs of vocational training facilities of the deaf; determine criteria for job success and provide information of what employees demand of skills and training before hiring the deaf.

This research project, which began July 1, 1964, and is to end June 30, 1965, is a companion study to one recently completed in the New England states. Henry Kronenberg, Dean of the College of Education at the University of Arkansas, is project director.

Blake received his M.S.E. in 1960 from Gallaudet College, Washington, D. C. He taught at Minnesota State School for Deaf in '60-'62.

In 1962 Blake and his wife **Mary** (BA'55) went to Ethiopia to assist in establishing the first school for the deaf in that country. This service opened the door for missionaries to remain in Ethiopia because according to national law, the church must render some special service to be recognized in the country.

Blake and his wife **Mary** and their two children, **Matthew** and **Elizabeth**, are now living in Hot Springs.
