Kinsey, Clymer Honored; 335 Degrees Conferred

Two nationally known businessmen, California contractor Kersey Kinsey and L. M. Clymer, president of Holiday Inns, Inc., were awarded honorary doctorates at the Harding College graduation exercises held May 14.

Dr. Clifton L. Ganus Jr., president of the college, conferred degrees on 335 seniors and announced honor graduates at the annual ceremonies.

Kinsey is president of the Kersey Kinsey Company Builders in Studio City, a company recognized for architectural and industrial installations and office buildings. He is a native of Nebraska.

Clymer became president of Holiday Inns, Inc. in 1973 and chief executive officer of the organization in 1976. A North Carolina native, he directs the operations of the company, which includes institutional furnishings and products, intercity bus transportation

Computer to Combat Rising Energy Costs

To combat escalating costs of utilities, the college will install an energy-saving system this summer. Called the Johnson Control 80 Computerized Program, the plan is expected to pay for itself within two years and save the college thousands of dollars in utility costs.

Utility bills have more than doubled in the past two years, according to Lott R. Tucker Jr., vice-president for finance. Last year the college paid \$750,000 in utility bills alone.

Administrators investigated the system, which has already been installed in at least one other college in the state, and agreed on the implementation. The new system will cost \$92,000.

Tucker explained the setup for the new system, which will go into effect with the fall semester.

The system will operate on a "duty cycle," which shuts off completely for 12 minutes of every hour of operation. Tucker said the purpose of the project is "to save money and not to disrupt the life of the college." The system can be programmed for a longer or shorter period of shutdown as function necessitated. Experiments have proved that the method will not effect room temperatures essentially.

In addition the plan will include shutting down of power in buildings (Continued on page 2) and ocean-going vessel operations. Special awards presented by

Three faculty members, Lois Brown, assistant professor of special education; Kenneth Davis, professor of music; and Harry Olree, professor of physical education, were named Distinguished Teachers and each received a \$1,000 cash award. Teachers were evaluated throughout the year by their students for the awards.

Mrs. Brown, who holds the master's from San Diego State College, joined the faculty in 1973. She is known throughout the Searcy area and Arkansas for her work with children in special education, with learning disabilities and with emotional disturbances. She has also worked with exceptional children. In addition to writing numerous newspaper articles, she instituted a program in a Searcy school for children with learning disabilities. She also helped write a master plan for special education in Arkansas.

Davis is a graduate of the University of Indiana who attended Harding Academy and College also. He joined the faculty in 1953. Dr. Davis is director of the A Cappella Chorus and Campus Singers. He organized the Harding Belles and Beaux in 1958 and directed

Final Plans Made for 13-in-1 Workshop

Thirteen complete Christian workshops, presented by 90 faculty members from 17 states, will be the fare for the 13-in-1 Bible Workshop planned by the Harding Bible Department for August 7-10.

Dr. Jerry Jones, chairman of the Harding Bible department, said that advance reservations indicate that between 4,000 and 6,000 persons are planning to attend.

The workshops, each with 16 hours of training offered, are in the areas of Biblical forum, bus workers, church leaders, deaf workers, educational directors, mental health, missions, personal workers, preachers, visual aids, Christian woman, youth workers and campus ministers.

The organized program will last from 8 a.m. to 10 p.m. each day, and up-todate mission reports from stateside and abroad will be given.

The program will be for all of the family with youth activities scheduled

for children of participants. The children's program is for those ages three to 17.

Housing accommodations are available in college dormitories, in a variety of nearby motels, in Christian homes and at a KOA campground close to Searcy.

The workshop attendants will meet each morning together for a devotional and singing. During the day the individual workshops will be conducted at various sites on the Harding campus and in surrounding church buildings. For the night session, all groups will assemble in the Harding Athletic Center for a period of singling led by Bernard Lassiter of Houston and an address, presented by Avon Malone, Landon Saunders and Jimmy Allen, respectively.

Nurses Transport Vaccine to Africa

A cargo of 3,000 doses of measles vaccine traveled to the African country of Nigeria May 16 as a result of the cooperative efforts of the Arkansas Immunization Task Force, Merck Sharp & Dohme Pharmaceutical Company, and Harding and its nursing department.

Valued at approximately \$27,000, the vaccine was a gift to Harding from Merck Sharp & Dohme made possible through the work of Mrs. Nell Balkman, coordinator of the Arkansas Immunization Task Force; Dr. Luther DeWeese, Public Health Advisor of HEW Region VI and Don Stenhouse of the Center for Disease Control in Atlanta.

Mrs. Cathleen Smith, chairman of the Harding Nursing Department, said, "We are delighted to be the recipient of such a gift. The Africa setting is in much need of the vaccine and the nursing department is pleased to be of assistance to the Nigerian government in this immunization program."

A group of student nurses from Harding and nursing instructor Janice Bingham departed for a five-week stay at the Nigerian Christian Hospital and hand-carried the vaccine on the plane. The medicine, which required refrigeration, was packaged in five individual containers.

"All student nurses at Harding are required to serve a preceptorship in a health care situation," said Miss Bingham. "Six members of the class interested in medical missions chose to go to the Nigerian Christian Hospital." Miss Bingham also accompanied a group to the hospital last year.

Student nurses making the trip include Beverly Thompson of Davenport, Nebraska; Lola Bowen of Atlanta, Georgia; Carol Huey of Marysville, Ohio; Patty Woods of McRae; Jeffrey Jackson of Williston, South Carolina and Diana Flowers of Santa Clara, California. Each student was required to pay his trip expense of \$1,700.

During their five-week stay, the nursing majors will serve on the staff of the 70-bed hospital. They will rotate responsibilities on ward duty, in the outpatient clinic, which serves 150 persons a day, and in surgery.

Full-time work will also be done at the preventive clinic for children under five years of age. The clinic will be the base for the immunization campaign. According to Searcy physician Henry Farrar, word of the vaccination program will spread to the Nigerian villages surrounding the hospital by word of mouth. Farrar established the hospital in 1965 and returns yearly for short stays. "What this vaccine is going to do," said Farrar, "is save the lives of thousands of children."

The team also plans to teach children's...Bible...classes...and visit churches of the villages. Their working day.will.begin with a staff devotional at 7:00 a.m.

OBU is only the second private institution ever to win the All-Sports competition. Harding was the first when the Bisons won⁻ the 1975-76 championship.


Harding won two conference championships this year with victories coming in cross country and bowling. A second place finish was recorded in swimming, a third in tennis, fourth in track and fifth in golf.
