### Phase IV Campaign Launched, Buildings Planned

Growth and expansion on the Harding campus will continue as three major building projects have been approved by the Board of Trustees. The three-year, \$5.6 million campaign has been designated as "Phase IV The Decade of the Eighties."

Early 1980 will signal the completion of the George S. Benson Auditorium and the beginning of work on Phase IV. Projects will include a \$1.2 million Business and Economics Building, construction of a \$1.25 million building for the Harding Academy in Searcy and a \$400,000 expansion of the Science Building.

In addition, the campaign will include \$500,000 endowment for the American Studies Program and the Center for Private Enterprise Education and \$2.25 million for operational supplementation.

"The next ten years will bring into even sharper focus the impact of inflation, spiraling costs and the need for both expanded facilities and increased endowments," President Clifton L. Ganus said. "This campaign will help us to meet those demands."

Construction on the Business and Economics Building will begin during the 1980-81 school year. In addition to the School of Business, the building will house the American Studies Program, the Center for Private Enterprise Education, the Educational Media Center and the Computer Center.


The building will house nine classrooms, a seminar room and a study lounge on the second floor. Also included will be 14 faculty offices, a reception area, a faculty conference room and a computer laboratory room.

Already under construction is the \$1.25 million Harding Academy Building. It will be located on the southeast corner of the campus near Alumni Field.

The 47,000 square foot building will include six elementary classrooms, 14 high school classrooms, an auditorium, a library, a gymnasium and administrative offices. Completion of the Academy is projected for the fall of 1980. Upon completion, the present facilities will be removed to provide space for the Business and Economics Building.

The \$400,000 expansion of the Science Building will include two new laboratories, two classrooms, a seminar room, a Math Education Learning Center, seven faculty offices and the conversion of two classrooms into laboratories.

The present building was completed in 1967 for a projected enrollment of 2,000 and the much needed space will provide greater use and flexibility of scheduling for students and faculty.



Construction on the proposed \$1.2 million Business and Economics Building is scheduled to begin during the 1980-81 school year. It will be located on the southeast corner of Center and Blakeney, across from the new Benson Auditorium.

"The facilities have been planned with frugal care, yet attention has been given to the expanding needs of our student body, which this fall exceeded 3,000 for the first time," Ganus said.

"The expansion represents tangible evidence of interest and concern for Christian education," he said, "and we want to meet the needs of our students in the best way possible."

### Christian Home, Text Study Included in 13-in-1 Topics

The individual programs of the 1980 13-In-One Workshop at Harding University, scheduled for August 4-7, will include sessions on Biblical Studies and the Christian Home.

The workshop on Biblical Studies will focus on four areas. Studies in the book of *Ruth* will be conducted by Neale Pryor of the Harding Bible Department. Jim Woodroof, minister of the College Church of Christ in Searcy, will teach the *Gospel of John*. Ephesians will be the topic of Avon Malone of the Bible Department, and

Jimmy Allen of the Bible Department will teach *Hebrews*.

The program will be in the George S. Benson Auditorium with Will Ed Warren serving as host.

The second workshop on the Christian Home will be held in the College Church of Christ and hosted by Jack Thomas.

C. W. Bradley of Memphis, Tenn., will talk on "How Do We Prepare Our Sons to Be Spiritual Leaders." Ken Dye (Continued on Page 2)

## Lomanco Head to Deliver Winter Graduation Speech

Del Belden, president of the Lomanco Corporation of Jacksonville, Ark., will address the final graduating class of 1979 on December 21.

Belden is an active supporter of the American Studies Program and the Center for Private Enterprise Education, and is the sponsor of a \$90,000 research project conducted by the school's physical science department.

The 52-year-old company head obtained his formal education through the ninth grade in 1941 but returned to the classroom in 1977 as a student in the School of Business.

Born in Shields, N. D., Belden was raised in Minnesota. In 1946 he joined with five men in founding the business which he now independently owns. His company manufactures louvers for sale to mass merchandising companies and wholesale contractors. Belden's sales this year have reached \$20 million.

He and his wife have four sons, one daughter and eight grandchildren.

registrar, 128 candidates will receive degrees. A total of 410 have received degrees in the two previous commencement exercises.

The ceremony will begin at 10 a.m. in the Main Auditorium.

### **April Forum to Explore 'Cults'**

"A Study in the Cults" will be the topic for the 1980 Harding Preachers' Forum scheduled for April 8 on the Searcy campus.

The full-day program, sponsored by the Bible Department, will include five lectures, and two question and answer sessions.

"Anyone who watches television, reads the newspapers or goes into an airport has seen the growth of cults in this country," said Dr. Jerry Jones, chairman of the Bible Department. "The topic is quite relevant to preachers and church leaders today," he continued.

Speakers will be John Waddey of

Knoxville, Tenn., on "Why Do People Join Cults?"; Ed Sanders of Searcy on "Daily Life in the Cults," "Bibliography and Cults" and "What Can We Learn From Cults," and Bob Dankelfsen of West Monroe, La., on "Disengaging From a Cult."

Panel members for the feedback sessions are J. D. Bales of Searcy, Marvin Robertson of Searcy and the forum speakers.

While the day is generally planned for the church leadership and ministers, Jones stressed that anyone interested in the topic of cults would profit from the seminar, which is open to the public.

### Management Seminar Set for February 9-10

The eighth annual Management and Economics Seminar for businessmen on February 9-10 will feature Dr. Ben Rogge of Crawfordsville, Ind., and Dr. Charles Hughes of Dallas.

Sponsored by the American Studies Program and the School of Business, the program will be held in the American Heritage Auditorium on the campus.

On Friday night, Dr. Rogge, a distinguished professor of political economy at Wabash College, will speak on "Economic Perspectives of the '80's."

Rogge has taught at the University of Sao Paulo in Brazil, Northwestern University and the University of Minnesota and has also served as dean of Wabash College. He has lectured for bankers, public utility executives, businessmen, teachers and ministers.

The Nebraska native was chairman of the board of the Foundation for Economic Education of which he remains a member. He has been director of the Wabash Institute for Personal Development, a summer training program in liberal arts for business executives.

Rogge's lectures will be at 7:30 p.m. and 9 p.m., followed by a question and answer session. Friday's program will open with registration at 5:30-6:30 p.m. and a dinner at 6:30 in the Heritage Cafeteria.

Dr. Hughes will speak Saturday on "Making Unions Unnecessary." His

8:30 a.m. session will include the topics Management Commitment and Communication, Basic Assumptions of Non-Union Companies, Pay Policies and Benefit Program, and Problem Solving.

Dr. Charles Hughes

At 1 p.m. he will cover Communication Programs; Selection, Placement and Promotion Policies, and Value Systems.

Hughes is the director of the Center for Values Research in Dallas. His articles and concepts have appeared in Harvard Business Review, the Wall Street Journal, AFL-CIO News, Industry Week, the Chicago Tribune and U.S. News and World Report.

He is the author of four books: Goal Setting, which won the McKinsey Foundation Award for Excellence, Management Without Interference, Making Unions Unnecessary and Value Systems Analysis: Theory and Management Applications.

Prior to entering private practice, Hughes was a consultant at IBM Corporate Headquarters.

"We are grateful for what she has been in example as a mother, wife, business woman and Christian," he said, "and this gift is an extension of the giving attitude that has characterized her life."

The septuagenarian continues to work full time, following a pattern that has been her routine for years. She has served as president of the PTA on the elementary, high school and county levels and has been active in Women of the Motion Picture in Fulton County. She is the oldest charter member of the Sandy Springs Church of Christ.

Further indicative of the verve and kindness of this lady is that she dons a Santa suit each year and makes a call on local nursing homes to bring cheer to the residents, a practice she's been doing for years.

At the conclusion of the celebration, Mrs. Brannon received yet another surprise—a decorated birthday cake prepared for her.



### **Reichel Named Distinguished Alumnus**

Gottfried J. Reichel of Munich, speaker on World Radio Germany and long-time minister of the Gospel, received the Harding University 1979 Distinguished Alumnus Award during Homecoming November 9-10.

Dr. Winfred Wright, alumni

Dr. Winfred Wright, alumni association president, presented the plaque "In recognition for his many years of dedicated service to the church, for his devotion to world missions, for his contribution to radio evangelism and for exemplifying the ideals of Harding University."

Reichel's broadcast over Radio Luxemburg, which he calls "a vital tool of evangelization among the 120 million German-speaking people of Europe," has had growing response through the years, especially from behind the Iron Curtain. In October he received the 35,400th written response from the effort.

A former Hitler youth, Reichel was a refugee from the Russian Zone following World War II when he came to Munich to locate his brother. Without papers or identification in his war-torn homeland, the teen-ager, almost without any hope remaining, was befriended by American soldiers who showed him Christianity as a way of life. He began preaching almost immediately and has declared, "Ever since I was baptized into Christ I felt the responsibility to bring others the message of salvation, and especially to the people of my own nation. To keep Germany a peaceful nation will only be possible if the people know about the message of peace, a peace which comes not through arms, but the Gospel of Christ, which gives the obedient the power to make peace with God, with his fellowman and with

### Harriers Take AIC, Place in Nationals

Rounding out one of their finest seasons ever, the Harding University cross country team finished 16th in the NAIA national meet after capturing Arkansas Intercollegiate Conference and District 17 Champsionships.

With junior Richard Teixeira earning NAIA All-America status with a 25th place in the NAIA championships in Kenosha, Wis., the Bisons registered their highest national finish since 1968.

"Despite losing two of our top runners during the actual race, one to injury and one to illness, the boys did a tremendous job for us," coach Ted Lloyd said.

In the NAIA meet, John Sills of Eads, Tenn. placed 55th, Joe O'Conor of Augusta, Maine was 134th, Mark Piller of Neenah, Wis. was 163rd, and Randy Jackson of Springdale, Ark. was 197th among 250 runners who finished.


On the conference and district level the Bisons recorded a perfect low score of 15 to completely dominate the competition. Harding, which hosted the meet at the Bald Knob Country Club, finished first through sixth to become only the second team in AIC history to record a perfect score. The 1965 Harding team was the first.

The team championship was its ninth consecutive AIC title and its 15th in the last 18 years.

Teixeira won the individual AIC and District 17 champsionship with a time of 25:37 over the five-mile course.

Bison runners John Sills and John McAlister of Temple Hills, Md., finished second and third with both crossing the finish line in 16:18. Close behind in the next three places were Randy Jackson (26:21) of Springdale, Ark., Carter Lambert (26:28) of Pearl, Miss., and Joe O'Conor (26:46) of Augusta, Maine.

Howard Sennett of St. Petersburg, Fla. placed 14th in 28:01.

### Roundballers Post 7-5 Record Early in Season

Harding basketballers jumped off to a fast start and have posted a 7-5 record in early season action.

The Bisons, under head coach Jess Bucy, races out to a 7-1 record, which included winning a third place trophy in the Evangel Classis in Springfield, Mo.

Utilizing a running game and rotating eight to ten players, the Bisons have averaged 79.3 points per game and head their opponents in rebounding average by a 38.2 to 35.9 margin.

Junior Ricky Treadway of North Little Rock is

leading Bison scorers with a 13.8 ppg. average. He is followed by freshman Hubie Smith of Memphis at 13.3 ppg, junior Tim Flatt of Memphis, 12.3 ppg and junior Bruce Baldwin of Jacksonville, Ill., 10.8 ppg.

Teamwise, Harding is shooting .519 from the field and .775 at the free throw line.

James Winston, a 6-7 senior from Memphis is the leading rebounder with a 7.5 average per game and Kenny Moorer is pacing the team in assists with 4.8 per game.
