George Benson to Receive Horatio Alger Award

President Emeritus George S. Benson has been named a recipient of the 1981 Horatio Alger Award. Benson is among 19 business leaders nationwide who will be presented the award in Hershey, Pa. May 15.

The honor is named for Horatio Alger, the author who developed in his 123 novels heroes who rose from poverty to power. The awards program was conceived in 1947 by Dr. Kenneth Beebe of the American Schools and Colleges Association to encourage youth to realize that, in America, success may be achieved by anyone who is willing to work for it.

Previous recipients of the Horatio Alger Award include Ronald Reagan, Dwight D.

Eisenhower, Herbert Hoover, J. C. Penney, Edward Rickenbacker, Dorothy Shaver, John D. MacArthur, Bernard Baruch, Pearl S. Buck, Conrad Hilton, Clare Booth Luce and Bob Hope.

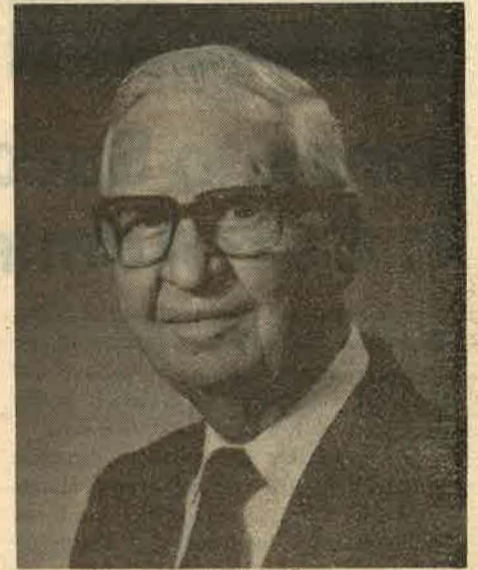
Benson was born in Oklahoma Territory to homesteader parents. He and four siblings worked on a 160-acre farm on the former Cheyenne-Arapaho reservation. Though an eighth-grade graduate could become a schoolmaster, Benson completed the studies at the local one-room schoolhouse and decided he "... could be more useful with more education." By serving as a farm hand and janitor, Benson worked his way through high school.

At age 17, Benson became a Christian and a preacher. He enrolled at Kansas' Harper College to learn more about the Bible and he completed his B.S. degree at Oklahoma A & M in 1924.

Later, Benson became principal of Harding's preparatory academy in Arkansas, where he earned a B.A. degree and where he met and married Sallie Hockaday. The couple became the first Church of Christ missionaries to enter China, and they remained in the Orient for 11 years. Despite Communist threats, Benson succeeded in opening Bible and English schools in Canton and created a "school for the poor" for the children of the coolies.

In 1936, Benson became president of Harding, obliterating the college's debt in three years. Until his retirement in 1965, Benson annually raised a million dollars for Harding for 29 years.

Benson is president and executive director of the National Education Program. Through his lectures, his own radio show and his newspaper columns, he

has consistently spoken out for the free enterprise system and against the Communist menace. His work has won recognition, directly or indirectly, from the Freedoms Foundation every year since 1949.

Texas Senator to Speak To 360 May Graduates

Texas State Senator Ed Howard will speak to Harding graduates during the spring commencement ceremonies May 10.

A total of 360 students have applied to receive degrees in May, according to Virgil Beckett, registrar.

Howard, of Texarkana, Texas, is a graduate of Abilene Christian University. He received his B.S. degree in 1955 and later pursued graduate studies in municipal administration at Southern Methodist University.

In 1959 Howard assisted in opening a family franchised discount center in Texarkana. The venture grew into a corporation with 30 outlets in five states. During his 18 years in retailing, he rose to the position of chief operations officer.

Elected to the Texas legislature in 1969, Howard served three terms, retiring in 1975 to devote more time to the family business. While a member of the House of Representatives, Howard was on several committees, being chairman of the House Administration Committee. In 1974 he was a delegate to the State Constitutional

Convention. He was elected to the State Senate in 1978 and presently represents 14 counties.

Howard has been appointed vice chairman of both the Finance and Administration Committees and of the Sunset Advisory Commission, a state agency review board. He is also a member of the State Affairs Committee, the Subcommittee on Nominations and the Subcommittee on Rules for the 1981 legislative session.

Additionally, Howard has twice been selected by Gov. Clements to attend the Southern Regional Education Board's Legislative Work Conference, a 16-state gathering of educators and legislators who desire to upgrade and improve higher education.

Howard is involved in numerous community organizations, and he remains active in real estate and development as well as in his family's farm and cattle operation near his home.

Howard is married to the former Jo Ann Jay of Abilene. They have four children.

Commencement exercises will be held at 2:30 p.m. in the George S. Benson Auditorium.

Baxter to Address HGSR Graduates

Dr. Batsell Barrett Baxter is scheduled to speak to the 1981 graduates of Harding Graduate School of Religion in Memphis during commencement exercises May 16.

Degrees will be awarded to 52 candidates, including 30 applicants for the master of arts degree, 21 for the master of theology and one for the doctor of ministry.

A total of 660 alumni of the institution are now serving in 40 states and 20 foreign countries.

Enrollment at the Graduate School has more than doubled in the last ten years, according to Bill Flatt, registrar. The spring semester count, 259, shows an increase over the 1980 figure of 242. The current student body represents 34 states and two foreign countries.

Groundbreaking Ceremony Held for Business Center

The band played, the sun shone, the cameras rolled, the remarks were kept short and the shovels dug deep on March 20 for the long anticipated groundbreaking of the \$1.88 million J. E. Mabee Business Center. Barring unforeseen delays, the two-story, 34,700 square foot structure is expected to be ready for use at the opening of the fall 1982 semester.

Remains of the Academy building, erected in 1948 for initial use as an industrial arts building, were cleared shortly before the ceremonies. Actual construction got underway the week of March 23.

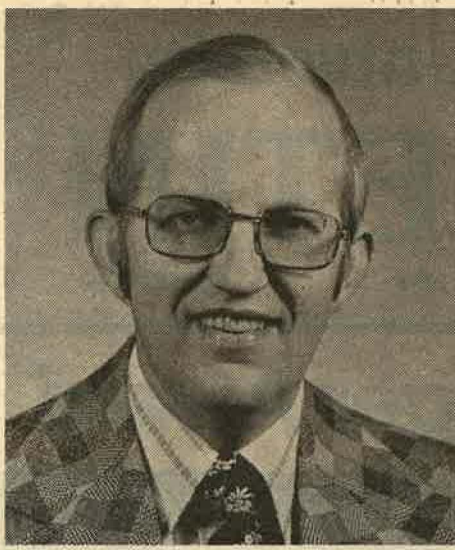

Jones to Succeed Sanders In CCP Administration

Joe D. Jones, assistant professor of Bible, will assume the duties of director of the Christian Communications Program (CCP) in August, succeeding Ed Sanders, it was announced by President Clifton Ganus.

"We appreciate the excellent direction which Ed has given to the program," Ganus expressed. "I am confident that Joe Jones will carry on the good work and the entire program will continue to grow and prosper."

The CCP is an intensive two-year training program for those who desire to be completely qualified for full-time work in the church.

Ed Sanders has served as director of the program since its inception in 1974 and has worked with Jones since he became assistant CCP director in 1978. "He is a splendid co-worker," Sanders said of Jones, "and he has my complete confidence."

Sanders will resign from his administrative duties "... so that I may spend more hours in the university classroom and in research and writing which is vital to the proper instruction of our students at Harding. My teaching load in the Christian Communications Program will remain unchanged."

Under Sanders' direction, the program has graduated 88 students, who are now serving congregations in 21 states and five foreign countries. Currently, 37 students are enrolled in the CCP.

High School Citizenship Seminar To be Held on Campus June 7-13

Former Dallas Cowboy footballer Cliff Harris will highlight the 25th Annual Youth Citizenship Seminar for high school students June 7-13 on the Harding campus.

Sponsored by the Arkansas and Tennessee Farm Bureaus, Civitan International and the Harding American Studies Program, the Americanism program will feature nine outstanding speakers.

Harris, a graduate of Ouachita Baptist University, was a four-time All-Pro selection and played in five Pro Bowls. He is a member of the National Association of Intercollegiate Athletics Hall of Fame.

Former Minnesota congressman Dr. Walter H. Judd will return to the seminar. Judd was a medical missionary in South China and is now a contributing editor for *Reader's Digest*. He lectures at many colleges and universities throughout the country.

Dr. Clifton Ganus Jr., president of Harding, has traveled extensively in Europe, making studies of European socialism. The history professor was also one of 30 higher education administrators selected to tour the People's Republic of Red China in 1979. His address, "Our American Heritage," received the Freedoms Foundation Award.

Miss Lori Cox, a student at Arizona State University, is a Freedoms Foundation Award recipient for outstanding address by a teen-ager. She has been instrumental in promoting a congressional bill to establish a National Patriotism Week.

Making his fifth appearance at the seminar, Commander Stephen Harris will include his experiences in the U.S. Pueblo incident in his presentation. A prisoner of war for 11 months, he was responsible for organizing and encouraging religious activities of the American prisoners. He is the author of a book, *My Anchor Held*; and is currently director of the Navy Drug Abuse Counselor School in San Diego, Calif.

Harding President Emeritus George S. Benson is known nationwide as a spokesman in behalf of the American way of life. He served as a missionary in China and witnessed first hand the internal struggle

Teacher Education Program Reviewed by NCATE Team

A ten-member team from the National Council of Accreditation for Teacher Education (NCATE) was on the Harding campus March 22-25 to review the University's teacher education program.

Harding's teacher education program, accredited since 1961, has not been reviewed in ten years, and the on-site study was to determine extension of accreditation, according to Dr. Bobby Coker, dean of the School of Education.

Previously the programs have received a maximum ten-year approval, but new regulations will require re-examination and accreditation at least every eight years.

Harding submitted an extensive written self-study of the program to the Council earlier in the school year in preparation for the visit. Using the guidelines of NCATE, the team validated the institutional report, Coker said.

"The examiners also made an assessment of whether or not we met NCATE standards," he said, "and we met the standards and the substandards." In reviewing the strengths and weaknesses of the program, the team cited no significant weaknesses, according to Coker.

The examination team's written report, a response from Coker and the school's self-study will be submitted to the National Council, which will determine the length of accreditation for Harding's program in June.

Administrative representatives included vice presidents J. E. Pryor, Floyd Daniel and Lott R. Tucker Jr., as well as David Burks, dean of the School of Business.

Mayor Wiseman, a Searcy native, reflected from 35 years ago when he had attended Harding. In lauding the standards of Harding, he noted "Harding has upheld her standards better than any other institution I know of anywhere." The city official also recalled his involvement with the construction of the original building. "I hauled concrete and helped make blocks for that structure," he said, "and frankly I kinda hated to see it go."

Dr. Ganus introduced Herman Spurlock, W. T. "Shorty" Pearson and Chester Williams, who will supervise the construction of the Business Center.

The platform crew received miniature souvenir shovels, but later manned the real tools for the ceremonial digging. Afterwards Ganus and Tucker climbed on a dozer parked at the site to pose for photographers, simulating the speed which they hoped would characterize the construction.

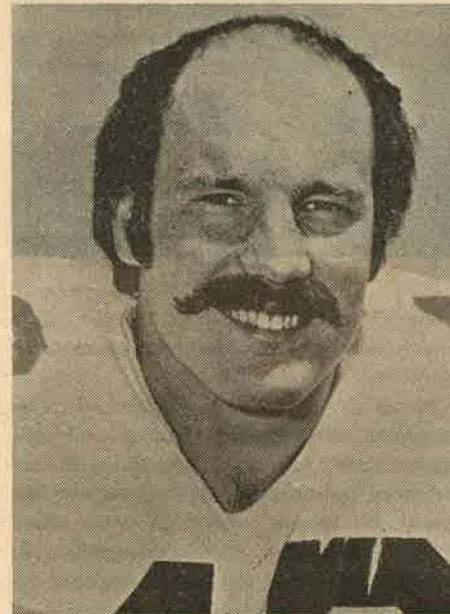
The Business Center is the last building scheduled in the immediate plan of the University. It will be the 18th major project for the administration of President Ganus, who took office in 1965.

The others include the Science building (1967), Stephens dorm (1968), Keller dorm (1969), Stevens Art Center (1969), Harbin dorm (1971), Hammon Student Center (1973), married students' apartments (1974), women's residence dorm (1975), Athletic Center (1976) and Benson Auditorium (1980).

During the period, major additions or complete renovations were completed, including Claud Rogers Lee Music Center (1966, 1969), Beaumont Memorial Library (1971), Alumni Field (1971), Ganus Building (1973), Ezell Bible Building (1974), Student Services Building (1974), and Olen Hendrix (formerly Old Science) Building (1975).

Outstanding student leaders from high schools in Tennessee, Arkansas, Florida, Alabama and Georgia will participate in the week-long event.

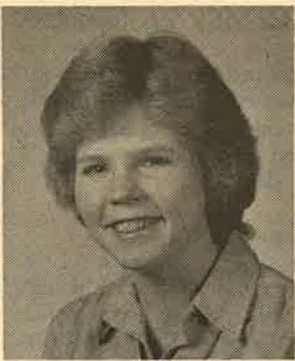

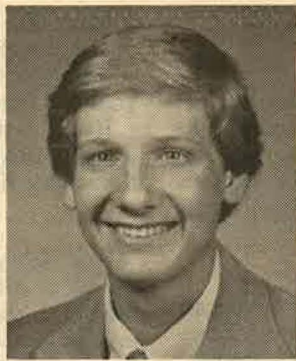

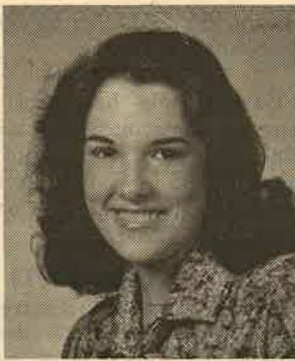

Psychology Teacher Earns State License

Dr. Robert McKelvain, assistant professor of psychology, has completed requirements as a licensed and certified psychologist by the Arkansas Board of Examiners in Psychology. McKelvain is the fourth member of the Harding faculty to attain certification.

Others holding the psychologist certificate are Dr. Jack Thomas, director of counseling and chairman of the psychology department, Dr. Lew Moore, assistant director of counseling, and Dr. Allan Isom, professor of Bible.

McKelvain scored 173 of a possible 200 on the tests, achieving the highest score in Arkansas and ranking in the highest 17 percent nationally on that test date.

"This is quite an accomplishment for an individual in our field, and we are especially proud, thankful and fortunate to have him on our staff," Thomas said.

Bison Boosters Sponsor Jogathon, Donor Response Totals \$93,551

With 788 joggers representing 4,800 sponsors, a Bison Booster-sponsored Jogathon has netted \$93,551 for Harding.

Bill J. Harris, Booster Club president and member of the President's Development Council, directed the fund raising effort. The Booster Club's proceeds will be used to light the recently completed Jerry Moore Baseball Field.

Under the rules of the Jogathon, the remaining 88 clubs and organizations participating in the event received proportionate funds for their own use.

Monies collected represent slightly more than 90 percent of the \$103,521 pledged during the drive. "We are well pleased with the response," Harris said, "and we are certainly grateful to all those who participated in the project." Harris himself collected \$1,006.75 in his name.

Individually among the student body, Wayne Ard, a junior from Richardson, Texas, collected \$1,030, or 100 percent of his pledges. His social club, Alpha Omega, was also the winning club and received \$100. Ard was awarded a pair of running shoes. Among the women, Lee Ann Jones Kemp of Ringling, Okla. was the winner, collecting \$596.

President Clifton L. Ganus took honors among the faculty and staff as well as overall by having a total of \$14,601 sent in his name. Dean Priest, chairman of the mathematics department, was second with \$1,471.50. In the non-Harding personnel category, James Branyan of Camden, a member of the President's Development Council, was responsible for \$4,726. Harris was second.

The department of physical science realized \$14,875 to lead that category and the A Cappella was second, garnering \$5,152. Second to Alpha Omega's \$1,368 was Sub T-16 men's club with \$1,319. Kappa Phi took the honors in women's clubs with \$2,903 and Tri-Sigma Delta was runner-up with \$1,521.

Harris, who was aided by his wife, Lil, in collecting data for the Jogathon, said the overall figures represented a phenomenal \$5.82 per lap run.

Summer Bible Workshops Planned for Church Leaders

A full week of study and fellowship is planned for visiting youth ministers when Harding hosts the Youth Ministers' Seminar May 11-15. Two other summer Bible programs are scheduled in June, according to Bible department chairman Jerry Jones. A Counseling Workshop is planned for June 15-17, followed by a Church Leadership Seminar June 18-20.

Participants in the Youth Ministers' Seminar will have the option of earning two hours of college credit during the week. The program will feature lessons taught by familiar brotherhood speakers, including "Curriculum" - Bobby Hise of Albuquerque, N.M.; "Spiritual Life of a Youth Minister" - Wally Wilkerson of Ft. Worth, Texas; "Program Planning" - John Paul Blankenship of Lubbock, Texas and "Techniques in Counseling" - Ken Dye of Stillwater, Okla. Directors of the workshop are Blankenship and Jones.

The Counseling Workshop, co-sponsored by the Bible and psychology departments, is designed to develop counseling skills and

techniques. The workshop will be limited to 30 participants. Required textbooks will be sent to each registrant and should be read prior to the workshop.

The opening session of the counseling program will be "Facilitative Conditions," a discussion of the empathy, positive regard, genuineness and specificity of content necessary in counseling. Other first-day sessions will concern physical attending. Supplementary materials will be recommended to counselors during a library session.

On June 16 workshop participants will have group exercises in attending to verbal messages and recognizing non-verbal cues. A second library session will be held. Topics for the final day of the workshop will be "Helper Self-disclosure" and "Confrontation in One-to-one Relationships."

The Church Leadership Seminar will be led by Dr. David Burks, dean of the School of Business, and Dr. Bobby Coker, dean of the School of Education. The purpose of the program is to develop further the leadership skills of present and future church leaders.

Topics during the three-day seminar will be "New Testament Concept of Leadership," "Church Leadership Style Test," "Models of Leadership," "Leadership by Objectives," "Organization Skills," "Motivational Skills," "Conducting Effective Group Meetings" and "Communication Skills." Also, seminar participants will view a film entitled "Keep Reaching." The program will end with an implementation and evaluation period.

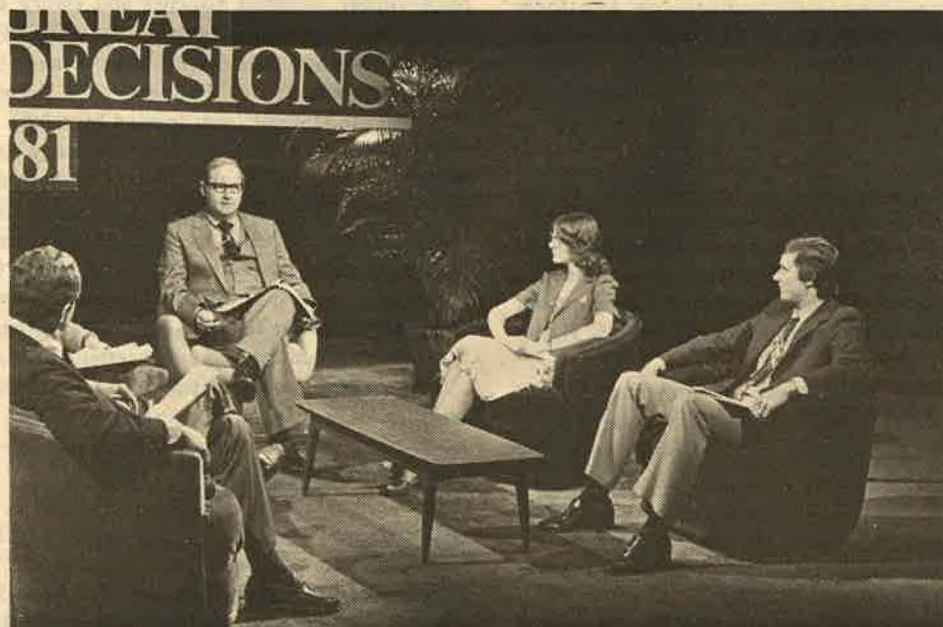

Students Give 'Gift of Love' to Nursing Home Patient

Frances Walker can't talk. And she can't use sign language, because she can move only her head, her right thumb and her left knee. But, thanks to the work of Harding's JOY organization and the contributions of Harding students, Mrs. Walker has regained the ability to communicate.

A victim of amyotrophic lateral sclerosis (ALS), Mrs. Walker, 52, has been a Leisure Lodge nursing home patient since May 1977. Because her disease has affected many muscles, including those in her throat and face, she has great difficulty communicating.

In 1973, Mrs. Walker experienced back pain and frequent falls. She was diagnosed as having ALS, a disease of the spine for which there is no cure. Still, she tried. She used four experimental drugs and even went to Florida to submit to a snake venom treatment, which could only halt the progression of the disease for two weeks.

Last March, Debbie Hooten, a Harding student from Amarillo, Texas, befriended Mrs. Walker. "I used to work at Leisure Lodge," she explained. "All the aides would avoid Frances because she couldn't communicate. Frances would get frustrated with the aides, and they would get frustrated with her because they couldn't understand her."

Miss Hooten, chairman of the JOY Elderly Committee, spoke with Dan Tullos, her speech pathology teacher, about Mrs. Walker's problem. "He had been talking about non-verbal communication in class," she said. "He and his assistant, Gina Miller, arranged for

Frances to have a communication machine for a free one-month trial."

The machine, explained Tullos, is an electronic communication system, a "ZYGO Model 16 Communication Board." Similar to a briefcase in size and shape, the device has 16 message panels. When activated by a foot pedal, a light moves across each of the four rows of panels until the pedal is touched again, stopping the light on one message. For Mrs. Walker, the pedal is attached to the

inside of her wheelchair so she can operate it with her knee.

"This particular system was good for Frances," Tullos said. "It is a 'closed' — a very limited — system, but it was appropriate for her because of her severe lack of mobility." To add a little more versatility to the system, the light panels were divided in half so that Mrs. Walker could convey her choice of 32 messages. Some of the statements included "I'm hungry," "Talk about your family" and

"Please take me outside." There was also a request to "spell the alphabet" so that Mrs. Walker could nod to select letters to spell out messages which were not on the board. Before she had access to the machine, this had been her only means of communication.

At the end of the November trial period, the \$600 machine had to be paid for or returned. Again, Miss Hooten volunteered to help Mrs. Walker. She and other JOY members displayed the communication machine in the student center and told the story of Frances Walker, while Harding students generously chipped in to buy the machine. The full amount was collected, and the machine was purchased.

Miss Hooten announced the victory in chapel on Jan. 29, and Mrs. Walker was brought on stage as her own previously spelled-out message was read to the student body:

"Before the machine, when I had trouble making people understand, I felt like I was fighting my battle alone. My battle is my mind knowing what I want but my body won't cooperate. Thank you for helping me fight my battle."

Recently, Mrs. Walker received a letter from Arkansas Gov. Frank White, congratulating her on her patience and rejoicing with her over her new communication aid.

Harding's Speech Clinic received a letter from the Governor, too, commending the students on their concern for others and thanking them for their generous "volunteerism in this age of need," Tullos said.

Campaigners Planning Summer Outreach

This year, as in years past, more than 15 percent of Harding's students will dedicate a portion of their spring and summer vacations to evangelistic outreach.

Already completed this year, the spring break campaigns involved a total of 103 students who spent the week of March 6-15 knocking on doors and setting up Bible studies in Michigan, Iowa, Illinois and Mississippi. Collectively, the efforts distributed 21,500 pieces of literature introducing the church and produced a number of new Christians, in addition to setting up more than 275 Bible correspondence studies, according to Harding Bible teacher L. V. Pfeifer, director of the campaigns.

Another week of work is scheduled for campaigners following graduation. These May campaigns, organized by Jim Woodell of Searcy, will place workers in Arkansas congregations to boost gospel meetings and vacation Bible schools, as well as to conduct personal Bible studies.

This May, the ten mission teams will work in Alma, Atkins, Augusta, Benton, Brinkley, Clinton, El Dorado, Marked Tree, Turrell and Walnut Ridge. Approximately 100 workers will be involved in the program, including more than 20 students of Harding Academy.

The most extensive efforts are scheduled during the summer months, with Campaigns Northwest and Northeast and International Campaigns. These projects, sponsored annually by area congregations, will involve a total of nearly 200 students.

Groups venturing into the northeast and northwest portions of the U.S. will visit primarily with small congregations, helping the local Christians to circulate Bible literature and plan activities which will stimulate interest in the church. Workers in the Northwest will be guided by Obert Henderson, a former Harding faculty member, while those in the Northeast will be led by alumnus Owen Olbricht.

The international campaigners, numbering 62 in Europe alone, will be stationed in England, Scotland, Holland, Germany, Belgium, Switzerland and Italy, according to coordinator Don Shackelford of the Bible faculty. Some group leaders, former Harding students, are already in Vienna, preparing for

summer work with the Austrians and Russians. Twelve students will be involved in Australian campaigns.

Volunteers train throughout the school year for their trips abroad, beginning in the fall with weekly meetings which instruct the prospective campaigners in fund raising and provide practical information such as how, when and where to obtain necessary passports and documents for travel. Films and slides from previous trips are studied, and the need and opportunities for workers are impressed upon the students.

Once the groups are divided by destination, the junior missionaries begin to learn the language and the customs of the countries which they will visit. Each student learns to introduce himself, to invite guests to gospel meetings and to sing hymns in his host country's native tongue.

Singing will be the major tool for attracting interest as Cliff Ganus III leads 20 Chorale members in an evangelistic tour through England. The group will join all other European campaign teams in Amsterdam at the end of their trip, and the students will have a spontaneous worship and

devotional period and share their summer experiences before returning home together.

Harding's 37 CCP students will conduct both domestic and foreign campaigns this year, under the direction of Ed Sanders, director of the Christian Communications Program. During spring break, some of the students worked with congregations in DeQueen, Ark., Oak Grove, Mo. and Gretna, La. In May, groups will work in London and Wellingborough, England and in St. Croix, Virgin Islands.

Spanish teacher Ava Conley and her family will lead a group of Spanish-speaking students in an annual Venezuelan campaign, while other Hardingites join in the efforts of sister schools, such as Oklahoma Christian College's Brazilian campaigns and Abilene Christian University's work in Chile.

In addition to the Harding-organized campaigns, many students will be involved in independent outreach programs. Still others will return for the summer to mission fields which they call home, where they will work with their families and local congregations in spreading the gospel.

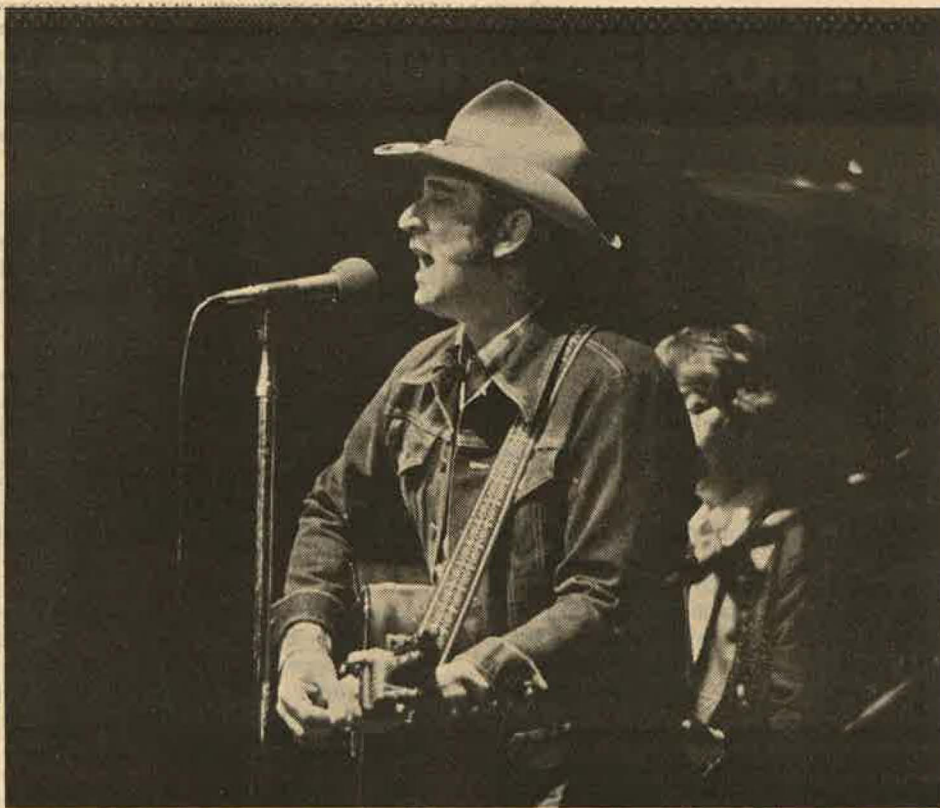

Nursing Student Speaks for Profession

Involvement may well be the key to strengthening and expanding the nursing profession, as indicated by Mary Copeland, a senior nursing major at Harding.

Miss Copeland, a member of the board of directors for the National Student Nurses' Association, recently returned from Washington, where she testified on behalf of the NSNA before the House Subcommittee on Energy and Environment. She joined practicing nurses who spoke for three other nursing organizations in supporting the Nurse Training Amendment of 1981.

According to Miss Copeland, the amendment would provide financial aid for nursing students and for nursing schools throughout the country. The first Nurse Training Act was passed in 1964, she said, and was renewed every three years until 1978. Congress has passed similar one-year resolutions subsequently, but the 1980 resolution will expire in June, leaving the program to face cutback or extinction.

Miss Copeland presented to the subcommittee a survey of her organization. Her statistics revealed that financial assistance was awarded to 58 percent of the national members, 85 percent of whom could not continue their education without that aid.

"We maintain that there is already a shortage of nurses," she stated. "To discontinue educational assistance would leave this nation with a severe nurse shortage."

After individual testimonies, the nursing panel fielded questions from subcommittee members. Miss Copeland was asked about the cost of a nursing

education. She cited tuition rates for both state and private schools and named additional expenses, including uniforms, homecare equipment (\$450-500 for a complete kit), transportation for homecare visits and clinical sessions and malpractice insurance. Nurses can expect to make \$13,000 during their first year in Arkansas, she added, while medical students may receive up to \$100,000 in educational grants and will earn \$50-60,000 in their first year of practice.

"The subcommittee was very encouraging as far as their support goes," she said, "but we'll really have to work with the Senate." She plans to appear before a Senate subcommittee in the near future and hopes to persuade them to be more generous in their allocations for nursing programs.

Political involvement is important to Miss Copeland and to her profession because, she said, "legislators are letting programs fall through simply because they aren't hearing support from their constituents."

In addition to legislation, she supports community health projects. "There is often an educational focus in our field," she said, pointing out that nursing organizations frequently sponsor workshops and seminars to educate the public. Miss Copeland also serves on an advisory board for a Nurse Planning Project sponsored by the Kellogg Foundation and supervised by the Arkansas Department of Health.

A transfer student from Freed-Hardeman College, the Atlanta native is a member of Harding's Nursing Honor Society. Last year she served as president of her nursing class and as president of the Arkansas State Nursing Students Association, an organization whose 10-member board includes three Harding students.

Recently, Miss Copeland has been featured in articles in the *Arkansas Gazette* and the *Arkansas Democrat* and has been named among National Dean's List honor students and among Outstanding Young Women of America.

Following her graduation in May, Miss Copeland will begin her nursing career in Nashville, Tenn. She plans continued involvement in legislative campaigns, organizational work and health education, all part of the movement to "upgrade the nursing profession, to make it more accepted among other professionals in the health care team."

Two Harding athletes, Tim Flatt and Hubie Smith, have been named to the 1980-81 Academic All-America Basketball-College Division fourth team, co-sponsored by the College Sports Information Directors of America (CoSIDA) and the National Collegiate Athletic Association.

Members of CoSIDA voted for the academic all-star team as 41 men qualified for the national ballot following preliminary competition in eight districts throughout the United States and the District of Columbia.

Flatt, a four-year Bison starter, completed his collegiate career with 1,448 points to rank fourth among Harding all-time scorers. A 6-1, 172 pounder, the business major carried a 3.06 grade point average.

A native of Memphis, Flatt has been selected to participate in the eighth annual All-Arkansas Classic at Arkadelphia, Ark., April 6.

A two-year starter, Smith, also a Memphis native, has recorded a 3.27 grade point average while majoring in physical education. In two seasons Smith has scored 690 points. During the 1980-81 season he established a single season assist record with 210. In addition, he has won All-Arkansas Intercollegiate honors in golf.

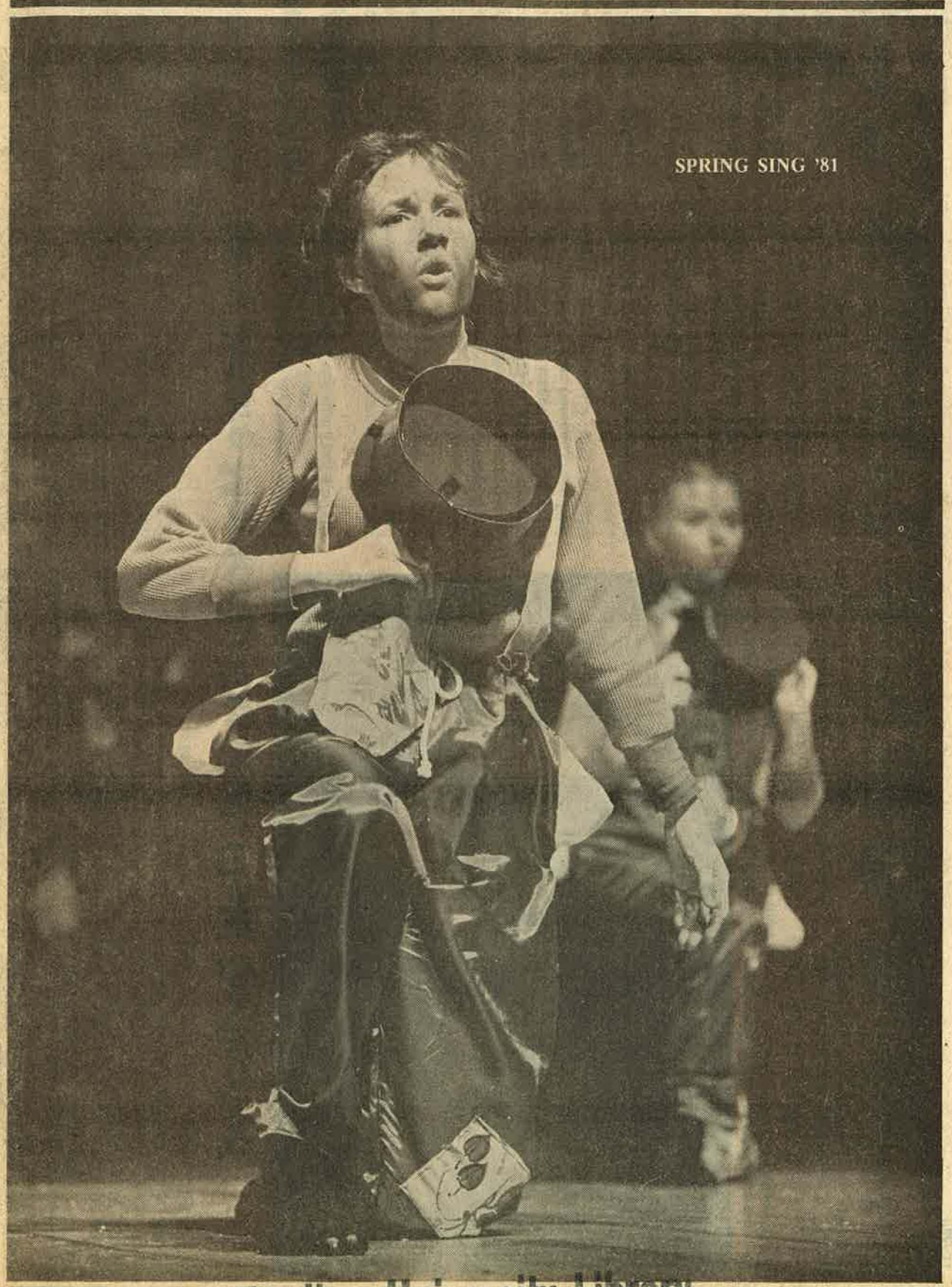
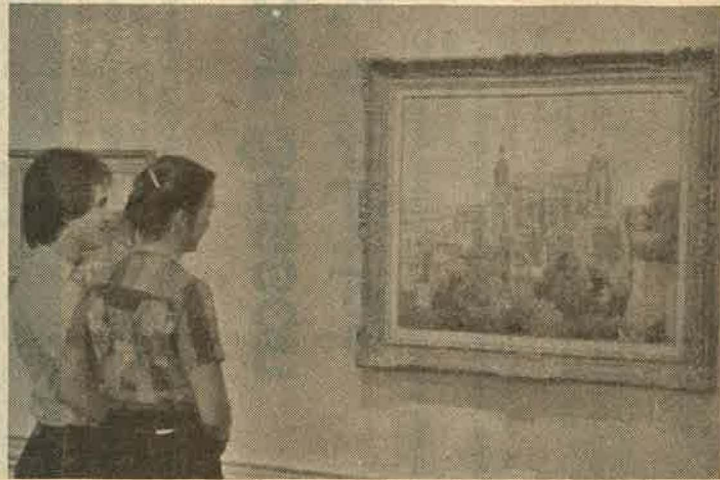
