Former President Ford To Close Lecture Series

Gerald R. Ford, 38th president of the United States, will close the American Studies Lecture Series when he appears at Harding April 23.

A native of Omaha, Neb., Ford grew up in Grand Rapids, Mich. and graduated from the University of Michigan. As a student, Ford was a member of the University's national championship football team, being named "most valuable player" in 1934. Following his graduation, Ford entered Yale University to pursue a law degree.

Ford received his LL.B. degree in 1941 and briefly practiced law before entering the Navy. He served four years, two aboard the U.S.S. Monterey aircraft carrier. He was discharged in 1946 and resumed his law practice.

Ford was elected to the U.S. House of Representatives in 1948 and served in the House for 25 years, holding various leadership positions, including Republican Conference chairman, Republican National Convention chairman and Minority Leader.

In 1963 he became a member of the President's Commission investigating the

assassination of President John F. Kennedy and two years later authored with John R. Stiles the book *Portrait of the Assassin*.

Ford became vice president in 1973, following the resignation of Spiro Agnew. He succeeded to the presidency upon Richard Nixon's resignation a year later. He served as president until January 1977.

In 1979, Ford published a book entitled *A Time to Heal*, which includes the story of his years as president.

Ford closes a season of the American Studies Lecture Series which has also included Casa Bonita President William Waugh and CBS correspondent Richard C. Hottelet.

The Lecture Series is an effort to supplement the curriculum of the university with educationally beneficial presentations by internationally known authorities.

Usually the lecturers spend two days on the campus and keynote at least one program for the more specialized American Studies group and another for an all-school chapel assembly. While on-campus, they are often asked and grant permission for in-

terviews by the local and college radio stations.

Dinner meetings, seminar sessions, question and answer periods, informal

receptions and class discussions round out the activities of the guests.

All Harding students participate in the American Studies Program in one form or another. To fulfill degree requirements, students must satisfactorily complete four courses in American history, economics, political science and European history.

A more extensive program is offered for history, political science, economics, business or social science majors.

The Lecture Series is designed to expose students and faculty of ideas, opinions and viewpoints which are basic to American citizenship.

Business Center Groundbreaking March 20

Official groundbreaking for the \$1.88 million Mabee Business Center has been set for March 20 at 4 p.m., according to President Clifton L. Ganus Jr.

The 34,700-square-foot building will be named in honor of J. E. Mabee, founder of the Mabee Foundation in Tulsa, Okla.

The building will house the School of Business, the Quintin Little Computer Center, the Clark David Belden Center for Private Enterprise Education and the Educational Media Center. It will be located at the corner of Center and Blakeney streets, east of the Benson Auditorium.

"We've looked forward to this for a long time," Ganus said. "We are especially glad that the efforts of many, many people are now coming to fruition. The facility will definitely enhance our overall academic program."

The Mabee Foundation has played a major role in the Harding campus development, dating back to 1964. In the construction of four buildings, the John Mabee American Heritage Center in 1965, the Mabee Library Addition in 1971, the Athletic-Physical Education Complex in 1976 and the Benson Auditorium in 1980, the Foundation was especially supportive.

The academic computer center will be named in honor of Quintin Little of Ardmore, Okla. His wife, Mrs. Carrie Lou Little, is a member of the University Board of Trustees.

Significant support was also received from the Stanley S. Kresge Foundation of Detroit, Mich. and the William H. and Kate F. Stockham Foundation, Inc. of Birmingham, Ala.

The Business Center will house eleven

classrooms. All are designed to allow color video viewing (either computer printout or video tape-cassette). Two large classroom areas feature a joint projection room for multi-media presentations. Two other classrooms are designed with a one-way glass mirror system for use in teaching group dynamics in management.

Additionally, it will contain 19 faculty offices and reception-work areas for the School of Business and the Center for Private Enterprise Education. The James Hedrick Memorial Conference Room will also be in the new building.

In the Little Computer Center, approximately 40 terminals will be available for student academic use.

Moore Baseball Field Dedication To Precede Doubleheader April 4

A pre-game ceremony will highlight the dedication of the Jerry Moore Baseball Field on the Harding campus April 4.

The new facility will be named in honor of Moore, a 1971 graduate who was killed in an airplane accident in Searcy Feb. 18, 1978. An All-Arkansas Intercollegiate Conference baseball player, he also served as a graduate assistant coach for the Bison team.

Ceremonies will begin at 1 p.m. and will precede a doubleheader between Harding and Ouachita Baptist University.

Special guests for the dedication will include his widow, Becky Ross Tubb of Sparta, Tenn. and members of his family,

Yearwood and Johnson Architects, Inc. of Nashville, Tenn. served as the designer for the building. Ellers, Fanning, Oakley, Chester and Rike, Inc. of Memphis, Tenn. are the design engineers of the project. It is expected the building will be completed during the fall semester, 1982.

Diffine, Private Enterprise Center Honored by Freedoms Foundation

The Freedoms Foundation of Valley Forge, Pa. has announced that two Valley Forge Honor Certificate Awards will be presented to Dr. Don Diffine, associate professor of economics, in May.

Both Honor Certificate Awards recognize the *Entrepreneur*, a nonprofit publication edited by Diffine and distributed quarterly by Harding's Clark David Belden Center for Private Enterprise Education, which is under Diffine's direction.

According to Freedoms Foundation President Robert W. Miller, the publication represents "an outstanding accomplishment in helping to achieve a better understanding of the American way of life."

Diffine will receive one Honor Certificate Award as editor of the *Entrepreneur*. He will accept the second award on behalf of the Belden Center. The awards will be bestowed during a special Private Enterprise Education awards ceremony on the Valley Forge campus May 7.

The awards nomination of the *Entrepreneur* was based on the 1979-80 issues of the publication. Features in those issues included "Let's Be Free to Choose," by Dr. Milton Friedman, "The Graduating Class of Harding University," by D. R. Belden, president of Louver Manufacturing Company, and "Small Businesses Make Free Enterprise Work," a congressional subcommittee testimony by Diffine.

National AWH Meeting Will be Hosted April 24

The National Council of Associated Women for Harding will host the 16th annual general meeting of AWH on the Searcy campus April 24. Both chapter members and at-large members are invited.

The full morning of events will include presentations by Jim Bill McInter of Nashville, Tenn., a member of the Board of Trustees, and Betty Woods, women's editor for the *Arkansas Democrat*.

Mrs. Al Jolly of Cabot and Mrs. Ann Hewett and Miss Brenda McClain of Little Rock are coordinating the activities. The event will be directed by Mrs. Richard Burt of Dallas, national president of the AWH council.

Invitations have been issued to the 1,500 AWH members across the nation. A recent membership drive has enlisted a substantial number of enrollees in the support group for the University, boosting the total membership to the largest point since the group was organized in 1965.

The meeting will open in the Heritage Room of the American Heritage Building with registration and coffee. The ladies will join the student body for chapel in the Benson Auditorium at 9 a.m.

Mrs. Burt will preside at the business session, which is scheduled from 9:45 to 1 p.m. During the meeting, chapter reports will be made and entertainment will be

provided by the Northeast Arkansas AWH chapter and Randy Burrus of Little Rock, a Harding alumnus and professional entertainer.

A dutch-treat luncheon will be held in the American Heritage Cafeteria following the session.

Dr. Jimmy Carr, who coordinates the work of AWH members with the University, has encouraged members to attend the meeting. "The annual meeting provides an excellent opportunity for members to share their experiences and even their problems and be strengthened and encouraged in planning for the future," Carr said. "We hope many ladies, whether affiliated with a chapter or not, will take advantage of this opportunity to be with others who are interested in the work of Harding University."

Dedication, Open House Draw 500 to Academy

An over-capacity crowd of students, faculty, parents and local supporters gathered at Harding Academy for dedication ceremonies and open house at the new \$1.25 million facility March 1.

The platform party comprised several Harding officials and community leaders, including Ed Higginbotham, superintendent of the Academy; Bill Diles, prin-

cipal of the high school; Tony Finley, principal of the elementary and Bret Shirley, president of the Student Council. Brief remarks were made by Clifton Ganus Jr., president of the University and Lott Tucker, vice president for finance. Special guests included James Cone of Little Rock, a member of the Board of Trustees; Wayne Hartsfield of Searcy, chairman of the State Board of Education and Dwane Treat, president of the Searcy Chamber of Commerce.

State Representative John Paul Capps presented to the Academy an Arkansas flag which had flown over the state Capitol. Also included in the program was a performance by the Academy chorus, directed by Craig Jones.

More than 500 guests celebrated the formal opening of the building, which has been in use since the beginning of the spring semester Jan. 5. Visitors toured the site and examined the classrooms, finding several improvements over the former facilities.

The 47,000-square-foot building contains 20 classrooms and administrative offices. Students have access to a modern science laboratory, a dark room, an art room and a home economics workroom equipped with major homemaking appliances for three complete kitchens, in addition to the gymnasium, auditorium and library.

Students Form Arkansas' First AMA-Backed Management Club

A chapter of the Society for the Advancement of Management has been formed on the Harding campus. It is the first Arkansas chapter to be recognized by the national organization, which is sponsored by the American Management Association.

More than 75 interested students attended the initial organizational meeting of the chapter Feb. 16. Under the supervision of student co-chairmen Byron Westbrook of Centralia, Ill. and Paul Parten of Houston, a proposed club constitution received the 25 signatures required to make the group an official campus organization.

During a March 2 meeting, Phil Davis, personnel manager of Owatonna Tool Company, spoke to the group about current problems in personnel management. Prospective club members made plans for the semester and elected club officers.

Future activities of the society will include panel debates, organizational drives, case studies, film viewings and guest speakers.

Mother of Eight Finally Finds Time for a Hobby

She'd be the last to admit it, but 78-year-old Bonnie Kee is unquestionably among Searcy's most remarkable citizens. The latest to surface in her long list of achievements is her artistic ability.

A collection of oil paintings by Mrs. Kee was recently displayed in the Stevens Art Gallery. The 30 pictures exhibited were selected from among the 50 she has finished since first trying her hand at the easel in 1968, after her daughter Marie gave her some paints for Christmas.

This was the first public showing for a collection of her works, though her pieces have claimed ribbons three times at the White County Fair, which she entered at the insisting of family and friends.

"I've always wanted to draw," Mrs. Kee said, "but I had to work so hard all my life I never had time." After her eight children were grown and away from home, and after she'd taken French lessons and gone to Europe and many parts of the United States on evangelistic campaigns, at last she found opportunity.

"Now when I paint I forget the world is turning," she beams in telling of her new-found talent. And once she begins, she doesn't stop until the picture is complete, even if it runs into the night.

Her studio consists of a card table placed in front of the fireplace, a wooden stool pulled up to hold her paint box and a small easel. Lids from tin cans serve as her palette and she has slowly collected a substantial array of brushes.

Ideas for her art come from photographs or from memory of particular scenes she has enjoyed, such as the view from her kitchen window on the western edge of Searcy.

All of her works are claimed by her family, with one exception. Georgia James, a long time close friend, has one — a scene from the James home on Valley View Drive.

The artist is a native West Texan, reared on a farm. Formal schooling ended for her in the eighth grade, a level her father considered sufficient. But she took classes at home, completed high school requirements, passed the teaching exams and taught school.

Marriage produced five sons and three daughters in 21 years. "We talked nothing but college to the children, but we told them we'd rather they make B's and C's than to sacrifice learning how to work." The teaching was a success. All

graduated from Harding, and most have advanced degrees as well. Sons James and Norman are business men; Windle and Doyle are missionaries. One, Wayne, is deceased.

Her three daughters are unmarried. Jeannette and Marie are teachers; Barbara Ann is a librarian. All are committed Christians.

The entire family is closely tied with Harding. For 28 consecutive years there has been at least one Kee enrolled. Currently there are two — Larry, son of James, and Mark, son of Doyle.

Mrs. Kee brought her family to Searcy in 1958 and she went to work in a cafeteria. She labored hard, sometimes ironing 10 hours a day to keep the family

going. "When I look back at it now, I don't see how we made it," she laughs.

With her children all grown and educated, one might think she'd opt for a rocking chair. But not Mrs. Kee. She enrolled in French classes at Harding, raised travel funds and joined evangelistic campaign groups in door knocking efforts.

Next she took on typing. She has worked with mission groups as recently as November, when she joined a group from White's Ferry Road Church of Christ to Edmond, Okla. She's making plans for more activities.

Meanwhile, she continues working on the one-acre tract at her home. She studies the Bible daily, gardens, cans and freezes, grows flowers, thinks about pictures she wants to paint, and continues to study French every day.

She is almost totally responsible — at least initially — for the Golden Years Group, a facet of the West Side Church of Christ. At her urging, the program for persons over 60 started meeting a year ago. She eagerly waits for Tuesdays to join the 40-50 others for games, singing, Bible study, lunch, an occasional field trip, a movie or other enjoyable pastime with her friends.

On March 1 a reception at the art gallery honored Mrs. Kee. She was present to show her works.

Her exhibit closed March 6. And now, perhaps, she'll rest? "Not on your life," she replies. She'll keep busy exploring new fields. She has advised young parents that "children should be taught to want to work. By working on, day by day, keeping on, they can accomplish something."

Surely, she's inspirational proof of her belief.

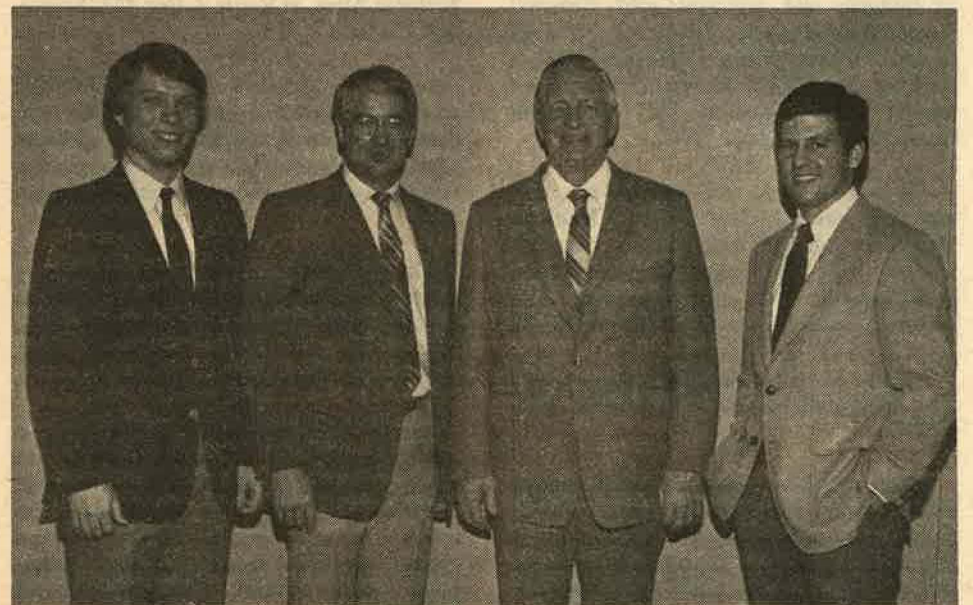

Martial Arts Complement Nursing Skills

Betty Griffith, a 4-11 senior nursing major, looks harmless. But she isn't defenseless; she has black belts in both karate and judo.

"I began studying karate in Hawaii at the age of eight," Griffith said. "My father really encouraged me in it. My whole family is martial arts oriented. My older brother has his black belt in karate, and he's working on his red belt — the master's degree. My sisters have brown belts in judo, and my younger brother has studied karate for two years. It's really a family thing."

Karate is divided into three degrees, signified by three black belts. An instructor, or master, of karate wears the red belt.

The art of karate requires physical strength and involves the use of both the hands and the feet. Karate is a sport of "jabbing and blocking."

Judo mastery is measured in six degrees. There are white, orange, yellow, green, brown and black belts. Movements in judo use the whole body and require less strength from the fighter.

"I practice Jujitsu, which is the simplest form of judo," Griffith said. "It is mainly an art which uses body mechanics and leverage. I like it better than karate; my size gives me an advantage in it."

Griffith was awarded her second black belt in karate and her black belt in judo when she was in junior college. Although she no longer takes lessons, she continues to practice her exercises and falls for judo and her kicks and jabs for karate.

She has never had to use her skills for her own defense, but she did help her brother out of a scuffle once. Griffith

uses her talents in other circumstances. "I have found the use of body mechanics and leverage very helpful in lifting patients," she explained.

Because she has confidence in her ability to defend herself, Griffith has few of the fears that many women face. But she feels very firmly that the martial arts are not "fun and games. It should be used only for self defense — it's not something to play around with. It's a discipline, and you have to learn not to

show it off."

Although Griffith has found interest in karate and judo to be more widespread in California, her home state, it is growing in popularity. There is a school in Searcy which offers martial arts courses to aspiring young students. She has not been connected with the school here, but she "would recommend it (martial arts defense) to anyone of any age. Once you have it, no one can take it away from you."

Post season honors and new records highlighted Harding's 1980-81 basketball season as the Bisons advanced to the National Association of Intercollegiate Athletics District 17 playoffs.

Finishing with a 13-17 record overall, the Bisons earned a berth in the district playoffs with a tie for fifth place in the Arkansas Intercollegiate Conference. They fell to Arkansas College in the playoffs.

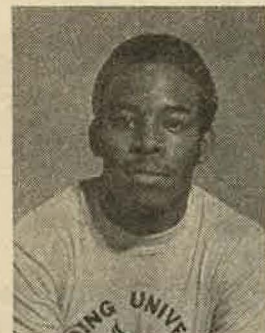

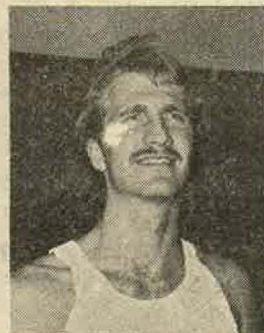

Three all-conference players from last year's Arkansas Intercollegiate Conference champions will provide Coach Phil Watkins a solid base for the 1981 campaign.

Brent Taylor of Tulsa, Okla., a two-time All-AIC selection, and first time honorees Hubie Smith of Memphis and David Padgett of North Little Rock will again make the Bisons legitimate contenders.

Junior Randy Wooten of Turlock, Calif., will team with sophomores John Hendricks

of Shreveport, La. and Jeff Jones of Memphis to fight for a spot in the top five. First year golfers are Scott Fryer of North Little Rock and Alan Patton of Houston, Texas.

TRACK

A highly successful indoor season and 19 lettermen bring about an optimistic outlook for Harding track coach Ted Lloyd.

Expected to lead the way outdoors are All-AIC, defending champion John Sills in the 5000 meter run and two indoor NAIA All-Americans, hurdler Dwayne Allen of Harrisburg, Pa. and distance man Carter Lambert of Pearl, Miss.

Also returning after a 1980 season interrupted by injury is Bison pole vault record holder Mike Lynch (16-9) of Bivins, Texas.

In addition to Sills, Lambert and Lynch, other returning senior lettermen are Stan Burnette of Athens, Ga., triple jumper Kevin Granberg of Tacoma, Wash., miler Randy Jackson of Springdale, Ark., 5,000 meter runners John McAlister of Temple Hills, Md. and Richard Teixeira of Auburn, Ind.

The Bisons placed fourth in the conference last year. The AIC Track and Field Championships will be in Arkadelphia April 30 and May 2.

Records Shattered, Swimmers Rank Second In AIC

In an outstanding team performance, the Harding University Water Buffaloes rewrote ten school records and finished second in the Arkansas Intercollegiate Conference Swimming Championships at Conway Feb. 21.

With sophomore Rick Krug setting the pace with a victory in the 200-yard butterfly event, Harding collected 286 points to finish behind champion Hendrix College.

"We accomplished what we were shooting for," said coach Jack Boustead. "We knew Hendrix was heavy with seniors but our kids did an outstanding job. They really competed."

Krug had a hand in six of the new records and teammate Richard Denny was close at hand with participation in four school records. In all, eight individual records and two relay marks were set in the meet.

A native of Anaheim, Calif., Krug took the Bisons' only first place in the meet with a record 2:07.19 in the 200-yard butterfly to erase his own record of 2:13.19 set in January.

He then added school records in the 1000-yard freestyle (10:57.5), the 1650-yd. freestyle, (18:21.24), 500-yard freestyle in 5:13.82, 100-yard butterfly (58.64) and in the 400-yard medley.

Denny, only a freshman, from Rock Island, Ill., displayed great speed and effort in the sprints. Topmost among his efforts was the second place 22.89 in the 50-yard sprints, missing first place by only .17 seconds. In the 100-yard backstroke he clocked 1:02.24 in the finals to rewrite the two-year old record of 1:03.28 set by former Bison Steve North.

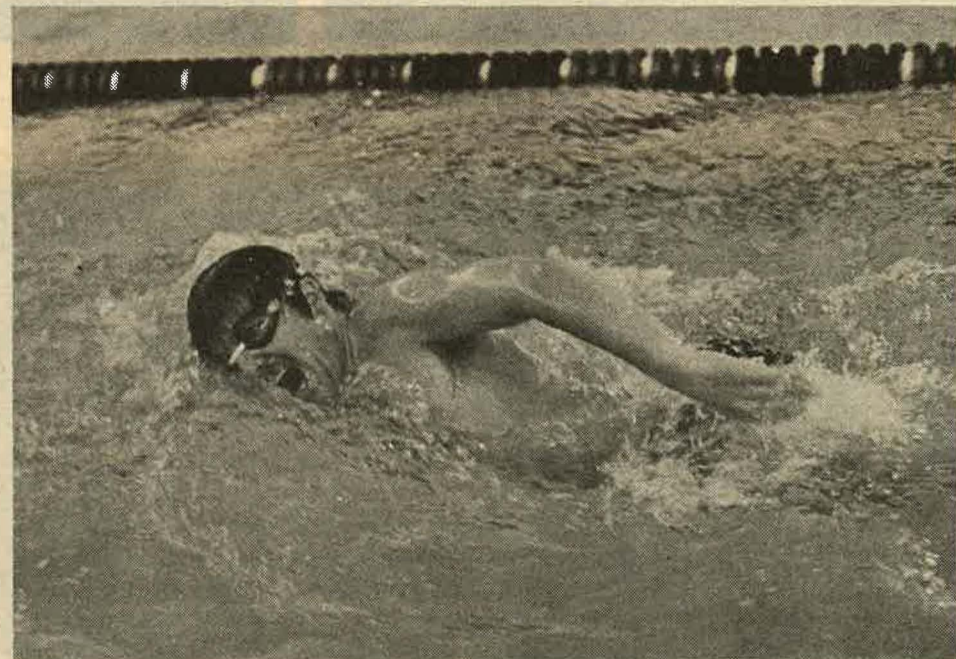
Denny and Krug each contributed a leg on the record finish of the 400-yard medley. Teaming with Steven Froehlich of Syracuse, N.Y. and Ben Waites of Atlanta, Ga., the foursome placed second in the AIC event in 3:59.69. The previous record was 4:04.9 set in 1975.

Denny came back to join with Waites, Andrew Batie of Shreveport, La., and Tom Strother and post a time of 3:30.88, good for third place. The old school record was 3:34.78 set in 1978.

The tenth school mark belongs to diver

Jim Davenport of Walden, N.Y. Competing in the three-meter event, he put together 312 points on 11 dives to rewrite his own record of 303.45.

For the meet Krug finished as the Bisons' high point man with 60.5 points. Denny was second with 48.5 points and Waites, the sophomore co-captain, had 41.5.

Bison Earn All-America Honors, Allen Wins National Hurdle Title

Two Harding tracksters, Dwayne Allen and Carter Lambert, earned All-America honors in the 16th annual National Association of Intercollegiate Athletics Indoor Track and Field Championships Feb. 19-21 in Kansas City, Mo.

Allen reigns are the national champion in the 60-yard high hurdles, with a 7.46 clocking in the meet finals. A freshman from Harrisburg, Pa., Allen is the third Bison athlete to earn a national indoor track event championship.

In earlier competition, Allen was clocked in 7.37 twice, in the prelims at the Magnolia State Indoor Classic at Jackson, Miss., Jan.

17 and at the prestigious Track and Field Association-USA Meet in Kansas City Jan. 24.

Lambert, a senior from Pearl, Miss., placed sixth in the two-mile event in 9:22.8. In the Mason-Dixon Games Feb. 6 he set a school record with a 8:40.2 time in the 3,000 meter run.

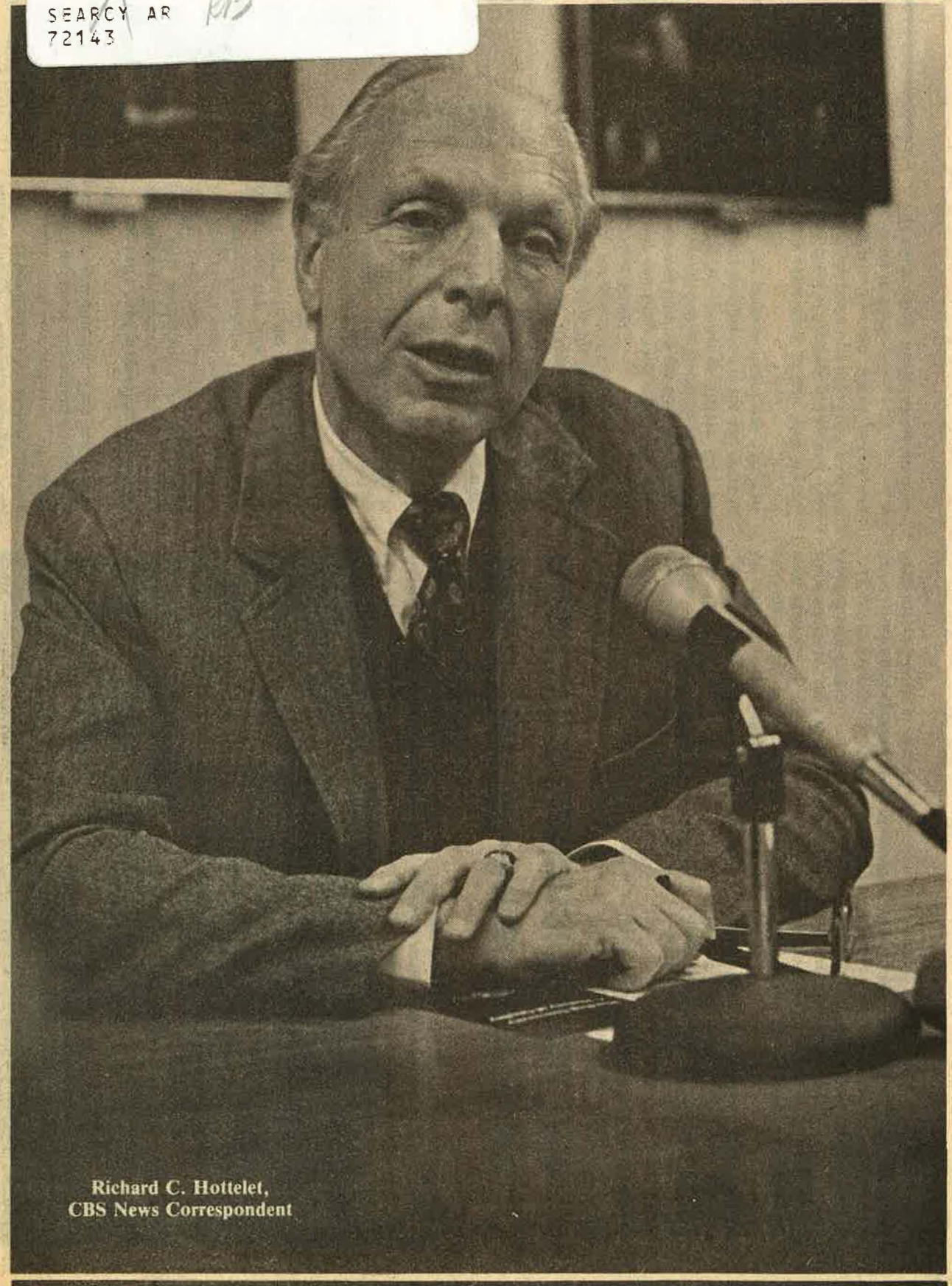
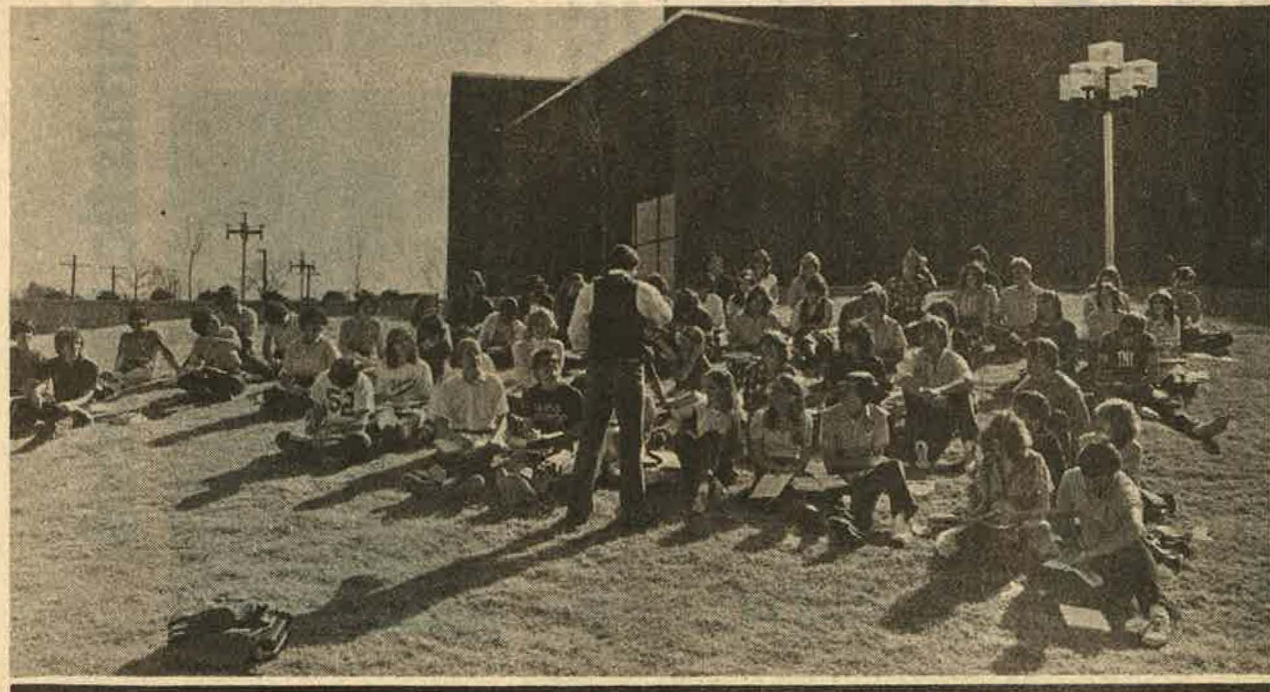
