Searcy Area Fund Drive Exceeds \$800,000 In Pledges

Exceeding the \$750,000 campaign goal, more than \$800,000 has been pledged in the Searcy-White County Fund Drive, according to Lott Tucker, vice president for finance and campaign chairman.

The victory announcement was made at a Report Luncheon which was attended by the campaign volunteers.

"The strength and support of our home community is tremendous," President Clifton L. Ganus said. "We want to express our thanks and appreciation to each volunteer who had a part in this fund raising effort."

The advancement effort was launched Nov. 29, 1984, and is a part of a \$13.1 million effort by the University. The five-year program is to provide operational supplementation and endowment funds for the school.

Tucker indicated the Searcy-White County Fund Drive was the most successful ever conducted. In 1979 a five-year program raised \$550,000. "The receptiveness and response of the business community was impressive in every aspect," he said.

"For schools such as Harding, the strong support of your home community is ex-

tremely important," Tucker said. "It has a multiplying effect when working with other potential donors."

The final figure for the fund drive has not been set because contact with some area firms with national offices is still in progress. A final tabulation will be announced when all pledges have been finalized.

More than 80 community and business leaders participated in the campaign work, Tucker said. "The success of this kind of effort depends on the quality of your volunteers and we feel we had the very best working with us."

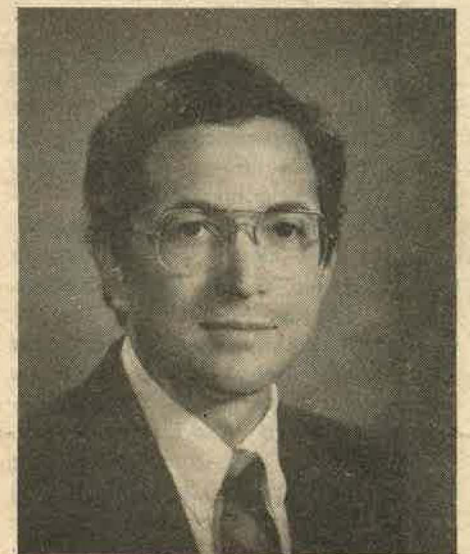
High School Day Set for October 12

Harding's annual fall High School Day is scheduled for Oct. 12 and will feature as its main speaker Mike Cope, evangelist for the College Church of Christ in Searcy.

At 29-years-old, Cope identifies well with young people and presents interesting and challenging lessons to his listeners. A 1978 graduate of Harding University, Cope received his M.Th. degree in 1982 from the Harding Graduate School of Religion in Memphis, Tenn.

For two and a half years he preached for the Pine Valley church in Wilmington, N.C. In October 1984 he began his work as pulpit minister for the College church in Searcy.

He and his wife, Diane, have two

High School Day is a special day set aside for high school students to visit the Harding campus and enjoy special activities planned just for them. The day's events include musical entertainment, inspirational devotionals and speakers and periods of informative discussion about Harding.

This year's High School Day will begin with a devotional, which will be followed by the newest Harding University slide show. A musical show will be presented just before

Profile Finalized for Presidential Candidates

Completing three months of discussions, the Presidential Search Committee of the Harding University Board of Trustees has developed a profile of qualifications for the successor of President Clifton L. Ganus, who will retire in May, 1987.

The announcement was made by James H. Cone of Little Rock, chairman of the Harding Board of Trustees and the Presidential Search Committee.

"Due to the self-initiated desire of Dr. Ganus for retirement from the presidential office, our thoughts of qualification are to virtually describe the man we already have," Cone said. "We feel a great loss that we will no longer have Dr. Ganus at the helm."

The profile developed by the Search Committee establishes characteristics of the ideal candidate for the position, Cone said. As approved by the seven-member committee, the ideal candidate should be someone who:

- * Is loyal to the scriptures, doctrinally sound, evangelical in nature and an experienced leader in the Church of Christ, morally above reproach and possesses unquestioned integrity;

- * Is committed to Christian education, academically qualified, willing to accept the task of hard work, and a strong supporter of the free enterprise system, loving this nation and all its people;

- * Has good business judgement, demonstrated managerial ability and administrative experience;

- * Can articulate the principles and purposes of Harding, generate support for its work and lead a growing student body to

develop in all the ideals of Christian achievement;

- * Is capable of developing financial support for the program of the University.

"We realize the challenge that we have before us," Cone said, "and that our profile represents a cross section of the ideal candidate. We have not conducted any interviews and we want to officially open the process of obtaining resumes. By this fall it is our purpose to begin private interviews with candidates and have a progress report for the November 1 Board meeting."

Academic Accreditation Complete

Continued accreditation by the North Central Association of Colleges and Schools has been given to Harding University.

Vice President for Academic Affairs Neale Pryor announced the 10-year approval upon receipt of notification from Thurston E. Manning, director of the Commission on Institution of Higher Education in Chicago, Ill.

"We had no serious question about Harding's accreditation being continued," Pryor said, "but we are happy to receive the official word and know that we have received the maximum approval from the commission."

The recognition by North Central culminates nearly two years of self-study and evaluation by the Harding faculty as

President Ganus congratulated the committee for its work. "I fully appreciate the major matter confronting the Board. They have the fullness of my cooperation in this task. We all serve together to a common end — to make Harding University the greatest Christian school it can possibly be. To this end I've devoted the greater part of my life and will continue to work toward this ideal."

well as on-site visits by a five member committee appointed by NCA.

Pryor indicated the study report was complimentary of the University in a number of areas. The study commended the morale and spirit of cooperation among the faculty, the neatness of the campus and facilities, the development of the Harding University in Florence, Italy, program and the University's work in student retention.

Other strengths mentioned were the support of the Board of Trustees and the commitment of all segments to the stated mission of the school.

Harding became an accredited member of the North Central Association in 1954 and has undergone periodic evaluations to continue its accreditation.

Risinger Added to Board

Harry B. Risinger Jr., an executive of the W.R. Grace & Co. and a 1968 alumnus, has been elected to the Harding University Board of Trustees.

Risinger, vice president of finance for the agri-chemical group of W.R. Grace & Co. in

Memphis, Tenn., is the 20th member of the Board.

"We are delighted that Harry Risinger has been added to the Board of Trustees," President Clifton L. Ganus said. "He has served well on the Development Council and has the dedication, capability and interest that should make him a very capable and effective member of the Board."

The 39-year-old Risinger has served as a member of the President's Development Council since 1974 and as chairman of the Endowment Investment Advisory Committee of the Council. As a member of the Board he has been appointed to the committee for finance and investment, academic affairs, the Harding Graduate School of Religion and development.

A native of El Dorado, Ark., Risinger served in the U.S. Army, earned the MBA degree from Memphis State University and is a certified public accountant (CPA). He is married to the former Janice Robinson of Paris, Tenn., and the couple has two sons, Matthew and Adam.

The new board member is a deacon at the Church of Christ in Millington, Tenn.

Belden Professor Appointed

George Oliver of Detroit, Mich., has been named the first Del Belden Visiting Professor of Sales for the Harding University School of Business.

The appointment will be effective for the fall term, according to Dr. David Burks, dean of the School of Business.

The visiting professorship is funded by Del Belden, past president and chairman of the board of Lomanco, Inc., of Jacksonville, Ark. Belden is also funding a five-year program for marketing majors with a special interest in the sales area.

Oliver has more than 30 years of business experience including nine years as a sales executive with General Motors. He was associated with Griffin Floors and is now the civilian Chief of Personnel with the U.S. Army Tank-Automotive Command in Detroit.

"Harding is extremely fortunate to secure the services of a man with the broad background of Mr. Oliver," Burks said. "His practical experience and training will be important pluses for our students as they plan to go into the marketplace."

Burks indicated a full program emphasizing the sales area is planned through the sponsorship of the Belden funding. Specific activities will include the installation of a teleconferencing system in the J.E. and L.E. Mabee Business Center, a sales seminar in the fall and the establishment of the Belden Video Library in Sales. Additionally, an annual recognition, the Belden Outstanding Sales-Marketing Student Award, will be presented to the

student majoring in marketing with an interest in sales.

The establishment of the Visiting Professorship in Sales continues the involvement of Belden in the Harding Program. He previously had provided support for the Del Belden Center for Private Enterprise which was established in 1976 as part of the School of Business.

"Mr. Belden's willingness to combine the efforts of the business and educational sectors in the training of our students has been very important to the growth of our program," Burks said. "In this instance, especially so, since sales is ultimately the leading edge of profitability of every company in this country."

UPLIFT Program Successful

Eight young people were baptized and 60 others responded, asking for prayers, during the inaugural session of "Uplift," a summer Bible camp on the Harding University campus.

More than 200 full-time campers from about 10 states took part in the intensive Christian camp, June 23-28. About 300 additional young people and adults from the Searcy area participated in various activities of the camp, bringing the average attendance at evening sessions to more than 500.

Allen Isom, professor of Bible at Harding and director of the camp, is pleased with the results of the first Uplift session. "Some very fine young people came and studied at the feet of some very spiritually-minded youth workers," Isom said. "The title of our

program — Uplift — was seen in the activities all week. We were able to give (the campers) continual uplifting experiences."

Isom stated the attendance for Uplift was about what could be expected for the first year. He expects the number of campers to grow considerably next year after more hear about the camp as word spreads. Next year's camp will be June 22-27.

Comments from youth directors and campers were overwhelmingly favorable of this year's program. One note received by Isom stated, "It is a great program. The affect it had on the kids was tremendous."

Isom attributed the camp's effectiveness to the unique aspects of the camp. "We have the right facilities available here at Harding and we can get the right staff here to get the job done," Isom said.

Bible Lectureship, 'Jesus Calls Us,' Promises Challenging Sessions

Harding's 62nd annual Bible Lectureship, Oct. 6-9, is designed to appeal to the entire family by featuring three sub-themes of the main theme, "Jesus Calls Us."

"The Bible Lectureship has been an effective study situation for preachers, elders and Christians of every profession for 62 years," said Eddie Cloer, lectureship director.

"This year," Cloer continued, "the lectureship should appeal to an even broader range of Christians, including young people. And this is being done without diminishing the traditional quality or depth of the lecture series."

"Jesus Calls Us Out Of The World" will be the sub-theme for Monday, Oct. 7. The lectures and classes for the day will be encouraging for persons of any age who are striving to live the Christian life in today's secular world.

The keynote address that night will be delivered by Jeff Walling of El Toro, Calif. and is titled "Jesus Calls Us Out Of The World."

"Walling's superb ability to communicate with young people and the timeliness of his message makes it appropriate that Monday evening is being designated as 'Youth Night,'" Cloer said. "We want as many young people as can to come especially Monday night."

Theme lectures for Monday are titled "The Call Of The World," "The Danger Of Materialism," "What Is Worldliness,"

"The Essence Of Spirituality" and "Victory Over The World."

Tuesday's lectures and classes will have special appeal to those who have an interest in the concepts of Christian unity and the restoration of the church. The day's sub-theme will be "Jesus Calls Us To Unity."

The keynote address that night, under the title of "Jesus Calls Us To Unity," will be delivered by Ronnie White of Oklahoma City. Theme lectures in the day are titled "The Evils Of Division," "Pursue Peace," "Faith And Opinion," "Hindrances To Unity" and "How To Have Biblical Unity."

The "great commission" and world evangelism will be the focal points of Wednesday's program with the sub-theme "Jesus Calls Us To World Evangelism." Under the same title the keynote address will be delivered that night by Cline Paden of Lubbock, Texas.

Theme lectures for the day are titled "The Great Commission Analyzed," "What The World Really Needs," "Hindrances To Evangelism," "Mass Media Evangelism," and "Youth And The Great Commission."

The lectureship opens Sunday night, Oct. 6, with congregational singing in the Benson Auditorium at 7:00. Following at 7:30 will be a worship service in which Willard Collins of Nashville, Tenn. will deliver the opening theme address, "Jesus Calls Us."

Belize Official Keynotes American Studies Fall Lectures

Prime Minister of Belize, Manuel Esquivel will highlight the fall American Studies Lecture Series at Harding University. Other speakers will include Lyn Nofziger, former press secretary to Ronald Reagan and assistant to the president for political affairs, Dr. Kenneth Cooper, aerobics and fitness expert and Herbert Kelleher, chief executive officer of Southwest Airlines Company.

Nofziger will open the series on Sept. 24, Cooper will speak Oct. 15, Esquivel will follow on Oct. 28 and Kelleher will close the fall lectures on Nov. 11. "With the varied backgrounds of these speakers, this will be a well-rounded, informative series," said Dr. David Burks, director of the American Studies Program. "We believe the presentations will be very interesting and authoritative."

Nofziger has been a partner of Nofziger and Bragg Communications, a consulting and government relations firm since 1982. Formerly, he has served as senior consultant to the Reagan-Bush '84 Campaign and Inaugural Committee, assistant to the president for political affairs at the White House and press secretary to Ronald Reagan.

He worked on the Reagan for President and Ford-Dole campaigns. He served as director of communication when Reagan was governor of California. He is a member of the National Press Club, Citizens for the Republic and Committee on the Present Danger.

Cooper is recognized through his writing and research as the leader of the international physical fitness movement and has been credited with getting more people to exercise in pursuit of good health than any other. He has advocated revolutionizing the field of medicine away from disease treatment to disease prevention through aerobic exercise.

He is a member of the American Medical Association, Texas Medical Association, Dallas County Medical Society, American Federation for Clinical Research, Texas Governor's Commission on Physical Fitness and is a member and medical consultant of the Association for Fitness in Business.

Cooper is a fellow of the American College of Sports Medicine, American College of Preventive Medicine and American Geriatrics Society.

Esquivel was named Prime Minister of Belize by parliamentary election in December of 1984. Previously, he had been a member of the Belize City Council and a member and leader of Opposition Business in the Senate.

He was a founding member of the United Democratic Party and has served as party chairman and party leader. Esquivel was also an instructor in physics and mathematics at St. John's Junior College in Belize.

Kelleher was a founder of Southwest Airlines Company and has served as secretary, interim president, president, chairman of the Board and chief executive officer. He is a founder, director and

shareholder of Oppenheimer, Rosenberg, Kelleher and Wheatley, Inc.

He has been active with the University of Texas College of Business Administration; May Petroleum Company; MCorp; Texas Transportation Institute; Texas A & M University System; Communities in Schools Advisory Council; Dallas Citizens Council; Better Business Bureau of Metropolitan Dallas; McDonald Observatory and Department of Astronomy Board, McDonald Observatory at Mount Locke at the University of Texas in Austin;

Board of Trustees of St. Mary's Hall; American Bar Association; State Bar of Texas; San Antonio Bar Association; Texas Bar Foundation; Who's Who in the World, Who's Who in America and Who's Who in Law.

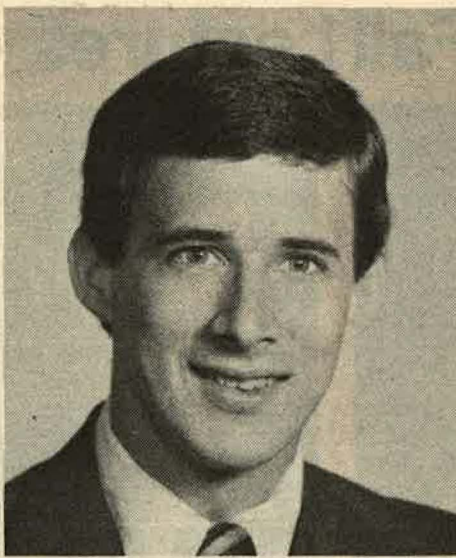

Tucker to Coordinate Walton Scholarships

David Tucker, assistant professor of economics, has been named coordinator of the Walton Scholarship Program for Central American Students, according to Dr. Clifton L. Ganus Jr., Harding University president.

Tucker will work directly with approximately 20 Central American students who will begin classes this fall under the scholarship program established with a \$1.2 million grant from Sam Walton, founder and chairman of Wal-Mart Stores, Inc. The grant, which will provide scholarships to disadvantaged Central American students over the next five to eight years, is to be matched by the United States Agency for International Development (AID).

Recently returned to campus from a two-year leave of absence to work towards a doctor's degree in economics, Tucker has assumed the position he held from 1980 to 1983. He is a Certified Public Accountant and holds the master's of arts degree in economics from Georgetown University. He is a 1977 graduate of Harding with a bachelor's of science degree in economics and accounting.

He has been active in the American Institute of Certified Public Accountants, Arkansas Society of Certified Public Accountants, Kiwanis Club and has served as an advisor to the *Bison* newspaper.

He is married to the former Renee East and the couple has one child.

Under the Walton Scholarship Program, scholarship recipients will pursue their choice of majors from the 68 offered by Harding. It is anticipated that many will be involved in business, economics and computer systems.

Walton and his wife, Helen, announced the scholarship program at a news conference in Little Rock, May 20. The Waltons stated then that the purpose of the program is to expose students from Central America to the benefits of a society and an economy which flourish under a free, open, elected government.

"I am convinced," Walton said, "that the only way these extremely poor (Central American) countries can make substantial improvements in the lives of their people is by having democratically elected governments which strongly support freedoms and reward individual initiative."

The concept of the program began, Walton said, when he and his wife met Gabriel Lewis, the Panamanian Ambassador to the United States, and had an opportunity to visit Panama. He eventually got the idea to offer a scholarship program for the country's students.

Sewell Concludes 38-Year Harding Career

A retirement dinner honoring Dr. Edward G. Sewell for almost 38 years association with Harding was held July 1 in the American Heritage. Among the guests were his children, Mary Ann Sniff of Irvin, Calif.; Dr. Granville Sewell of El Paso, Tex.; and Kirk and Claudia Sewell of Springfield, Ill.

Dr. Sewell came to Searcy in 1947 to teach at Harding Academy and began teaching in the college part-time the next year and about 1952 began full-time in the Education Department. His wife, Ann, still teaches in the Music Department of the University.

Sewell established the Florence Cathcart chapter of what is now the Student NEA. For several years the chapter was the largest in the state and several students were elected president of the state organization and two went on to hold national offices. He also was instrumental in the establishment of a chapter of Kappa Delta Pi, national honor society in education. As a member of the Department of Audio-Visual Instruction he initiated a campus study that led to the development of the Educational Media Center.

Dr. Sewell received a Distinguished Teacher award two years. While serving as chairman of the Education Department he worked with Dr. Mildred Bell of the Home Economics Department to develop a program to certify teachers of kindergarten and certification of special education teachers was instituted during his tenure. He served a time as director of graduate studies and briefly as chairman of the combined departments of education and psychology. He served on many faculty committees including Student Affairs, Executive Committee, Admissions, and Graduate Committees.

Among his professional activities was participation at three levels in the National Council for Accreditation of Teacher Education. He was a member of NCATE visiting teams to colleges and universities in Alabama, Kansas, Oklahoma, Nebraska and Texas. He was team chairman of teams visiting in Texas and North Carolina and was appointed to a four year term on the NCATE Evaluation Board and met in Minneapolis, Chicago, Cincinnati, Dallas and Memphis. He served one term on the national Teacher Education Committee of the Department of Audio-Visual Instruction.

May Ceremonies Graduate 336

Harding University graduated 336 students in May commencement ceremonies at the Benson Auditorium.

Keynoting the event was speaker Roy Orr, chairman of the board, First National Bank, DeSoto, Texas. He challenged the students to take a few minutes to look at the past and put the future into proper perspective. He emphasized five main points: 1. In everything you do be a servant; 2. Dream big dreams; 3. Use your training; 4. Beware of cultural impressions on the church; 5. Take leadership positions.

The distinguished teacher award recipients were Rod Brewer, associate professor of English; Wilt Martin, professor of health, physical education, and recreation and Dean Priest, dean of the College of Arts and Sciences.

"These students will benefit greatly from this program in that they will already have experience with a leading accounting firm when they graduate, and they will have an opportunity to practice the different areas of accounting and set more knowledgeable career goals for themselves," said Ken Johnson, director of the Harding accounting program.

Miller is a senior, accounting major and is a member of American Studies and Tri-Kappa women's social club. She is the daughter of Mrs. Elaine Miller of Clarksville. This program has been organized through the cooperation of Phil Herrington, audit partner with Arthur Young and Company in Little Rock and Ed Hanlon, managing partner with Arthur Young and Company in Little Rock. Johnson and Dr. David Burks, dean of the School of Business, met with Herrington and Hanlon in March to formalize the internship agreement.

"This program differs from most internship programs in that it is a full semester in length and occurs during the spring semester when accounting firms are extremely busy," said Burks. "This will give students an excellent opportunity to see and experience what really takes place in public accounting."

Juniors and seniors majoring in accounting are eligible for the internship program. Students selected for the program will be able to complete their degree requirements in four years by taking a full load during the summer. It will be possible for these students to have two semesters or ten months of work experience at the time of graduation.

Science Seminar Planned

Dr. Michael B. Smith, 1973 Harding alumnus, will be the featured speaker for the Second Annual Science Seminar. The seminar coordinated by Dr. Ed Wilson, professor of physical science and Dr. Mike Plummer, associate professor of biology, will take place Oct. 10, 1985 at 7:30 p.m. in the American Heritage Auditorium.

Smith is the head of the Nuclear Magnetic Resonance Spectroscopy and Senior Staff Investigator for the Department of Neurology at the Henry Ford Hospital in Detroit, Mich. He is in charge of the strongest whole-body Nuclear Magnetic Resonance Spectrometer in the United States. The instrument is used to look at human tissues and organs and is non-destructive and non-invasive. At the present time, two 1.9 Tesla spectrometers exist. He also serves as Clinical Assistant Professor of Medical Physics for Oakland University.

He has done postdoctoral work in the Department of Biochemistry at Oxford University, England, and was a National Institute of Health postdoctoral fellow at the Institute for Enzyme Research, University of Wisconsin, Madison.

He is currently chairman of the Nuclear Magnetic Resonance Protocol Committee and has been active in the American Chemical Society.

After receiving the bachelor's degree in chemistry at Harding, he earned the masters and doctorate degrees from the University of Arkansas at Fayetteville. His doctoral dissertation was titled, "A 19F Nuclear Magnetic Resonance and Kinetic Study of Specifically Trifluoroacetylated Cytochrome c and its Interaction with Cytochrome c Peroxidase."

Smith has made several presentations to professional organizations including the American Federation of Clinical Research and the European Experimental Nuclear

Magnetic Resonance Conference in Palermo, Italy. He has also had numerous articles published in science-related magazines.

Smith's topic for the science seminar will be "Applications of Nuclear Magnetic Resonance to Biochemistry and Medicine: A Window to the Cell." The Science Seminar is funded by the Coons-Farrar Endowment Fund for the Sciences.

Educators Update Harding History

Pursuing doctoral dissertations is a regular activity in higher education and two Harding faculty members used their graduate study to document the history of the University and Harding Academy.

James Nichols and Tony Finley, assistant professors of education, received their doctoral degrees from the University of Arkansas and provided Harding with some much-needed material about its past in the process.

"Primarily my study covers and documents the years of the administration of Dr. Ganus," Nichols said. "Previous material was already available about the early years of the school, but there is practically no information covering Dr. Ganus and his administration (1965 to

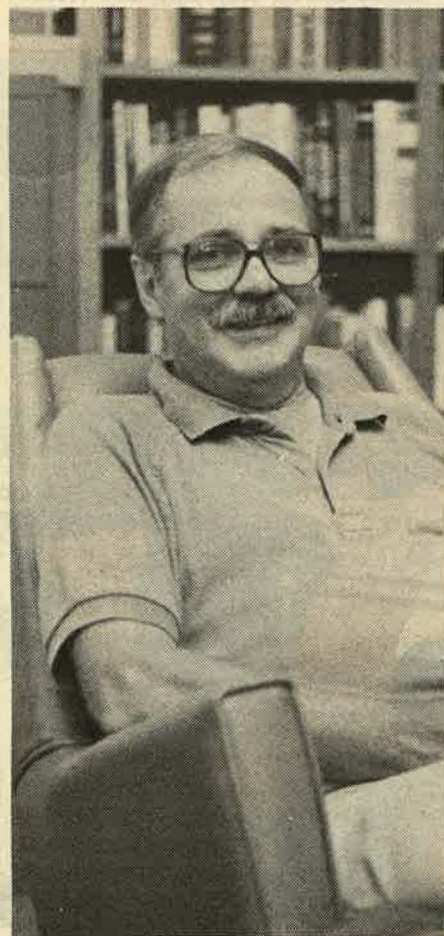
present) except in the school publications and brochures."

Nichols said, "There seemed to be a real blossoming of the school during his administration. The enrollment really took off and construction under his leadership practically doubled the campus."

Ganus was described by Nichols as a "kind, concerned administrator who is totally committed to what he's doing — 24 hours a day. I'm very much impressed with the spiritual depth and quality of the man," Nichols said.

Finley, a member of the Academy faculty before joining the University, compiled the history of the private school which began in Morrilton in 1924.

Raymond Muncy—Chairman and Professor of History and Social Science. A.B. (1960) Indiana University; M.A.T. (1963), Ph.D. (1971) University of Mississippi.

Scholar, teacher, preacher, elder, author, gardener — in short, Ray Muncy is a *doer*.

From the humble beginnings as the son of a coal miner in the West Virginia mountains, he has moved to a position as chairman of the history and social science department and has gained international recognition for his research and writing.

A genial storyteller of the first rank, Muncy has authored two books, *Sex and Marriage in Utopian Communities* and *Searcy, Arkansas, A Frontier Town Grows Up With America*. His first effort developed from his doctoral study at the University of Mississippi. Originally published by the Indiana University Press, it was then bought and published in paperback by Penguin Books.

His work on communal groups warranted an invitation to speak at the International Conference of Kibbutz and Communes Researchers May 19-29 at Tel Aviv University in Israel.

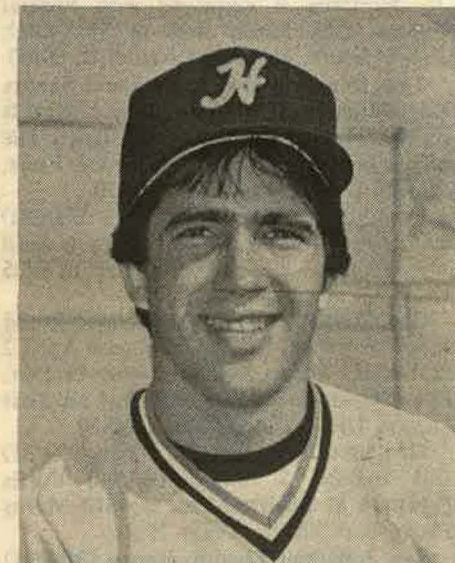
"That was an experience I'll never forget," he said. "I was totally unprepared for the visual impact of the country. The spartan life of the kibbutz and the people

made a great impression on me." Why does he teach? "I've always wanted to share ideas and I couldn't be happy doing anything else. Anything else would be dull by comparison."

Muncy also is an accomplished speaker and pulpit preacher, with a straightforward, sincere style of delivery. A full time minister before joining Harding in 1964, he preaches each Sunday morning for the Pine View congregation, a community just outside of Searcy. Since 1971 he has served as an elder of the College Church of Christ with a special interest in the educational program of the congregation.

Apart from the busy schedule of teaching and preaching, Muncy and his wife Eloise, find an outlet for their extra energy in a picture-book backyard garden. Raising everything from sweet corn to herbs, their time in the outdoors is obviously a refreshingly therapeutic outlet they love and enjoy.

Remember the old adage about "if you want something done, go to the person who is already busy?" Well, Ray Muncy is living proof.

Thompson Earns NAIA All-American Honors

Harding University second baseman Greg Thompson received NAIA All-American honorable mention recognition according to Charlie Eppler, NAIA director of communications.

Thompson, a 5-8, 155 pound junior, led the Bisons to the NAIA District 17 championship and a runnerup spot in the Area V tournament with a .396 batting average.

The Decatur, Ill., native was selected as Co-Player of the Year in District 17 (shared with Dan Marrero of Henderson State), All-NAIA District 17 and All-Arkansas Intercollegiate Conference.

Thompson set three records as the Bisons were enjoying their most successful season in school history. He had 61 base hits in 154 at bats and batted in 37 runs. In the field he was involved in 21 double plays and fielded .959.

In the final statistics released by the NAIA office, Thompson earned a fifth place ranking for hitting 17 doubles in 40 games.

Wishbone Installed, Bisons Gear Up for AIC Race

Taking a page from the past, Harding University will return to the wishbone offense in the fall of 1985, a formation that brought the Bisons great success in the early 70's.

John Prock, approaching his 22nd year as the Bisons' head coach, is hoping for the same results that brought Harding the Arkansas Intercollegiate Conference championship and a spot in the Cowboy Bowl in Lawton, Okla., in 1972. That was the season that the Black and Gold compiled a 10-1 record while averaging six yards per play with the full house offense.

"You've got to have more than one quarterback, some running backs, to make the wishbone go," Prock said. "We've got three young quarterbacks and it should be some contest to see which one comes out on top. We think we've got the personnel to make it effective."

Following his own advice, Prock has waited for an opportune year to reinstall the potent offensive attack. A very successful spring training has everyone enthused about the explosiveness of the offense and its potential.

Junior Mannie Lowery, who spent most of last year on the bench with a broken thumb, is the leading candidate for the man-under spot. A team leader from Little Rock, Lowery has accumulated 342 yards in the air.

Lowery's toughest competition will come from Roddy Mote. He is a hard-nosed sophomore who stepped in last fall when Lowery was injured and became the team's total offense leader with 709 yards. A quick-footed product of St. Mary's, W.Va., Mote should make Prock's quarterback decision difficult.

Also competing for the spot behind the center is sophomore Ryan Blickenstaff, a young competitor with a rifle arm from

Boise, Idaho.

"If we had to play today, I don't know who would start," Prock remarked. "All three ran the offense well in spring drills and they really root for each other and help each other."

Up front senior co-captain Scott Franklin (6-0, 244) of Dunwoody, Ga., will anchor the offensive line at tackle, along with 268 lb. senior Wes Hunt of Denison, Texas. Bob Harvey (5-11, 242) or Irving, Texas, and John Collins (5-11, 220) of Uniontown, Ohio, are returning starters at the guard spots and top hand James Smith, a 235 lb. senior from West Helena, Ark., will handle the offensive snap.

The Bisons will back up their signal callers with a pair of bullish-type backs at the fullback position.

ZCO Uhatafe, the "Running Samoan," returns to the fullback job for his fourth



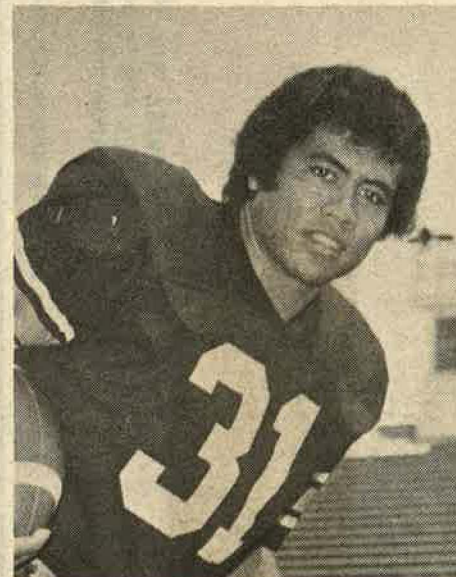

year with 775 yards under his belt. A senior from St. Petersburg, Fla., Uhatafe is returning to the running form he exhibited before a knee injury slowed him through most of the 1984 campaign. Joining Uhatafe at fullback is sophomore Kent Chambers, a 5-7, 205-pounder from North Little Rock. Although small in stature, Chambers is the top weight lifter on the squad.

Prock's team also will benefit from the services of junior tailback Glenn Segars, a hole-finder from Lithonia, Ga., who has rolled up 1,051 career yards in a Bison uniform. Segars has the talent to be All-America caliber with good speed and staying power.

In all, Harding is returning 15 offensive lettermen, seven of whom were starters last year.

Graduation hit the Bisons defensive unit hard but several talented athletes are ready

to step into the vacancies. Good quality experience is on hand to provide the leadership.

Noseguard Fanasial "Dump" Quinn, a one-man wrecking crew with All-America potential, returns for his senior season after leading the team in tackles last year with 112. The 5-8, 224-pounder hails from West Point, Miss.

In the defensive backfield, cornerback Drake Jackson of Temple, Texas, will lend his leadership ability as one of this year's co-captains. The hard-hitting 6-0, 195 lb. senior has posted four career interceptions.

The Black and Gold "Killer Bee" defense returns 11 lettermen, including four of last year's starters.

With 26 returning lettermen and a powerful offensive set-up from the past, the 1985 edition of the Harding University Bisons should be a team to watch.

Harding Shortstop Signs Pro Contract

Harding University shortstop Randy Hindman signed a professional baseball contract with the Cincinnati Reds.

A two-time All-Arkansas Intercollegiate Conference selection, Hindman was signed after a day long tryout camp in Searcy June 11.

"It is the first time in four or five years that I've signed a player that day at a tryout camp," said Bill Clark, the Red's midwest scouting supervisor.

A 5-9, 160 lb. athlete, Hindman batted .361 this spring to lead Harding to its first NAIA District 17 baseball championship. He set single season school records with 40 runs scored and 27 stolen bases. Hindman also set a career record of 48 stolen bases.

"All I ever wanted was a chance," the former Sylvan Hills High School standout, said. "I was relaxed when I came here and I didn't try to press. My running really helped me. He timed me twice in 6.4 for the 60-yard dash."

Hindman reported to the Reds' rookie league team in Sarasota, Fla.

More than 80 athletes participated in the tryout camp which was conducted by Clark and fellow Reds' scout Jerry Raddatz. (Editor's Note) At presstime, word was received that Hindman is hitting .359 with 17 runs batted in, and enjoying a fine season in the Florida rookie league. Coach Johnson said Hindman had been moved to second base and was making rapid adjustment at the new position.

Harriers Boast Depth, Experience

Three All-Conference performers headline a list of six returning lettermen as the Harding cross country team embarks on the quest of its 15th straight Arkansas Intercollegiate Conference championship.

Coach Ted Lloyd will return one of his most experienced teams ever. The All-AIC trio are seniors Al Bates of Nashville, Tenn., and Larry Wayne of Fairhope, Ala., and sophomore Jon Partlow of Portland, Ore.

Rounding out the experienced runners who will be back are senior Jim Baird of Rolla, Mo., juniors Darryl Halbert of Lakewood, Colo., and Eddie Neal, all conference in 1983, of Griffithville, Ark.

Lloyd, who was the AIC and NAIA District 17 Coach of the Year last season, indicated he was expecting some talented freshmen to add valuable depth to this year's squad.

"By all indications," Lloyd said, "this may be the best summer we've had. Most of the runners have been getting in some good training. That should help us."

The Bison harriers will open the season at home Sept. 21, hosting their own Bison Invitational Meet. Other meets will be the Notre Dame Invitational (Ind.) Oct. 4, the Washington University Invitational (Mo.), Oct. 12, the Southeastern Championships in Nashville, Tenn. Oct. 26, and the AIC-District 17 meet Nov. 2. The NAIA Championship will be held in Kenosha, Wis., Nov. 16.

A strong challenge to the Bisons could come from two AIC opponents, according to Lloyd. Both, the University of Arkansas at

Monticello and Ouachita Baptist University, return all their top runners from last year.

The picture for the women's team is one showing growing improvement for the young program. "I look for the women's team to be much improved over last year," Lloyd said.

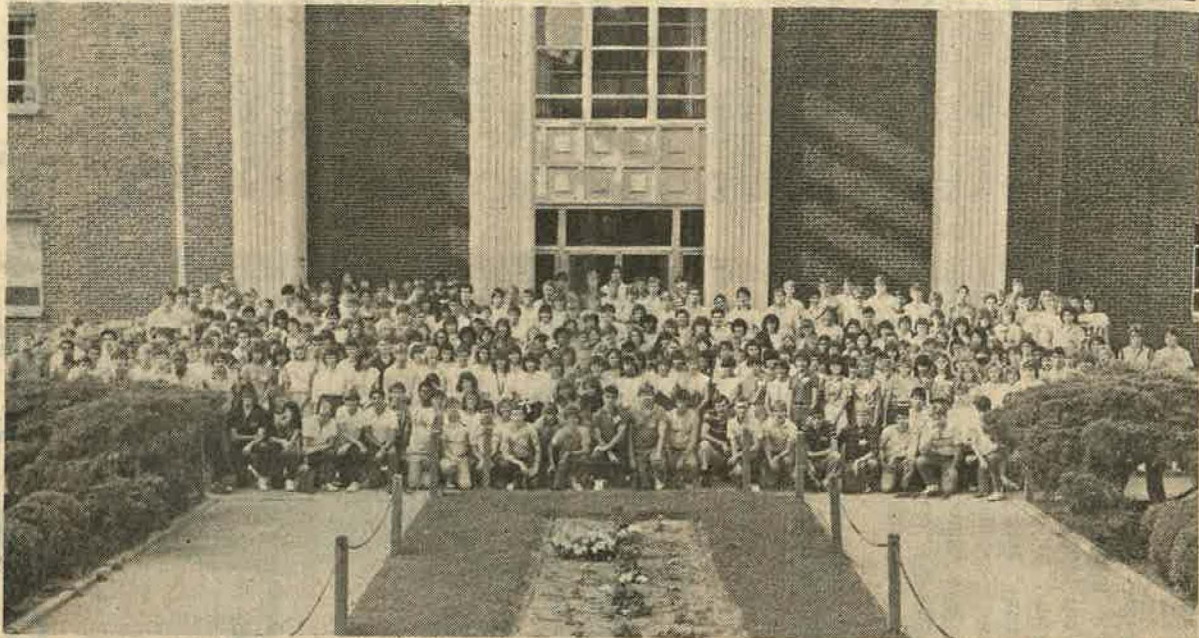

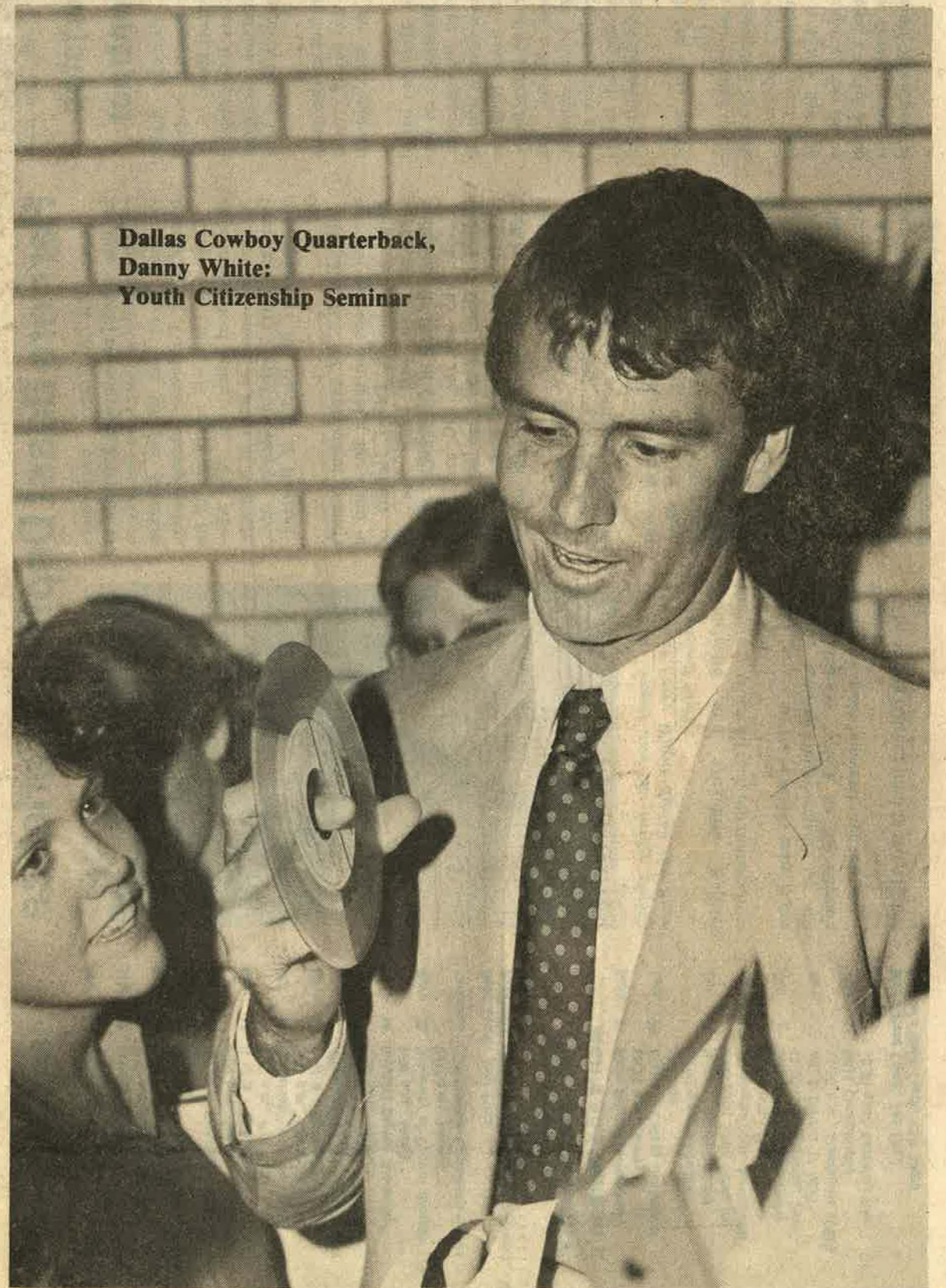
