## Fund-Raising Efforts for 1988 Result in Record \$6 Million Year

Harding friends joined forces to bring the year's donations to a record \$6 million mark in 1988. The \$6,048,463 total represents a 15 percent increase over the previous record in 1985 and a 79 percent increase over the 1987 total.

"Giving to Harding
University in 1988 was at
an all-time high," said Floyd
Daniel, vice president for
university relations. "It was
truly a team effort among
Harding's friends."

The record mark comes in the first of a five-year Beyond Excellence campaign. The campaign has designated a \$25 million goal for current and capital projects and \$40 million in endowment needs. The campaign is the largest ever undertaken by Harding.

"An increase in alumni support played a big part in last year's fund-raising success," said Al Fowler, assistant vice president for university relations. "Alumni support totaled \$1,349,784 and the number of donors increased by 570. Our alumni know us best, and

we will need their continued support if we are able to go beyond excellence."

The receipt of a \$1.25 million challenge grant from the Mabee Foundation highlighted the year's gift activities. The grant was certified after Harding raised \$2.5 million in gifts and pledges from alumni, trustees and administration.

September's nationwide alumni phonathon served to kick off fund raising for the Mabee challenge. A total of 3,116 households were contacted and \$599,453 was raised in gifts and pledges.

The Mabee grant funds are being used in a renovation and expansion project involving three buildings on the Harding campus — the John Mabee American Heritage Center, Pattie Cobb residence hall and Beaumont Library.

Renovation for Pattie
Cobb hall was completed
soon after 140 women
moved to the building at
the start of the fall
semester. The project for
the entire building started

in late January and included restoration of the exterior of the three-story building as well as renovation on all three floors.

The first floor, which was used as a cafeteria, was converted into a reception room, manager's apartment and individual rooms. The facility, built in 1919 and used constantly since Harding has occupied the Searcy campus, is now considered the residence hall of choice for women.

Renovation on the Heritage Center and Library will begin soon.

"The year's success in fund raising is an example of the willingness of Harding's friends to become genuinely involved in enhancing and strengthening Harding for future years," Daniel said. "More than the dollars given, I believe giving at this high level validates the feelings about Harding's mission and the quality of our effort by those who know us best. People do not give generously to works they don't have a lot of confidence in and we count this confidence a trust.

"Finally, and most of all, we thank God for the generous giving of so many friends to Harding in 1988; for it is God who gives the increase in those things that are good," Daniel added.
"We are excited about the prospects for 1989."

## 25th Annual Youth Forum Features Pryor, Walling

The Silver Anniversary edition of Harding's annual Youth Forum will feature Neale Pryor and Jeff Walling March 24-25.

"You Are Not Your Own" is the theme for the two-day forum. Vice president for academic affairs at Harding and well-known evangelist, Pryor will speak on Friday, March 24. His topics will be "God and You" at 9 a.m. and "You Are Not Your Own" at 2:30 p.m.

Walling is minister for the Mission Viejo Church of Christ in California. "My Master and My Servant?" and "Possessed or Possessor?" are the titles of his addresses on Saturday, March 25. His first lecture will follow President David Burks' welcome at 9 a.m. and the second is at 12:45 p.m.

A highlight of the Youth Forum weekend is the student presentation of Spring Sing. Annually involving 400 to 700 university students, the musical extravaganza is viewed by nearly 12,000 people. Performances are Thursday at 7 p.m. (\$5), Friday at 7 p.m. (\$6), and Saturday at 3 p.m. and 7 p.m. (\$6).

Other musical presentations will involve the University Chorus, the Concert Choir and the Concert Band, beginning at 12:45 p.m. on Friday; the Belles and Beaux at 4 p.m. Friday; and Time of Day at 8 p.m. Friday and at 10:30 a.m. Saturday.

A campus-wide devotional at 10:30 p.m. Friday, March 24, will feature S.A. president, Mark Moore, as speaker. The Harding video will be shown at 10 a.m. Friday and 11 a.m. Saturday, followed by campus tours every half hour until 2 p.m.

Registration for the anniversary weekend of Youth Forum will begin at 8 a.m. Friday, March 24, in the lobby of the American Heritage Center. More than 3,000 guests are expected to attend.

#### **Barnes Appointed to Administer Student Affairs Division**

Dr. Jerome Barnes, professor of Education and Dean of Campus Life at Harding University, has been named Vice President for Student Affairs, effective in May. He will succeed Dr. Ted Altman, who announced his resignation in November to return to classroom teaching.

Barnes is a 1956 Harding graduate. He has been a member of the faculty since 1962. He received his master's degree from Harding in 1958, and he holds the doctorate degree from North Texas State University.

During his tenure at Harding, he has taught in the School of Education, directed the Educational Media Center and, for the

Barnes and his wife, Barbara, have three children: Roy, who lives in Jackson, Miss.; Randy, a senior at Harding; and Jennifer, a sophomore at Harding Academy.

## **Spring Enrollment Tops 3,000**

When enrollment closed for the spring semester Jan. 23, the number had topped 3,000.

The total of 3,027 is 325 more than were enrolled for the spring semester last year and is a school record for spring enrollment.

"The number is really significant," said Ron Finley, registrar. "We graduated 129 students in December and we are only 75 students under the record number for last fall."

Admissions Services Director Jim White is encouraging prospective students for the fall of 1989 to complete their applications early. "We know approximately how many openings we will have for housing, and students will be placed according to their *acceptance* date," White said. "When we reach capacity, we will place all we can three to a room and the others will be placed on a waiting list," he added.

The number of applications for fall is 26 percent ahead of this time last year. White indicated that openings for women students are filling especially quickly.

#### **Teen-agers from 5-State Area** To Attend Citizenship Seminar

The 33rd annual Youth Citizenship Seminar will be hosted by Harding June 11-16, 1989. Designed to help high school juniors and seniors learn more about democracy, free enterprise and the American way of life, the seminar involves more than 500 students from five states.

Major speakers for this year's program will include Elaine Donnally of Eagle Forum; Oddvar Berg, a Swedish immigrant: Eric Brodine, an international economist; Capt. Ken Wells, a Vietnam P.O.W.; Col. Joe Hickox, a Soviet air attache; and Gene Antonio, a wellknown AIDS author.

"The Youth Citizenship Seminar informs young people of their heritage and encourages them to take an active role as citizens and community leaders," said Dr. Bob Reely, director. The seminar is sponsored jointly by Civitan clubs, Kiwanis clubs, Lions clubs, Arkansas and Tennessee Farm Bureaus and the university's American Studies Institute.

Various activities and projects fill the week for students from Arkansas, Alabama, Missouri, Florida and Tennessee. A formal banquet and presentation of projects is the closing highlight of the seminar.

### Searcy Summer Dinner Theater Schedules Three Productions for 1989

"Arsenic and Old Lace" will head the list of plays for Searcy Summer Dinner Theater, with performances June 22, 23 and 24. Two other productions, "Wait Until Dark" and "The Rainmaker," will be presented July 13-15 and July 27-29, respectively.

The dinner theater program will be presented in the American Heritage Cafeteria this year for the first time. A banquet room will be designed with a stage and other accommodations necessary for the annual theater program. "We have pretty well

outgrown the Student Center area and it became increasingly difficult to do the stage work in such a busy place," said Dr. Morris Ellis, director of theater. "The new facility will give us lots of room in an out-ofthe-way area to work." ARA Food Services will cater the meals.

"Arsenic and Old Lace," a comedy by Joseph Kesselring, will be directed by Leigh Ellis. The story centers around three charming and innocent ladies who populate their cellar with the remains of socially and religiously "acceptable" roomers. Added to the humorous strains are the antics of their brother who thinks he is Teddy Roosevelt and the activities of another brother. The cast includes 11 men and three women. Auditions will be held Monday, June 5.

"Wait Until Dark" is a mystery drama by Frederick Knott. The story follows the actions of a courageous and enterprising young, blind woman who fends off mysterious scoundrels in her basement home while her husband is out on a photography assignment. The cast includes six men, one woman and one girl.

Directed by graduate assistant Andy Kronnenwetter, the roles will be cast following auditions June 5.

The final production for the summer of 1989 will be Richard Nash's comedy, "The Rainmaker." Set in the West during a paralyzing drought, the story follows a girl whose father and two brothers are as worried about her being an old maid as they are about their dying cattle. A rainmaker appears on the scene and convinces the father that he can bring rain (for \$100). He also convinces the girl that she is beautiful. The result is rain and romance.

Morris Ellis will direct this production, which involves a cast of six men and one woman. Audition times will be announced at a later date.

Searcy Summer Dinner Theater presentations have been a popular entertainment medium for members of the community and for students in summer school. A number of guests from nearby communities have attended regularly as well.


## 129 Receive December Diplomas

## Student Teacher Makes an Impact in the U.S.A.

When Michel Aguilar
walked out of classroom
#703 at Bald Knob High
School Friday, Dec. 16, she
had not only finished student teaching but she had
completed her stay in the
United States.

A Central American student who attended Harding as a part of the Walton scholarship program, Michel and her husband, Miguel, were at Harding for two and one-half years. She missed graduation ceremonies Dec. 17 so they could catch an early-morning flight to Honduras rather than stay another 12 days and miss Christmas at home.

Michel and Miguel were recruited by Dr. Clifton L. Ganus, Jr., during a visit to Honduras. "My husband wanted to study so we both decided to apply. We were accepted for scholarships, so everything was set," Michel said.

Her study at Harding was not Michel's first experience with college education in the United States. She had attended St. Louis University in 1976 to study English; later she added a few courses at Sanford Brown College and Houston University. She also studied in her home country at the University of Honduras.

The Walton program was funded by Sam Walton to recruit students from Central America, let them learn about freedom and democracy and return to apply these principles in their own countries. Most of the Walton students major in business. Few choose to major in education, but Michel combined the studies and majored in business education.

"I decided to teach because I like to share with people," Michel said. "I have a lot of love to give young people; they are the ones who need the most help. They need to learn good things.

"Many of the students don't have the moral teaching or love at home that they need," she added. "I get close to my students. Teaching is what's important to me, not making money."

"Michel has done an excellent job in her student teaching," said Mrs. Beth McCarty, her supervising teacher at Bald Knob. "She overcame a lot of obstacles, especially her accent. We soon got used to her and she got used to us and there were no more problems," she added.

Jody Spradlin, a senior in her Computer II class, said,

"There was a lot of adjustment to make. It was difficult to understand what she was saying so we had to listen more intently. We really learned a lot, especially about her homeland. She's really nice."

"I begged Dr. (Jim) Nichols not to make me student teach in the United States," Michel said. "I was afraid the students would not understand me and that I would not do well. He told me I could not receive my degree in the U.S. without student teaching here. I'm so thankful now - it was a great experience! It is really a privilege for a foreigner from an underdeveloped country to get to teach American children."

To help in the transition from Mrs. McCarty, Michel introduced herself early in her student teaching experience by dressing in native attire and telling the students about her home country. She also taught them some short Spanish songs during five-minute sessions about life in Central America.

"My educational training has been excellent. The people at Harding have been so kind," she said. "They took time to help me. They have gone out of their way, especially because of my difficulty with the language. Of the colleges and universities I have attended, I like Harding best, I think because it is a Christian school."

As to her stay in the United States, Michel described her adjustments and reactions. "The biggest adjustments were to food and weather," she said. "I now have sinus problems, something I didn't even know about before." She also cited the "hurried life" in the U.S., but was especially fascinated with shopping.

"When we come back for a visit, I want to come in December to do my Christmas shopping," she said. "There is such a variety of things to buy and at good prices, especially on electrical appliances. I also like the snow," she added, "so maybe it will snow if we come in the winter."

Michel summarized her feelings about returning to Honduras. "What I'll miss in the U.S. is people, but I prefer living in Honduras. My family is there and my people need me more than I am needed here. I'm anxious to go back."

When Michel and Miguel boarded the plane in Little Rock, they were returning to their native country. Both had jobs awaiting them — he as vice president of Baxter Institute and she as a teacher in a bilingual (American) school, or as an accountant. Whichever career she chooses, Michel Aguilar will certianly "apply the principles of freedom and democracy in her own country."

Her stay in the United States gave Michel a lot education, training, perspective and appreciation. Perhaps even more significant is what she gave to those she left behind.

### Missionary to Belize To Teach During 1989-90

William Howard (Bill)
Searcy, who has worked
as a missionary in Belize
since 1984, will be the
Visiting Professor of Missions for the 1989-90
school year. Searcy has
also served as a coordinator for Health Talents
International in Belize.

A magna cum laude graduate of Harding in 1977, Searcy holds both the Master of Theology and the Doctor of Ministry in Missions from the Graduate School of Religion in Memphis.

As a student, Searcy spent much time sharing his life's story and his conversion to Christ while he was in prison for drug abuse and dealing in his native North Carolina. Another Harding alumnus, Kent Brand, befriended Searcy, who immediately began a preaching career at the prison. He has had extensive experience speaking for civic clubs, schools and special interest groups. Also, he has lectured extensively throughout the U.S. and Europe on such subjects as drug abuse, jails and prisons, world travel,



Searcy democracy and communism.

While a student at Harding, he became interested in teaching behind the Iron Curtain, and spent five years as an evangelist in the Soviet Union and other communist countries preaching and teaching. During graduate school in Memphis, he worked with the White Station and Highland Street Churches of Christ and the Memphis State Christian Student Center.

Searcy is married to the former Mary Katherine Heitman, a registered nurse who also holds a master's in counseling and special hocation.





## University Relations Makes Administrative Changes

Tim Bruner has been promoted to senior development officer and director of special programs. Rowan McLeod is assistant director of development administration. Carter Lambert has joined the staff as director of alumni relations.

Fowler joined the Harding staff in 1973. In 1984, he was named director of development. A 1968 Harding graduate, he is a Certified Public Accountant. Before returning to Harding, he was an accountant for Ernst and Whinney from 1968-71 and was controller of Superlite, Inc., a division of U.S. Industries, from 1971-73.

Tucker joined the staff of the university relations office in 1981. He received the B.A. degree in business administration from Harding in 1968 and graduated from the University of Alabama School of Law in 1969. He practiced law in Tuscaloosa from 1970 until 1981.

Bruner served as director of alumni relations during 1987-88 and as assistant director the previous two years. A 1973 graduate of Harding, he was a missionary/instructor at Namwianga Secondary School in Kalomo, Zambia, from 1974-76. He served as director of college relations and assistant to the president at

York College during 1977-85.

McLeod is a 1970 Harding graduate who joined the university relations staff in 1984. A CPA, he worked as a staff accountant and accounting manager for firms in Memphis and Dallas from 1970-74. He served as vice president for finance of Spears Carpet Mills from 1974-80 and was owner of McLeod Accounting from 1980-84, both in Hope, Ark.


Lambert, a 1982 graduate, recently completed doctoral study in educational administration at Texas A & M. An All-American distance runner, he was the

## Christian Stewardship And Estate Planning



#### WHAT IS ESTATE PLANNING?

An estate plan is an arrangement of one's affairs so that their assets can be used and conserved during life and transferred smoothly at death. It involves more than merely preparing a Will.

It involves lifetime objectives such as providing funds for children's education, income for retirement, replacement of income in the event of disability, and management of the estate in the event of incapacity.

Many estate planning tools are available to the estate owner to help accomplish his or her goals, such as: lifetime transfers, revocable living trusts, irrevocable trusts, testamentary trusts, life insurance, annuities, charitable gifts, charitable gift annuities and charitable remainder trusts. All of these tools have multiple facets and are available to help the estate owner accomplish his or her objectives.

Each estate is different in composition and each estate owner has different objectives. It naturally follows that each estate plan must be tailor-made to coordinate assets with objectives. A skillful mix of estate planning tools will help to accomplish the estate owner's lifetime objectives and the disposition of these objectives at death, with minimal taxes.

Many have a natural reluctance to plan their estates. Estate planning forces one to come to grips with matters that he or she may not like to think about, such as retirement, illness and death. Perhaps this strong psychological resistance to estate planning plus procrastination and indecision are responsible for the majority of U.S. citizens dying without a Will.

Should Christians be a part of the majority who never plan their estate? A Christian's estate belongs to the Lord. Christians are stewards or temporary managers of assets entrusted to them by the Father. It is right for Christians to carefully plan for the use and conservation of God's assets during life and to provide for an orderly-transfer of those assets at death.

## Gift Clubs Initiated To Recognize Donors Harding gift clubs will plaque will be unveil

Harding gift clubs will take on a new look in 1989 and will be known as the *Century Club*. The reorganization is part of a concentrated effort to better recognize thousands of dedicated Harding donors and to increase muchneeded annual unrestricted gifts.

"More young people than ever before are looking to Harding for their Christian education," said Dr. David Burks, president. "We are thankful for the increased enrollment, but we are now facing the challenge of raising more unrestricted gifts than ever before, in order to provide the kind of education our young people desire."

The Century Club will recognize those donors contributing \$100 or more in unrestricted gifts during one calendar year. All gifts received during one year may count toward Century Club membership for that year.

There are four levels of Century Club membership: Century (\$100), University (\$250), Heritage (\$500), Presidential (\$1,000). Each Century Club member will receive a handsome walnut plaque with an engraved nameplate. Pendants below the plaque will indicate the years of membership. The

plaque will be unveiled in the April Bulletin.

"The majority of Harding's support has, historically, been from donors contributing less than \$1,000 per year," said Brett Kirkman, Director of Annual Fund. "The Century Club is designed to show lasting appreciation for this important group of dedicated friends and to encourage others to join in the effort."

Unrestricted gifts include any gift that provides funds immediately available to Harding. Gifts received on pledges to the Beyond Excellence campaign do qualify for Century Club membership. These gifts are the lifeblood of Harding, providing funds for current operations not covered by tuition and grants.

"I encourage all of our friends to choose an appropriate Century Club level, but whatever the amount of the contribution, the gift is appreciated and needed, and will have an impact on the students at Harding University," added Burks.

Some social clubs, such as Knights men's club and the JOY women's service group, contributed from their membership and collected additional funds for a children's home in the city. The two groups went to the home, Moore donned a Santa suit, and the children were treated to a special evening.


Bison football team members and cheerleaders sponsored a party in which a selected family was brought to the campus for a generous outpouring of gifts and food.

The campus Public Relations Student Society of America (PRSSA) chapter gathered \$300 for the local United Way campaign. The members sponsored a Levi Strauss company project which not only raised money but also gave the students valuable experience in advertising methods.

Many of the other social clubs and campus organizations joined in funding and sponsoring a special project that involved others.

The examples of serving were not limited by any measure to the holiday season. Throughout the year, students and sponsors in the social work area salute senior citizens and/or students in Searcy's Sunshine School in a monthly chapel program. parents concerned about their children's welfare on dark streets. Students gather candy weeks in advance and distribute it to the young guests.



## 15 to be Inducted into Into

Fifteen coaches, administrators and former athletes will be inducted March 3 as charter members of the Harding Intercollegiate
Athletic Hall of Fame. The announcement of the honorees and induction ceremonies was made by Searcy Downtown Bison Booster Club President Bill Harris.

"These 15 individuals have contributed greatly to Harding's athletic program," said Harris, who chaired a committee that selected the honorees from more than 90 nominees. "There have been many outstanding athletes, coaches and supporters through the years who deserve inclusion in the Hall of Fame. We look forward to recognizing their accomplishments in the future."

The charter members of the Hall of Fame include athletes Ned Boaz, Cliff Clark, Jim Crawford, Edd Eason, Stan Eckwood, Lavester "Butch" Gardner, Tom Ed Gooden, Ronnie Peacock, Elwin "Preacher" Roe and Steve Smith; coaches Ted Lloyd and John Prock; and administrators Dr. Clifton L. Ganus, Jr.; Dr. Joseph Pryor and the late M. E. "Pinky" Berryhill.

Harris said the Booster Club had considered the idea of the Hall of Fame several years ago and "just decided it was time to do it." The club gathered a list of 1,900 athletic alumni and sent information on the Hall to every other one, as well as campus faculty and staff, for nominations. After nominees were submitted, a committee of 10 boosters and school administrators selected the charter group.

Harris said the committee selected 15 initially to "work as a good base for future selections," with plans to add not more than five each year in the future.


Selection into the Hall is divided into three categories: Athletes, Coaches and Meritorious Service. Criteria for athletes include the completion of their eligibility at least five years ago, good character and citizenship both during and after their playing days, the earning of at least two varsity letters, and the receiving of All-Arkansas Intercollegiate Conference, All-NAIA District 17 or All-America honors. Coaches must have demonstrated good character, and meritorious service honorees must have been strong supporters of the program through their work or actions.

An awards banquet honoring the charter inductees will be held March 3 at 6:30 p.m. in the American Heritage Cafeteria. The speaker will be Jim Bill McInteer, board of trustees member and publisher of Twentieth Century Christian. For more information on the banquet, contact Dr. Jimmy Carr's office at P. O. Each of the honorees' photographs will hang in the Ganus Athletic Center for display following the banquet.

#### Boaz

A 1965 graduate, Boaz received NAIA All-America Honorable Mention and All-AIC honors in basketball his senior season while averaging 18.9 points a game. In two seasons following his transfer from Lubbock Christian, he scored 911 points to rank him among the top 20 scorers in school history. In 1973, Boaz was honored as the Neil Gibson Martin AAU Athlete of the Year in Arkansas for his participation on the Carder Buick AAU squad.


#### Clark

Clark is a native of Shelter Island, N.Y., who was the first Harding track performer to win an NAIA national title with his victory in the 3000-meter steeplechase in 1966. A year earlier, he was the school's first All-America selection by virtue of his 12th place finish in the NAIA cross country meet. He also received the Neil Gibson Martin AAU Award in 1966. Clark was inducted into the NAIA National Track and Field Hall of Fame in 1975.

#### Crawford

Crawford was the first runner from an Arkansas school to break the four-minute barrier in the mile run with his 3:59.6 performance in the 1969 California Relays. The West Millington, N.J., native won numerous NAIA All-America honors and received the Neil Gibson Martin AAU Award in 1968.

In 1971, he earned the bronze medal in the 1500 run of the Pan American Games in Cali, Columbia, and was a U.S. Olympic Trials finalist in 1968 and a semifinalist in 1972 in the 1500-meter run. He was inducted into the NAIA Track and Field Hall of Fame in 1976.



Crawford

#### Facon

A 6-4, 230-pound offensive tackle from Ft. Worth, Texas, Eason was named to the 1972 NAIA All-America team while helping lead the Bisons to a 10-1 record and the AIC co-championship. He was a unanimous choice to the All-AIC and All-NAIA District 17 squad. He was also named the school's Outstanding Senior Athlete for 1972-73.

#### **Eckwood**

Eckwood averaged 26.2 points a game and scored 759 points to rank as the eighth leading basketball scorer in the nation in 1978-79. He led the AIC in scoring as a junior and a senior, was an All-AIC and NAIA District 17 selection both seasons, and an NAIA All-America Honorable Mention as a senior. His 1,593 points ranks him third in school history.

A native of Brinkley, Ark., he was drafted in the ninth round of the 1979 National Basketball Association draft by the Portland Trailblazers and was the final player cut by the team prior to the start of the season.

#### **Gardner**

The all-time leading scorer for the Bisons, Gardner reaped NAIA All-America honors his sophomore, junior and senior seasons. His 2,255 career points and 983 rebounds are both Harding records. He earned All-AIC and NAIA District 17 laurels all four years.

After a tryout with the Atlanta Hawks of the NBA, the Searcy native served as assistant coach for the Bisons for five seasons before becoming head coach at the University of Arkansas-Pine Bluff. He returned to Harding in 1987 as Dean of Men.



Gooden

#### Gooden

Gooden earned NAIA All-America, All-AIC and NAIA District 17 honors in 1973 to cap off one of the most prolific football careers in school history. A 6-2 triple threat quarterback, he led the Bison offense for three seasons, including 1972 when they went 10-1.


The Carlisle, Ark., native accounted for 3,667 yards in total offense, including 1,002 yards rushing and 2,665 yards passing. In addition, he kicked 53 of 62 extra points and 12 field goals, and punted 98 times for a 39-yard average through his career. He was chosen in the 11th round of the 1974 National Football League draft by the Cleveland Browns.

## ercollegiate Hall of Fame

**Peacock** 

Peacock was the eighth receiver in collegiate football history to catch more than 200 passes in a career. He rewrote Harding and AIC receiving records with 201 catches for 2,553 yards. His 62 receptions in 1970 stood as the league mark until 1985, and remains as a school standard.

The McGehee, Ark., native earned All-AIC and NAIA District 17 honors in 1970 and 1971, and NAIA All-America Honorable Mention in 1971. He was signed to a free agent contract by the Pittsburgh Steelers of the NFL.



Roe

A member of the NAIA and Arkansas Halls of Fame, Roe achieved lasting fame in major league baseball after an outstanding collegiate career. The lefthanded pitching ace from West Plains, Mo., attended Harding from 1935-38 and led the Bisons to the AIC Championship as a senior. He gained national recognition in 1937 when he struck out 26 Arkansas Tech batters in a 13-inning game.

Roe signed a bonus contract in 1938 and played with the St. Louis Cardinals and the Pittsburgh Pirates before joining the Brooklyn Dodgers in 1944. He posted a 19-11 record in 1950 and was 22-3 in 1951 when he was named the top National League pitcher by *Sporting News*. Among his victories were 1-0 (1949) and 5-3 (1952) World Series wins over the New York Yankees. His career record was 129-85.

Roe was inducted into the Arkansas Hall of Fame in 1967, and the NAIA Hall of Fame in 1976. His Dodger uniform, worn during the 1952 World Series, is on display in the Ganus Athletic Center.

#### **Smith**

When Smith graduated in 1963, he took with him almost every athletic award the school had to offer. Among the most outstanding feat was a record 12 athletic letters earned in four sports. That record still stands, and the athletic versatility required to achieve such a record makes it seem secure for some time.

A Newport, Ark., native, Smith won the first M. E. Berryhill Award for the outstanding senior sports. He garnered four letters each in baseball and basketball, three in football and one in bowling. He was the runner-up in 1963 for the AIC Scholar-

Athlete award, a two-time All-AIC recipient in baseball and All-AIC honorable mention his junior and senior seasons in football. He presently is head Bison baseball coach and a professor of mathematics.



Lloyd

#### Lloyd

Lloyd has directed the men's and women's cross country teams to a combined total of 22 AIC and 19 District 17 championships, including 18 consecutive men's and three women's titles. His men's track and field teams won conference titles in 1966, 1981 and 1982. In addition, he has coached three cross country and 22 track and field All-Americans during his illustrious career.

A professor of health, physical education and recreation, Lloyd is a native of Spring Hill, Kan., who graduated from Harding in 1957. He served as head coach of the Panama National team in 1969-70 that competed in the Central America-Caribbean Games, and was a member of the United States coaching staff for the 1985 World University Games in Kobe, Japan.

#### Prock

Prock served for 24 years as head coach of the Harding football team. Under his direction, the Bisons won AIC titles in 1972 and 1976. He was named NAIA District 17 Coach of the Year in 1969, 1972 and 1976, and NAIA Area IV Coach of the Year in 1976. His 1972 squad finished the season 10-1, including a 30-27 win over Langston University in the Cowboy Bowl, and ranked sixth in the final NAIA poll.

The Hollis, Okla., native, who is a professor of health, physical education and recreation, was the sixth winningest active head coach in the NAIA with 114 victories when he retired in 1987. During his tenure, he coached 10 NAIA All-Americans, four Academic All-Americans and 63 All-AIC honorees.

#### Ganus

As a student, faculty member and chief executive officer, Ganus not only supported Harding sports, but was a fiercely competitive athlete. Often he could be found on the softball or football intramural fields during his 22 years as president, and was an outstanding intramural athlete while an underclassman.

Few Bison loyalists can challenge Ganus' support and encouragement for the school's athletic program. He, along with Berryhill and Pryor, were the catalysts behind the move in 1957 for Harding's resumption of intercollegiate athletics. During his administration, the school's athletic facilities

were greatly improved. They included the construction of the 82,000-square foot athletic complex, which bears his name, and the Jerry Moore Memorial Baseball Field, regarded as one of the top three in Arkansas.

#### **Pryor**

Many know Pryor best for his bow tie and academic influence on the school during his 40-plus years of service, but the enduring physical science professor was perhaps the most influential person in the AIC in his role for three decades as Harding's faculty athletic representative to the conference. He retired from the position in December after completing his third term as president of the league.

Pryor's interest in Bison athletics didn't come by accident. He was an outstanding basketball and track performer during Harding's early intercollegiate era, earning five letters. He was also named as one of the school's five best basketball players during its first decade of competition.

When Harding resumed varsity participation in 1958, Pryor was named the school's faculty athletic representative and guided the league as president in 1967, 1977 and 1987. He was instrumental in helping initiate the conference's academic guidelines. Eighteen men and two women from Harding have received the AIC Scholar-Athlete Award during his tenure. He still serves as official scorer for intercollegiate basketball games and clock operator for Bison football games.



Berryhill

#### Berryhill

Berryhill will long be remembered as the driving force behind the intercollegiate and intramural athletics programs at Harding. When he returned to his alma mater in 1937, he launched an intensive effort to expand the intramural program, which grew to include the participation of more than 90 percent of the students. In 1951, he was responsible for developing Searcy's Little League program, the first of its kind in Arkansas.

In 1938, Harding's final year of competition during its early era, Berryhill directed the Bison baseball team to the AIC championship. He was named athletic director and baseball coach in 1958 when competition resumed. Ill health forced him to resign his administrative duties in 1960, but he continued to coach, leading the bowling team to the AIC title in 1965. He died in 1972 following a lengthy illness.

Jeff Walling, Mike Cope, Jimmy Adcox, Rex Boyles and Buddy Bell are the featured speakers. Special programs will be provided by the Harmony Boys and Acappella.

The basic purpose of UPLIFT is to serve the spiritual needs of the campers. "We focus on spiritual development in a Christian college environment," said Dr. Paul Pollard, director. "We want to help

the young people begin to discover themselves spiritually and, at the same time, get a glimpse of life in a Christian college setting."

Encounter classes will be taught by 30 youth ministers, and 40 collegeage students will serve as counselors. Campers are housed in air-conditioned dormitories and all sessions are held in air-conditioned buildings.

## **Bisons Begin Conference Play** With Impressive Fall Record

With their non-conference schedules behind them, the Bisons and Lady Bisons are gearing up for a competitive Arkansas Intercollegiate Conference roundrobin slate.

The Bisons closed out the fall semester with an impressive 7-2 record, second best in school history, despite numerous injuries and illnesses that affected the team's titiveness. Included in the nonconference results was a second place finish in the Southern Illinois University-Edwardsville Thanksgiving tournament.

The Lady Bisons, meanwhile, entered league play with a deceiving 3-7 record. Four of the losses came against three nationally ranked teams with combined records of 34-3. The Lady Bisons are also 1-1 in

games versus two other opponents in pre-AIC action.

The Bisons opened league play Jan. 9 with a tough 101-85 loss to Hendrix College, and followed with an 88-82 setback in overtime against 10th ranked University of the Ozarks to stand 7-4 on the year. Ozarks handed the Lady Bisons their first league setback to give them a 3-8 mark.

Ailments have hit the Bisons like the plague. Twovear starter Rolando Garcia was forced to miss the first half of the season with a knee injury, and his status is still in question for AIC play. Others have fought the injury and illness bug, thus affecting the Black and Gold's depth.

"I've never seen anything quite like it," said Bison head coach Jess Bucy of the Bisons' early health problems. "There were a couple of times that we didn't have enough players to practice. It's not something you plan for, but our players have responded well in spite of the lack of depth. We've come a long way since the beginning of the season."

Two junior guards have come to the front to pace the Bison offense. Veterans David James and Corey Camper ranked second and third among the AIC's early season scoring leaders. James began the season averaging 27 points a contest but has cooled down to 21.4 points a game. Camper is just a step behind him at 20.6 points an outing.

The Bisons opened the season in Jackson, Tenn., with a tough 95-85 loss to Union University. Three straight wins over School of the Ozarks (82-68), John Brown University (100-79) and Wisconsin-Parkside (86-63 in the opening round of the STU-Edwardsville tournament) followed. STU-Edwardsville, ranked among the NCAA Division II top 20, downed the Bisons 80-76 in the championship game of its tournament, but the Bisons blazed to four consecutive victories.

They blew out Union 86-70, whipped Philander Smith 109-76, defeated School of the Ozarks for the second time 87-76, and dominated Missouri Baptist 92-81. Next came the loss to

Hendrix, and the overtime slip to University of the Ozarks.

The contests against Ozarks, incidentally, were played in front of a frenzied crowd that packed Rhodes Memorial Fieldhouse, the Bisons' home until 1976. More than 3,000 fans crammed into the "Old Gymnasium," which has an official seating capacity of 2,500.

The Lady Bisons are playing with several new faces after graduation took three starters from the lineup. Junior forward Syrena Burch leads the team in scoring with a 12-point average. Barely trailing her is junior guard Lisa Kirk with 11.7 points a game. Junior college transfer guard Carrie White averages 11.4 points, followed by senior forward Julie Roddy with 10.5 points and transfer Shannon Tate with 10.1 points. White, Tate and guard Gina Hudson (sixth in scoring with 8.8 points a game) teamed together the last two years at North Arkansas Community College.

"We're a young team, which is always a concern," said head coach Phil Watkins, "but we're making definite progress this season. Our main goal is to improve and hopefully qualify for the post-season tournament, and we're optimistic that we'll do that."

Highly ranked opponents such as Union, Oklahoma Christian and Southern Nazarene have presented the Lady Bisons problems, yet they have still played with responsibility. Union handed Harding's ladies lopsided losses, as did OCC and Southern Nazarene in the OCC New Year's Tournament. The Lady Bisons posted wins over Bethel College (70-63), John Brown University (71-57) and Southwest Baptist (83-72). Other losses have come to John Brown, in the JBU Invitational Tournament finals, Bethel and University of the Ozarks.

Both teams conclude their regular seasons Feb. 25 in Arkadelphia against Henderson State. The NAIA District 17 tournament opens March 2, with NAIA National Championship first round games scheduled for March 14 (men) and 16 (women).

## **Spring Sports Outlook Shows Promise**

The welcome return of several lettermen in each sport highlights the Bisons' and Lady Bisons' spring sports outlook.

Only one senior graduated from last year's baseball squad, keeping the Bisons strong in practically every position.

Leading the pack are outfielders Dennis Mitchell and Robert Cooper, catcher Tom Hull, pitchers David DePew and John Kodatt, and infielders Perry Parr, Andy Kinser, Larry Cheshier and Scott Rose.

Mitchell paced the Bison hitters with a .356 average and is a three-year starter. Hull is also a three-year veteran, as is Parr. DePew, who doubled as a third baseman and pitcher, and Kodatt posted 2-3 records a year ago. Kinser returns at shortstop with Rose settling in at second base. Cheshier, a starter at first base as a freshman, will likely move to third base for his sophomore season. Cooper also shined as a freshman

Track and field enthusiasts should have plenty to cheer about with the return of several experienced men and women.

Field events will be one of the Bisons' strengths. High jumper Te Howard and pole vaulter Jimmy Sloan, both All-Americans last

year, will receive help from distance men Marty Koonce and Jon Murray.

In the women's competition, all-everything Cheryl Bednosky will make a bid for All-America honors after setting school records in the 800, 1500 and 3000 meter runs. Margaret Eoff, who captured the 200 and 400 meter races at the AIC meet in 1988, should be the pre-AIC favorite in both events. Sprinter Kara Hutchinson and distance runner Tracy Parks also earned All-AIC

Chris Brewer and Jason Nier headline the returnees on the Bisons golf team.

Brewer finished 12th in the final AIC individual standings and helped lead the Bisons to a tie for third place. Nier joins returnees Marc Anderson, Scott Barber and Brett Biggs as the only veterans who will give support to Brewer.

In tennis, Ruy Martinez, Richie Roberts, Kelly Barden, Arleum Curry, Todd Gilliam, Keith Olree, Greg Barden and Lee Mackey are back to help the Bison netters. A year ago, the Bisons finished second behind a strong Southern Arkansas University squad in the AIC standings.



Senior linebacker Brooks Davis was named to three prestigious squads at the completion of the Bison football season.

A native of Bartlesville, Okla., Davis was named to the second team GTE/College Sports Information Directors of America (CoSIDA) College Division Academic All-America squad, as well as the NAIA Scholar-Athlete team. He was also named to the All-Arkansas Intercollegiate Conference second team for the second straight year.

He served as co-chairman in 1982, and wo fithe Student Association Jack Moore recognitude Life Committee and honor last fall.




