Enrollment Sets Record

Harding's enrollment is again at capacity for the third consecutive year with a record 3,311 students registered for the fall semester, an increase of 26 students over the 1989-90 total.

"Harding is in a special position right now in that we have more students seeking admission than we have space available," said Dr. Jim Carr, executive vice president.

Jim White, director of admissions services, believes the trend will continue and Harding will experience a capacity enrollment again next year. "We could have accepted even more students this year, but our problem is the lack of dormitory space," he said. Students who applied late in the summer could not be admitted for this reason.

Armstrong, Graduate Hall, Cathcart and Kendall dormitories were renovated during the summer. These four dorms and the six others on campus are filled. To accommodate female students, the third floor of the Heritage Inn is being used to house more than 40 girls.

To increase enrollment without taking up dorm space, recruiting efforts will focus on increasing the number of commuting students. White noted there are 138 new commuters this fall.

"Since we're limited as to the number of students we can admit, we will strive for students with an increased level of college preparation that will benefit from the quality program that Harding offers," said Carr.

Carr emphasized two reasons in explaining the recent increases in Harding's enrollment. "We've got a lot of students satisfied with the product we're providing and they are spreading that message to their friends," he said. Carr also stated that Harding's marketing and recruiting strategies are among the most aggressive in the country.

To maintain that competitive edge, the Admissions Services Office has added two additional staff members who will serve as admissions advisors. These additions bring the total admissions staff to 11 members.

Admissions figures indicate that their recruiting efforts are already affecting next year's freshmen enrollment. "Applications already exceed 1989 levels for the same time period by 25 percent, and we've had a record number of can-

Honor Roll Recognizes Harding

Harding University was in the 1990 Honor Roll of the John Templeton Foundation which recognizes character-building colleges and universities across the nation.

The Honor Roll was founded by investment advisor and philanthropist John Marks Templeton to formally identify and acknowledge those schools which make the develop-

ment of strong moral character among students a priority.

This year 102 schools from 32 states are highlighted on the Templeton Honor Roll. "These schools deserve to be recognized by both prospective students and by their sister schools for their achievement in this area," stated Templeton. "It is the hope of the Foundation that

all universities and colleges will aspire to join the ranks of Honor Roll schools by consciously instilling integrity and value judgement into the educational experience of students on their campuses."

All four-year, accredited colleges and universities are eligible for the Honor Roll. The average enrollment for Honor Roll colleges is 2,574,

Freedoms Foundation Awards Two Honor Medals

Freedoms Foundation of Valley Forge, Penn., has again recognized Harding with two George Washington Honor Medals. The American Studies Program was selected for excellence in the category of Programs and Activities, and Dr. Don Diffine was selected in the category of Public Communications for authoring the booklet entitled "To The Flag: Our Banner of Liberty."

The American Studies Program was honored with the medal for its lecture series and Youth Citizenship Seminar activities. The lec-

ture series brings to the campus leaders who present ideas, opinions and viewpoints which are basic to American citizenship. This unique approach brings speakers of national and international prominence to share their experiences and perspectives with students.

Last year's series featured former Secretary of Defense Frank Carlucci, Arkansas Congressman Tommy Robinson, IBM president John Akers and former United States Attorney General Edwin Meese among others. Harding was notified in July that the 1989-90 series had

received the honor medal.

The honor medal for the American Studies Program was presented to Dr. Jim Carr on September 24 by Robert Miller, president of the Freedoms Foundation.

Diffine received the honor medal for his efforts in the writing and publishing of a booklet saluting the American flag. Diffine said he decided to write "To The Flag: Our Banner of Liberty" during the summer of 1989 when the flag-burning issue was at its peak.

From the President

We officially began the 1990-91 academic year with a Convocation on August 29, with a capacity enrollment present in Benson Auditorium. I asked each person, "Why are you here?" I know that many students selected Harding as their university many years ago. I also know that some enrolled because others want them to be

here, and I know that some are here unclear in terms of what they want to do in life. I suggested that the answer to this important question can be summed up in two words — for freedom.

For freshmen, the definition of freedom may be quite different than what I am suggesting. They may be glad to be away from parental control and want very much to be free to do what they want to do. But freedom involves much more than this.

Had we been in East Berlin on November 9, 1989, the concept of freedom would have a very special significance. Tears would have filled our eyes as we walked or ran through the open wall to freedom in the West for the first time, perhaps to be reunited with family, perhaps to be able to taste freedom for the very first time.

Even as I stood between the two

walls of Berlin in July, in the so-called death strip, I could feel the electricity, the aura of the significance of what had happened.

Then as East/West relations eased, talk of a peace dividend became so prominent in our nation. Then suddenly, without warning, Saddam Hussein invaded Kuwait and today a world crisis exists in the Persian Gulf. For freedom, soldiers have left family and friends for the desert with gas masks in hand, to protect the rights of free men.

What does freedom really mean? Dr. L. C. Sears wrote a book about John Nelson Armstrong, Harding's president from 1924 to 1936. This book helped answer this question which I have raised. As an educator, preacher and editor, brother Armstrong was involved in the greatest crises facing the church

and the nation in the first half of the century. The story told in FOR FREEDOM is a story of a heroic struggle to preserve the Christian ideal of personal freedom in a world increasingly obsessed with dreams of power.

We face these same challenges individually and collectively today. Our real struggle in life is for the kind of freedom described by Paul in Galatians 5:1, "It is for freedom that Christ has set us free. Stand firm, then, do not let yourselves be burdened again by a yoke of slavery."

How do we find freedom? John tells us how to begin in John 8:31, "...then you will know the truth and the truth will set you free." Such is inscribed on our Bible building to remind us of the importance of this truth. Liberty is found in doing right.

Why does Harding exist? Why are we here? For freedom.

Five Speakers Slated for Lecture Series

Senate veteran Howard H. Baker, Jr., of Tennessee; human resources authority Brian Tracy; Admiral William J. Crowe, Jr.; and alumni Robert H. Jones, M.D., and Billy Ray Cox headline the 1990 fall lecture series of the American Studies Institute. Their appearances are a part of the year's events of the expanded ASI as announced by Dr. Jim Carr, Executive Director.

Admiral Crowe will speak at 7:30 p.m., Oct. 15 in Benson Auditorium. As the nation's senior ranking military officer and as principal military advisor to Presidents Reagan and Bush, Crowe has been involved in U.S./Soviet relations, the Persian Gulf, the Middle East, and Latin America and has served as chairman of the Joint Chiefs of Staff. A 43-year Navy veteran, he is now a professor of geopolitics at the University of Oklahoma.

Jones is scheduled for 7:30 p.m., Oct 30, in Benson Auditorium. A 1967 graduate, he is a Distinguished Professor of Surgery at Duke University Medical Center in North Carolina. He has lectured in many countries, including West Germany, Russia, Japan, Taiwan, Argentina and Poland. He has served as a visiting professor at Harvard, Columbia and George Washington universities and at Cedars-Sinai Medical Center in Los Angeles. He is a member of the Society of Nuclear Medicine,

American Heart Association, American Association of Thoracic Surgery and the American College of Cardiology.

Cox, who will speak at 7:30 p.m., Nov. 29 at Benson Auditorium, served 15 years as a professor of accounting and executive vice president at Harding. He directed the American Studies Program and received the Freedoms Foundation Principal Award for Outstanding Public Address in 1975. The speech, entitled "The Rebirth of a Nation," has been published.

Currently he is chairman of the Board of DalTile Group Inc., in Dallas. He is a director of DTM Investors Inc. and is a visiting professor at the SMU Graduate School of Banking.

Tracy initiated the series on Sept. 4 with a sales seminar on "The Psychology of Success"

sponsored by the Center for Professional Sales. A recognized author-narrator of such programs as **The Psychology of Achievement** and **Fast Track to Business Success**, he is president of the Institute for Executive Development in California.

Baker came to the campus Sept. 24. The first Republican ever popularly elected to the U.S. Senate from Tennessee, he won reelection by wide margins for two additional terms. He was vice chairman of the Senate Watergate Committee in 1973 and received the Presidential Medal of Freedom in 1984. From February 1987 to July 1988 he was President Reagan's Chief of Staff. Baker has now returned to private life and the practice of law in Tennessee.

A full slate of speakers will also be presented during the spring semester.

Ten-Year Approval

Dietetics Program Accredited

The Didactic Program in Dietetics in the university's department of home economics has been granted accreditation/approval by the American Dietetic Association for a period of ten years.

Mrs. Elizabeth Wilson, home economics department chairman, said the awarding came as the result of a self study conducted by the university. "The process required a great deal of time and effort," she said, "but the faculty of the department are thrilled that the full approval for the maximum time period has been granted."

The dietetics program is based upon the philosophy that optimal nutrition is essential for the health and well-being of every person. Likewise, the program recognizes that societal needs are best served by having a population that is adequately nourished. The mission of the program is to prepare individuals with a unique combination of knowledge and skills conducive to helping individuals and society meet their nutritional needs.

Accreditation for the program will enhance graduate school opportunities for students who have com-

pleted the degree at Harding. "We are happy to be able to offer such a program to our majors," Wilson said, "because our goal is to offer the best in the inter-relationships of food, nutrition and health."

Last fall 17 of the 85 majors in the department were studying in the field of dietetics.

Harding's department is also approved by the State Department of Education and the Federal Office of Education for the training of teachers in vocational home economics and home economics.

Professors Retire

Classes got underway this fall without the services of Robert Helsten and Virgil Lawyer, two long-time professors who retired during the past year. Helsten, a professor of Bible, had been a member of the faculty since 1958. Lawyer was a professor of history, having come to the university in 1961 as Dean of Students before joining the faculty.

The two were honored at special dinners at which they were remembered warmly not only for their exemplary Christian lives and their teaching expertise but also for their caring, dedicated concern for students.

Similarities shared by the pair made accolades almost redundant. Both are 1946 graduates; both served as missionaries — the Helstens in Germany and the Lawyers in Japan. They have continued to preach through the years as well. Both were remembered for their quick wit and abilities to make others laugh along with their sincerity in reaching out to others in quiet service. The two even exchanged verbal jabs in extolling each other at their respective retirement ceremonies.

Both Mrs. Helsten and

Mrs. Lawyer have recently retired from the classroom. Mary Belle Garner Helsten, a 1947 graduate, taught fifth grade at Harding Academy and Lou Dugger Lawyer, from the class of 1948, was a member of the faculty at Southwest Middle School in Searcy.

Governor Appoints Professor

Sharen Crockett (home economics) has been appointed by Arkansas Governor Bill Clinton as a participant in a comprehensive field assessment of new model child care standards developed by the American Academy of Pediatrics and the American Public Health Association. Crockett is president-elect of the Arkansas Association of Children Under Six (AACUS) and is directing the U.S. Department of Education grant awarded to Harding last spring.

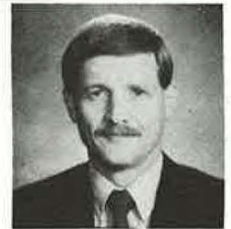
Serving as assistant editor will be Caryllee Parker,

Coons-Farrar Professor Selected

Biology professor Michael V. Plummer has been chosen to hold the Coons-Farrar Endowed Chair of Biomedical Science for 1990-95. Plummer succeeds Dr. Don England, distinguished professor of chemistry, who was the first to fill the position.

Established by alumna Irma Coons Terpenning, the endowment honors the memory of her parents, Robert Roy and Callie Mae Coons, both former Harding faculty members and department heads who were deeply involved in Christian education at Harding as well as at other institutions.

In 1972 the couple established an endowment fund to strengthen Harding's physical and biological science programs, donating their farm in Leesburg, Va., to the university. They also arranged the Coons-Farrar Fund in memory of Mrs. Coon's mother, who had spent many years in service to the sick, injured and newborn. The Coons-Farrar fund continues to provide scholarship aid and equipment for selected premedical and allied health students.

In announcing Plummer's selection for the faculty chair, President David Burks said, "We are delighted that we have such a man as Mike Plummer who can so capably fill this honor position. Dr. Plummer has an impressive record as a classroom teacher and also as a research analyst."

Burks also commended England, who will continue as chairman of the department of physical science and associate dean of the College of Arts and Sciences.

Plummer is a 1967 Harding graduate who returned to the faculty in 1970 after completing a master's degree in zoology at Utah State University. He received the Ph.D. from the University of Kansas, where he also worked as a teaching assistant from 1972-75.

A herpetologist, he has had numerous papers published in leading science journals and he has contributed chapters to books such as **Turtles: Research and Perspectives**. He was an invited speaker for a recent "Colloquim on Biology in the Mid-South" at Memphis State University. Dr. Plummer is often included on programs of herpetological societies to present lectures on his research on snakes. In 1980 he received a National Science Foundation grant to study off the coast of the Yucatan Peninsula in Mexico.

In 1989 he spent six months as a visiting scientist in research at the Savannah River Ecology Laboratory in Georgia. Mrs. Plummer is the former Sharon Lisle, an alumna. They have two children, Melissa, a Harding sophomore, and Scott, a student at Harding Academy.



Twenty-five Harding students spent ten weeks during the summer participating in Campaigns Northwest. They worked in eight locations in the Northwest: Coeur D'Alene and Pocatello, Id.; Cheney, Wash.; Ontario, Ore.; Price, Utah; and Glasgow, Billings and Great Falls, Mont. PASS Program Increases Retention

Barbara Turner has the highest grade point average in the School of Nursing's sophomore class, a fact that she contributes to the Program for Academic Success (PASS). On the advice of her academic counselor, Turner entered the program last year as a freshman. "I could never have accomplished what I've done without the help of this program," Turner said.

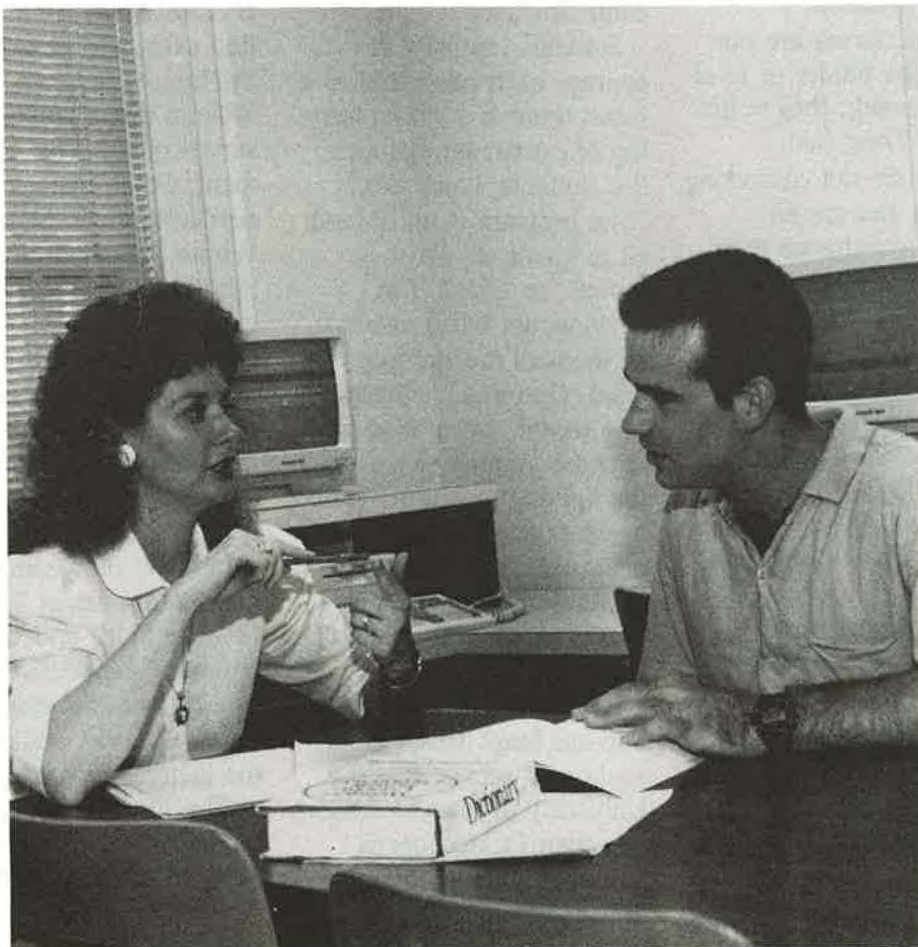
Turner was fighting the norm when she returned to school. At the age of 34, she enrolled in college after being part of the work force since her high school graduation. "I didn't take college prep classes in high school because I thought I'd never need them. So, I've viewed the PASS curriculum as a refresher course for me," Turner said. She is just one of many success stories that have resulted from this unique program.

The PASS program began five years ago when Linda Thompson formulated the idea as a graduate assistant for Lew Moore, a professor of psychology. "I felt Harding needed a program in place to help those students who enter college with ACT or SAT scores that are lower than average. We didn't want them falling through the cracks," she said.

Thompson presented her concept to Moore, and he liked it so well that he made a formal recommendation to the school's deans.

Thompson soon found herself proposing her ideas for PASS before the academic deans, and they too agreed that the program was needed. She has been the director of the program since its inception, but is relinquishing those duties this year to a new director.

Jan Morgan has been working

college work.

PASS students also have access to the Learning Assistance Center, which was established two years ago from grant funds. The center offers tutorial assistance for any student at Harding. If students need help with a writing assignment, study tips or reading skills, it is available in the Learning Assistance Center and its labs. The PASS program offices are located in the same facility as the center where they can conveniently make use of the same computers and labs.

Three different levels of testing are used to determine if students

Students who have been through PASS have been very receptive to the program. Almost all of the students agree that the program has helped them. "Initially, some think they don't need it, but they end up very thankful they went through it. I've had several tell me that they probably wouldn't have been able to stay in school without it," Morgan said.

Students who have gone through the program have made higher grades and more have stayed in school than students admitted to Harding before the PASS program was started. The program averages almost 100 students every school year, and 72 percent of PASS students return for their sophomore year at Harding. That represents an increase of 53 percent over previous years.

Although many students complete the PASS program in one semester, faculty advisors continue in a supervisory role for two to three

semesters. Students are helped with the selection of classes for at least one more semester before they are assigned an advisor in their major field. Appropriate help is offered if a student seems to be in need of further assistance.

The only apprehension students may have about the program is that it puts them up to a semester behind because of taking the preliminary courses. If a student views this as a drawback, the PASS courses are also offered in the summer, which gives students the opportunity to start in the same general curriculum classes as the other new freshmen.

"The average U.S. student today takes longer than four years to graduate, and students are realizing that four is no longer the magic number," Thompson said.

Thompson and Morgan have seen many advantages come out of the PASS program. "It's teaching students not to be afraid or embarrassed to admit that they need help and to ask for it," Morgan said.

"I can't express in words how supportive the teachers have been," says Barbara Turner, "I tend to get sentimental and mushy when I start thinking about everything they've done for me," she said. Even though Turner has completed the PASS program, she indicated that Morgan, Thompson and the PASS teachers are still there anytime a student needs them.

Turner has seen many examples of the advantages with which PASS has provided her. "College life is a new world that many aren't prepared for and PASS gave me a head start over other students when it came time to take upper level courses. These classes are nothing to be ashamed of because they give you an edge, and they've given me a great foundation that I can continue to build on," she said.

With the PASS program firmly established, success stories, like that of Barbara Turner's, will continue to increase along with grades, a student's confidence and teacher morale.

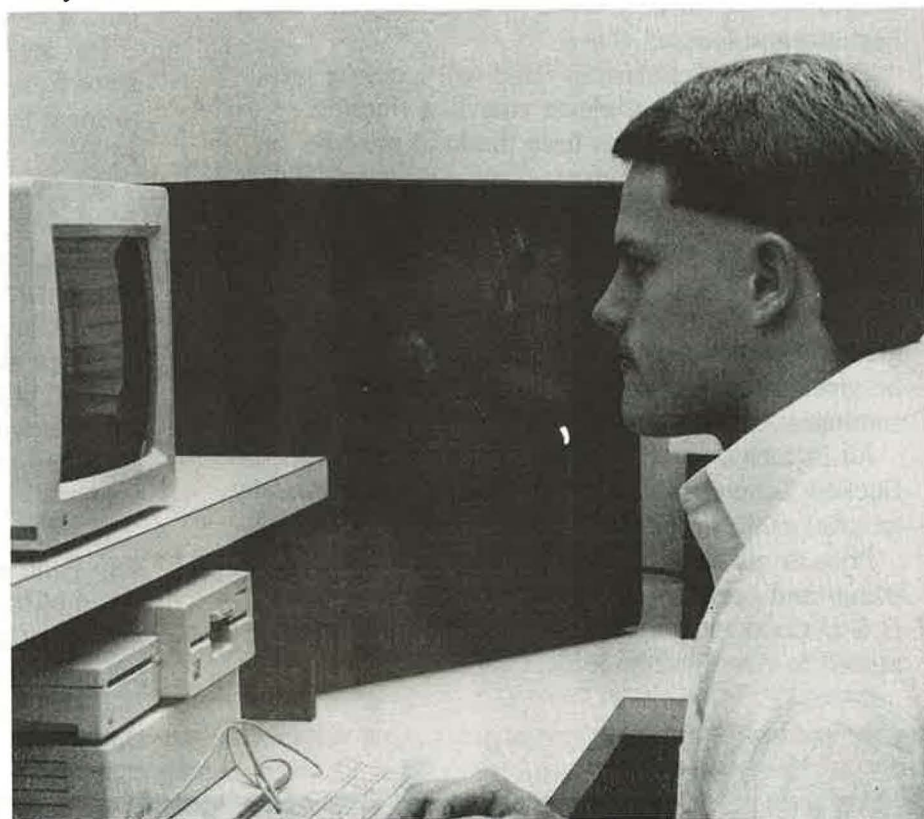
PASS class sizes are limited to around 15 students allowing the teachers and their students to become involved more personally.

alongside Thompson as an instructor in the program. Morgan has been the study skills coordinator for PASS since 1988 and has taught the PASS reading courses. She has seen the program help many students in the two years she has been involved with it. "This program gives students who may not have been too successful with their high school grades a chance to prove themselves in college. They're proving they can be successful in college, and success breeds even more success," Morgan noted.

The curriculum for PASS consists of five courses: Effective College Reading, Critical Reading and Reasoning, Study Skills and Personal Development, Basic English and Beginning Algebra. These classes are designed to prepare students for the courses they will be taking in Harding's general education curriculum. Three of the classes are accompanied by labs that further aid students in their

need all, part or none of the PASS curriculum. First, a student's ACT or SAT scores are used. If these scores indicate a need for the program, students are tested on a series of Computerized Placement Tests during registration. These examinations consist of Reading Comprehension, Sentence Structure, Arithmetic and Elementary Algebra. "This series of tests is just another opportunity of testing out of the program," Thompson said, "and many students perform better on them since they are not timed and are given on a computer."

If the computerized tests still indicate a need for the PASS curriculum, students are given the third and final level of testing. Teachers administer their own tests during the first week of classes and make recommendations based on their observations. Frequently, students are moved up into the next level of course work based on teacher recommendations.

Honors Program Begins Second Year

A year after being introduced to the curriculum, Harding's Honors Program, directed by Dr. Larry Long, has been termed a success. Several changes are being implemented this fall, however, in order to strengthen the offering for future enrollment.

Long said the 19 students who were invited to join the initial group have fulfilled the objectives and goals of the new project, which was designed to creatively address the educational needs of the most highly prepared

incoming students.

"Honors classes are not meant to be harder or to effect more work; they're just different," Long said.

"Students are not competing for grades, but are encouraged to enhance their individual abilities. It is intended that each student be dealt with as an individual."

Classes encourage student participation because the students assume more responsibility for the discussion. Instead of emphasizing testing, there is more sharing, more emphasis on writing and more oral

communication.

Students mutually encourage each other and as a result there is a strong feeling of camaraderie among the students, Long said.

"The program is not intended to create an elitist group," he added. The students are integrated into all areas of the Harding program. One was co-director of a recent Spring Sing production; another served as the lighting technician for a major drama production; nearly all are members of campus social clubs; some star in intramural athletic competition.

From the original group, one has been accepted for an honors semester at the University of Iowa in Ames. Jonathan Picklesimer is among 12-15 students nationwide to be selected to participate. Additionally, the Southern Region Honors Conference awarded Picklesimer a \$500 scholarship for the semester.

Students for the fall session were invited on the basis of ACT, SAT and National Merit Scores and from the Trustee Scholarships offered by the university. Courses will include Introduction to Honors, which

is emphasized communication skills and introduces the honors program, Honors Bible, a discussion-centered survey of the New Testament. Other courses in the curriculum will include The Human Situation: Social Systems, addressing the general education areas of the individual and the social environment and global living.

Next spring, courses will include The Human Situation: The Big Questions, combining the general education areas of The Creative Spirit and The Historical Perspective; and The Human Situation: The Physical World, addressing the general education area of The Physical World, exploring issues of nature, physical science, health, technology, ecology and mathematics.

In addition to Long, a professor of English, the Honors Council includes Dr. Neale Pryor, academic vice president; Dr. Jim Carr, executive vice president; Dr. Ray Muncy, distinguished professor of history; James Walters, an assistant professor of Bible and Greek; Dr. Don England, distinguished professor of

chemistry; and Don Robinson, chairman of the art department.

The Council has also been approved to make honors credit available by contract for upper level courses already on the schedule. In order to obtain credit, approved students and the teacher will re-write the course syllabus, according to guidelines established by the Honors Council.

"Harding has too many qualified students not to offer courses on a contract level," Long said. "We have students who can and will ask hard questions. We believe we must prepare them to be ready to deal with finding answers."

Department Hosts Meeting

More than 30 visiting delegates made presentations during the Conference on Christianity and Literature hosted by the Department of English Sept. 28-29. Dr. Dennis Organ, department chairman, coordinated the Southwest Region meeting of the organization which includes delegates from Arkansas, Texas, Oklahoma, Georgia, Tennessee, South Carolina, Arizona, Mississippi and Illinois. Dr. Jerry Daniel, a Harding alumnus who edits the Bulletin of the New York C.S. Lewis Society, was guest speaker for the Friday night banquet.

The 1990 National Awards Jury involved 12 judges who evaluated thousands of entries. Either Harding or members of its faculty have won Freedoms Foundation medals every year for 40 years.

didates apply for admission for a limited number of openings in the freshmen class," Carr said.

"Harding offers a top quality education and that message is reaching more and more students," White said in explaining enrollment figures.

Students enrolling for this fall semester represent 48 states and 24 foreign countries. Only the states of Rhode Island and Hawaii are not represented.

Arkansas leads the list of states with the most students at 1,051. Others at the top of list are Texas (369), Tennessee (211) and Missouri (148). Alabama and Florida are represented with 101 students from each of the states.

With this year's enrollment process completed, the admissions staff is focusing their attention on those planning to enroll in the fall of 1991. Next year's freshman class will be only slightly larger than this year's since only a few additional positions will be available. For this reason, the Admissions Services Office is urging students to complete the application process as soon as possible.



Family Honors Dockery

An endowed memorial scholarship fund has been established at Harding University honoring the late Carlyle Dockery, a long-time businessman from Pine Bluff, Ark.

The fund was established by Dockery's eldest daughter, Nell Dockery Owen of Madison, Ala., and her husband Randall Owen.

The Dockery Scholarship Fund will annually provide financial aid to students attending Harding. Students receiving grants from the fund must be enrolled as full-time students, have a demonstrated financial need, be maintaining a satisfactory grade point average and demonstrate a potential for service in their chosen careers.

Harding's Financial Aid Committee will select the grant recipients each year. Special consideration will be given to students from the Pine Bluff and southeast Arkansas areas.

All income derived from the investment of the Dockery Scholarship Fund will be distributed annually to scholarship recipients.

Prior to his death in 1983 Dockery was the co-owner and president of C. Dockery Real Estate and D & D Contractors in Pine Bluff. He and his family moved to Pine Bluff in 1955.

A native of Hayti, Mo., Dockery attended Freed-Hardeman College in Henderson, Tenn., and Lambuth College in Jackson, Tenn. In addition to his real estate and contracting businesses, Dockery was a minister for Churches of Christ in southeast Arkansas including congregations in Rison, Fordyce, Redfield, Ferda and Watson.

He is survived by his wife, June, who continues to live in Pine Bluff. In addition to Nell Owen, the couple has three children, Sammy, Susan Dockery Crofford and Pamela Dockery Truman. Nell and Susan are graduates of Harding.

Fund Awards 116 Scholarships

One hundred sixteen Harding students received financial assistance from the Ganus Scholarship Fund during the 1989-90 school year.

The students received a total of \$45,669 in scholarships from the fund. Scholarships ranged from \$250 to more than \$1,900. The average scholarship was \$400.

More students received scholarships from the Ganus Fund than any other endowed scholarship fund at Harding. Students receiving aid came from 19 states and four foreign countries.

All scholarship funds from the Ganus Fund have not been awarded yet for the 1990-91 school year. By the end of the school year again more than 100 students will have received scholarships, and the total of those grants is expected to surpass the 1989-90 total.

The Clifton L. and Louise Ganus Endowed Scholarship Fund was begun in May, 1986 by Harding's board of trustees to honor the then retiring President and Mrs. Ganus. The \$1 million endowment for scholarships recognized the couple for the 46 years of commitment, dedication and support of Harding University.

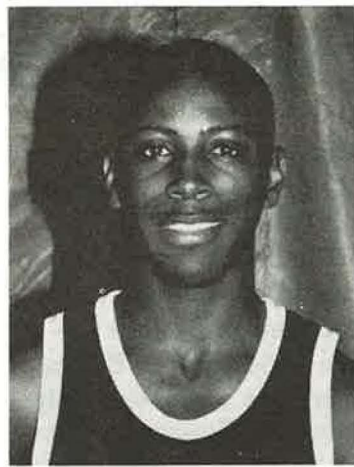

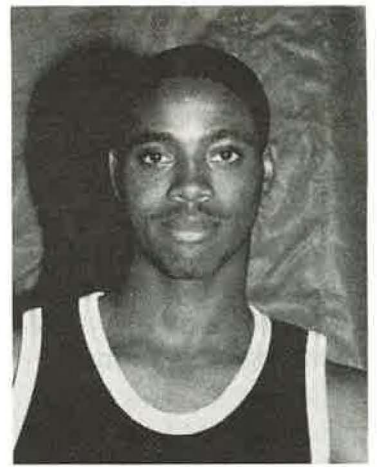

Harding's head basketball coach Nicky Boyd plans to have a basketball program that Harding students, alumni and area fans will enjoy watching and want to support. Boyd and new assistant David Todd take over the reins from retiring head coach, Jess Bucy, for the 1990-91 season.

Boyd brings the experience necessary to produce successful teams for the Bisons. The North Little Rock native played collegiate basketball at Henderson State University. He coached at Arkadelphia High School, Cabot High School and Harding Academy before joining Harding's staff as an assistant in 1984.

The physically demanding style of play will dictate having 10 people who can play the brand of fast-paced basketball Boyd wants.

September was a good month for Bison football fans. Harding completed its non-conference schedule with a 3-1 record and a seventh place national ranking among NAIA teams.

The only loss was in the opening game of the season to the nationally ranked Hornets of Emporia State (Kan.). The Bisons lost the contest 21-14 to the second-ranked Hornets.

Since the opening game, the Bison team has bounced back defeating Lane College, 38-0; Evangel College, 27-20; and Southeastern Oklahoma University, 15-14.

In the Lane College contest Harding unleashed its rushing attack as the Bisons marched up and down the field. Only a second quarter rain storm slowed the Bison attack.

The one-sided contest gave coach Larry Richmond a chance to look at some of his younger players in a game situation. Richmond liked what he saw in his youngsters.

True to form the Bisons' defense held the Lane

Dragons to only three first downs and only 37 yards total offense.

The third week of the season brought the Crusaders of Evangel College to Searcy. The Bisons jumped to a 20-6 lead only to see the Crusaders come back and threaten late in the game. The Bisons' "bend-but-don't-break" defense stopped Evangel four times inside the ten yard line in the final quarter.

Against the Southeast Oklahoma Savages the Bisons rode the toe of kicker Brent Goodwin to victory. Stymied most of the night offensively, the Bisons were down 14-0 in the first quarter.

After Harding scored a touchdown in the second quarter, Goodwin kicked three field goals, one a school record 54 yards, to provide the margin of victory.

The defense shut out the Savages during the final three quarters of play.

Defensively in the first four games All-American Pat Gill is leading the team

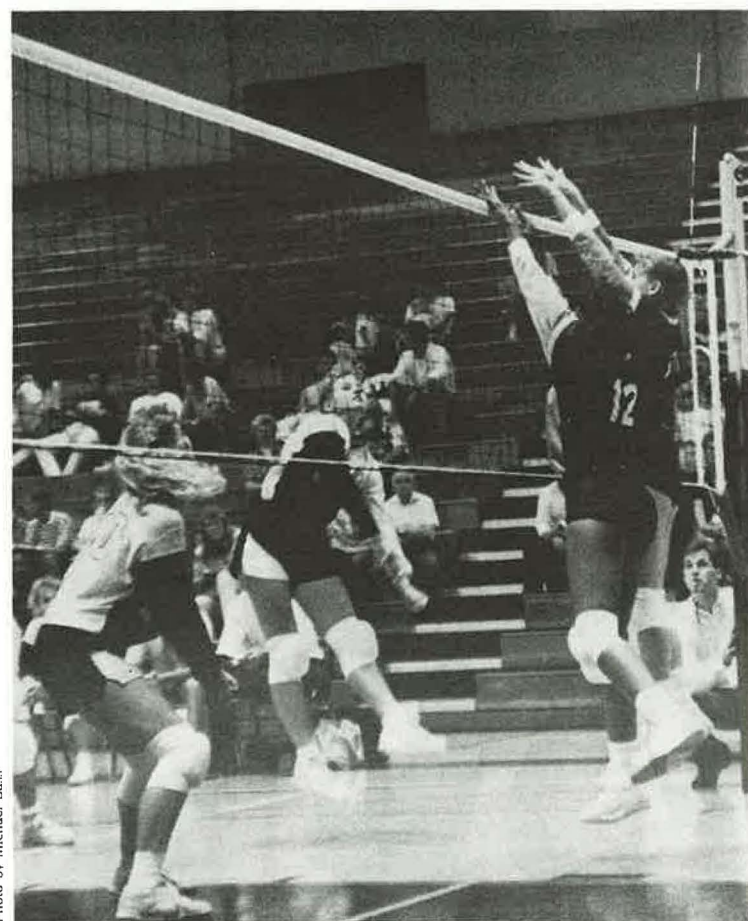

Disabled In Body, Not In Spirit

A crippling disease has confined him to a wheelchair. But the artist in him carries him to soaring heights.

The artist, **Edward Gurganus** (BS), worked 300 hours to paint the 7 by 12 feet mural which now decorates the wall outside the renovated Spedding Hall conference room on the campus of Iowa State University. The mural was originally located at the entrance to the nuclear reactor facility of the Ames Laboratory, Ames, Iowa, before the reactor's decommissioning in 1978.

The work of art vividly portrays the reactor core in a ten-sided prism, fuel elements, control room, personnel working in different departments and labs, and other aspects of the research reactor. It also shows the overhead water tank, utility and safety system, and practical aspects of nuclear research in the form of irradiated seeds for farming. The mural was completed in 1967.

Undeterred by multiple sclerosis, which restricts him to the wheelchair, the 59-year-old artist continues to help his blind son in higher study. "I go over his scripts. Having graduated recently in business, he is studying speech communication now."

Explaining the beginning of his own afflictions, Gurganus says, "The disease started sometime in 1965. I had a little problem with my hands and could not stand on my legs for long periods to work on the mural. Hence, I took more time to complete it than originally planned. I retired in 1974, and since 1977 I have been confined to the chair. Many friends from the Lab drop out to my house for coffee periodically to share new and interesting developments."

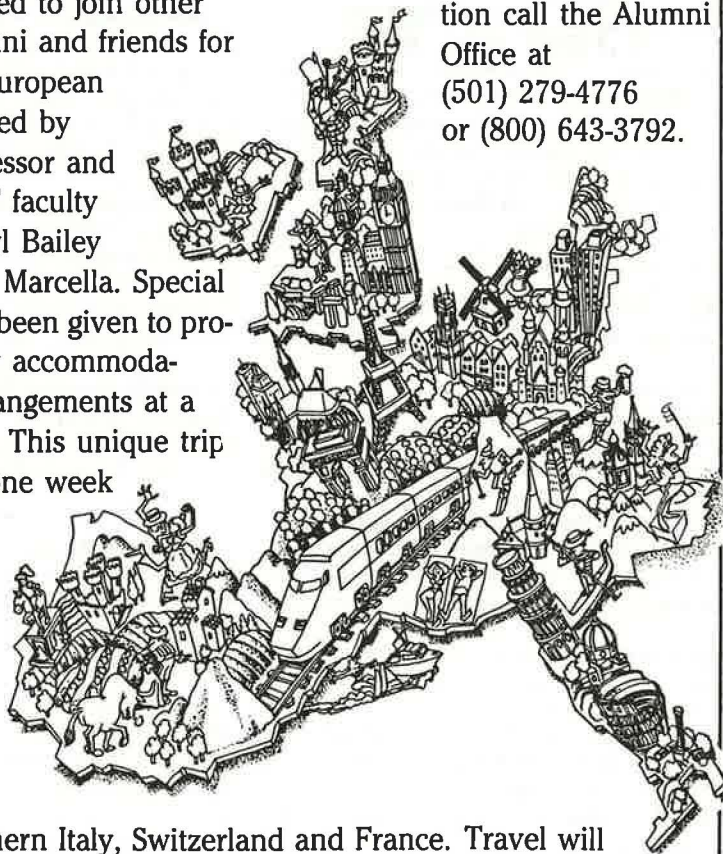

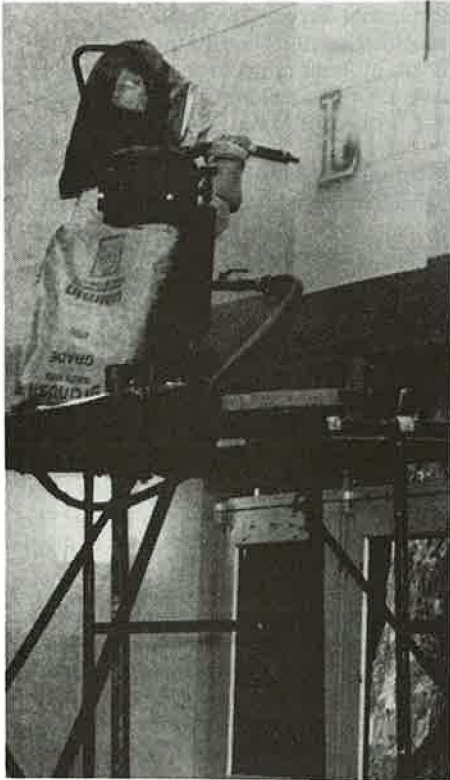
The two-week tour was sponsored in part by the People to People organization, an independent association established in 1956 by President Eisenhower. The purpose of the trip was for American medical personnel to visit their Soviet counterparts, tour their facilities and engage in group discussions and exchanges. "It gave us a first-hand view of how they do things there," Wilborn said.

Accompanying Wilborn on the tour was a 15-member group of nationwide medical specialists, including nurses, physicians, surgeons, a clinical psychologist and a veterinarian. Their travels took them to the capital of Soviet Georgia, a city in the Ukrainian Republic, Leningrad, Pushkin and Moscow.

The group discovered that the Soviet Union is medically sophisticated in some areas, but lags 25 to 50 years behind in other areas. Wilborn said rapid advancements are being made by the Soviets in the area of laser surgery. "They're using it in areas that have not even been considered in the United States," he said.

In the areas of diagnosis and lab facilities, Wilborn said the Soviet Union is behind the advancements that the U.S. is making. "I think it has to do with money," Wilborn said, "because they will buy new, modern equipment and then not have the chemicals needed for it." When that happens, Wilborn said they will resort to using older and cheaper methods.

Wilborn is the director of the medical laboratory technology program at Garland County Community College in Hot Springs, Ark. He has been with the college for 10 years.
