Student Association Minutes

The Student Association held its regular meeting on April 22, 1969. The meeting was opened with a prayer by Rick Glass. Sheri, Lynn, Chris, and Dr. Gilliam were absent. Johnny Chin and Dennie Reeve were visitors.

OLD BUSINESS

Contribution for Red Cross- Seven clubs participated in the collection of Red Cross contributions. Over \$500 was collected.

Officer elections, representatives- Officer elections will be April 30, and representative elections will be May 6. Presidential candidate speeches will be Tuesday, April 29. The S. A. members agreed to campaign individually for candidates if they so desired, but not to use the office they hold to campaign.

Cheerleader elections- The elections will be May 14. At least positions for two regular cheerleaders and one alternate will be open.

Limit on cafeteria drinks- Ron talked to Mr. Curry about the limit on drinks in the Heritage cafeteria. Mr. Curry explained that the present policy is probably a permanent one.

Ice Cream in Heritage- Ron talked to Mr. Curry about why we don't have more ice cream in the cafeteria. Mr. Curry explained that he can get more ice cream but, if he sold it early in the week, students would run out of money on meal tickets by the end of the week.

Reactions to Letter to Board- The Council members reported mostly favorable response from the students. There were few unfavorable comments. Ron reported that Dr. Ganus spoke to him about it, and he insisted that the S. A. change the wording from "dismissal" to "action of the Board." This accounted for the changes in the Bison. The new Board meeting has been set for June 3.

Book return-Miss Birdsall reported to Ron that she has received an invoice on the book return, and it should be in by next week. The S. A. agreed to pay for half of this return.

Dorm Council representative for Echo Haven- Phil Roberson talked to Dean Lawyer about the difficulties of the girls in Echo Haven, but Mr. Lawyer was already aware of them. He suggested that Phil get a list of complaints from the girls living there and let him work with them through his office. Phil will get the list this week.

NEW BUSINESS

Handbook revision- After discussion concerning proposed changes, it was agreed that Rod will check with Dr. Hacker about why girls cannot accompany men to preaching appointments. Ron will check on the possibility of having cheaper parking tickets for students who bring their cars for the last nine weeks of school.

Suggestion boxes- From the rotating suggestion boxes, four suggestions were turned over to the Dorm Council. Ron will check on stopping boys from throwing gravel off the sun deck in the parking lot, glass in the parking lot, and improving the drainage in certain places on the campus. Peggy will talk to Dean Lawyer about enlarging the girls' sun deck.

The meeting was adjourned at 7:05 P.M.
