STUDENT ASSOCIATION MINUTES

The S.A. meeting of December 8, 1970, was called to order by the president. An opening prayer was led by Dr. Jerome Barnes, sponsor.

Committee Reports:

SOCIAL AFFAIRS--there will not be a coffee house this week-end because of the play "Blithe Spirit." The next coffee house will be after Christmas.

CUTS--Karen talked with Dr. Pryor concerning double cuts. The matter will be taken up with the Academic Affairs Committee.

LYCEUM--Wayne reported that the Lyceum Committee will have a meeting Thursday, December 10, to discuss a future lyceum.

TOY AND DOLLY DRIVE--Stevia has received requests thus far for over 1,000 toys and dolls. The toys and dolls are to be turned in by Thursday, December 10, at 10 p.m. The S.A. office will be open all day Thursday so that toys may be turned in. People are still needed to carry boxes of toys to some of the orphan homes.

DORM COUNCIL--Kay presented a proposal to the S.A. concerning skim milk in the cafeterias and lighting on the walk between the library and the gym. Sara moved that the S. A. approve the suggestion and forward them to Lott Tucker with a carbon copy to Dr. Ganus and ask him to take proper action. The motion carried. Karen will write the letter.

Unfinished Business

"Miss-a-meal"--Kay moved that the S.A. select a person to present the "miss-a-meal" program to the student body for their approval. The motion passed. Karen made a motion that Gary handle the presenting of the program to students in chapel. The motion carried.

CLASS MAGAZINE--the student response to CLASS magazine was very good. John will see about ordering the next issue.

New Business

Needy families--Wayne read a letter to the council from a lady in McRae, Ark. asking for clothing for her grandson. Stevie also read a letter she received from a woman in Kentucky asking for clothing for her four children. Karen moved that the S.A. take care of these requests out of the general S.A. fund, and in the future refer requests to a special committee. The motion carried. Stevie will buy the clothing.

Petition from St. John's University--Wayne explained at petition received from St. John's concerning American POWs in Vietnam. They requested that we circulate a petition which asks information about these POWs. Candy made a motion that the S.A. submit the petition to the student body in chapel Friday for their signatures. Sara will take charge of this and see Dr. Ganus for permission.

Hair Lengths--Wayne informed the council about the new ruling on hair lengths and the disciplinary action that will be taken in the future. Kay moved that the S.A. discuss the matter with Dean Lawyer concerning the new rules. The motion carried, and Wayne will see Dean Lawyer.

License plates--at the request of Mrs. Jaynes, Stevie presented the suggestion to have black license plates ordered with Harding College on them in gold. David moved that the S.A. suggest to the bookstore to order a line of such license plates. Karen will write a letter to Mr. Dykes.

Faculty -Staff Directories--Stevie moved that the S.A. suggest to the Publicity Office to place faculty-staff directories at the phones in every dorm. The motion carried. Karen will make the suggestion to Stan Green.

Ear Books--John brought up the fact that there are many Ear Books still in the S.A. closet which were made several years ago. It was agreed to take them to the Alumni Office and let them send the books to alumni.

Prayer Chapel--at the request of Dr. Ganus' Sunday school class, David Ransom suggested that the S.A. see about the building a prayer chapel on campus. David Fincher will check into this with Mr. Barnes.

The meeting adjourned at 7:05.
