STUDENT ASSOCIATION EXECUTIVE COUNCIL MEETING

The regular meeting of the Student Association Executive Council was held Monday, September 24, 1973 with Mike Justus presiding. The meeting was called to order at 5:25 p.m., beginning with a prayer by Darrell Bruning.

PRESENT: Mike Justus, Phil Herrington, Elaine Shipp, David House, Dan Daniel, Becky Cochran, Darrell Bruning, Mark McInteer, Brenda Dimitt, Lot Therrio, Nancy Cochran, and Dr. Jerome Barnes.

ABSENT: None.

SA HANDBOOK: Becky reported that it would take \$368 to have the SA handbook printed. Because this project would be more effective when initiated at the very start of a school year, Darrell moved that we give the already prepared material to Dean Altman, recommending it to be enclosed in next year's student handbook. The motion was seconded and carried.

CHRISTIAN COLLEGE CONFERENCE: David reported that final preparations were being taken care of at Wyldewood for meals and housing. Elaine said that she was now receiving responses from the invitations and that she was working with Dean Altman's office on registration. Phil proposed a tentative schedule for the three days of activities. David moved that Dan work on getting a major lyceum for October 19 in conjunction with the CCC. The motion was seconded and carried. The schedule was approved.

CORRESPONDING SECRETARY: David moved that we hire a corresponding secretary to help Elaine with duties. The motion was seconded and carried.

APPLIANCES IN THE DORMITORIES: David talked with Dean Altman and Dean Campbell concerning the selection of appliances students may use in the dormitories. It was decided that there would be no distinction made between pop corn poppers, hot plates, coffee pots, etc. in relation to the selection of appliances the student wishes to use. Abuses such as use of full-sized refrigerators will not be tolerated.

CAFETERIA COMMITTEE: Dr. Ganus told Dan that he would accept a list of foods the students would like to have served. Dan said Dr. Ganus would approve anything within reason and would take the recommendations to the cafeterias.

LOST AND FOUND: David informed the council that a new Lost and Found cabinet was being built and will be placed along the wall in front of Mr. Dykes' office in the student center.

BENEVOLENT COMMITTEE: David moved that we appoint Ginny Haney to the Benevolent Committee, which takes care of sending cards and flowers for appropriate occasions.

PATTI COBB CAFETERIA: Elaine relayed statements she had heard concerning the reduction of the food quantity served at Patti Cobb. She said that students were also concerned with the length of the lines. In view of the fact that Nancy eats at Patti Cobb, David moved that she be appointed to the already existing committee to review the campus food situation. The motion was seconded and carried. Nancy will deal with the above mentioned conditions as part of her responsibility on the committee.

WEIGHTS IN THE DORM (ALTERNATE PLACE): David discussed the petition which had circulated through Kellar Hall requesting weights in the dorms. Lot Tucker was contacted about this matter. He suggested that the old Bales bookstore be checked out to see if it could facilitate these services. Mr. Tucker assured David that the rooms, if available, would be made accessible.

LETTER FROM MISS BRIDSALL: Miss Shirley Birdsall wrote a letter to the SA making suggestions concerning the sidewalk connecting American Studies with the belltower. Her letter was referred to the Physical Plant Committee.

PING PONG TABLES: Lot reported comments he had heard about the lack of ping pong facilities on campus. Becky moved that he talk with Mr. Tucker about securing a place for the ping pong tables. The motion was seconded and carried.

LETTER FROM MR. TUCKER: The council received a letter from Mr. Tucker stating the policy for placing signs on the new student center. Signs are not to be put on clear glass, neither the outside nor the inside. Posters placed on the outside of the building are limited to the week of elections with special permission from Mr. Tucker or Mr. Dykes.

BON FIRE: 9:30 p.m. Friday night in parking lot across from Harbin Hall. SA will supply marshmallows.

The meeting was adjourned at 6:29 p.m.
