Thank you for talking with us about our group.

This past Sunday my wife and I went to Tulsa and talked with the leaders of Brookside congregation.

They invited the whole group to come back during the Christmas vacation. ^{however,} We will continue to inquire with other elderships.

However, my wife was critically injured on the way back from Tulsa. Karen is still in the hospital here in Fort Smith (St. Edwards Hospital). She said nothing, by Sunday, Karen will be better; so I will be in Little Rock most of next week (MO 3-2730)

Two days ago I mailed three letters that Karen had typed before the accident. The following men were sent a letter and a group outline: Mr. Houston Exell (Vulture), Mr. Cha North (Madison) and Mr. R. B. Sweet (Austin).
